Chair Baker, Vice Chair Chang and Committee Members:

I am Marilyn Takeshita, retired Secretary to the System Director of Human Resources, University of Hawaii.

I am testifying in favor of Gubernatorial Nominee, Leslie Murata's consideration and confirmation to the State Board of Barbering and Cosmetology, for a term to expire on June 30, 2021.

They are able to laugh and view what others take for granted or do not have enough time to enjoy themselves.

Mr. Murata gives his time freely without expecting any personal reward and is humbled and grateful to be able to help all those who call upon him. He is well appreciated by all those who he has volunteered to help because they know that he has the ability to get the job done.

I know that when Mr. Murata is confirmed to the State Board of Barbering and Cosmetology, he will be a great and valuable asset in all that he does as a member of the Board.

I urge the committee to consider and confirm Mr. Murata to the State Board of Barbering and Cosmetology.

(1) Why do you want to be a member of the Board?

I want to become a board member because I enjoy volunteering no matter what it may be. From a public person view of point, I believe I can be a fair voice for the consumers

What do you perceive are the roles and responsibilities of a member of the Board?

I perceive this board as an entity to help consumers who are concerned about the safety and wellness in our salons. I also perceive that this board would make sure that all barbering and cosmetology schools are following the same guidelines and laws of the State of Hawaii.

During my tenure at the Consumer Affairs Office, USPS, I was able to solve problems with the customers.
