Aloha Senators from Waimea, Island of Hawai'i -

I write to please ask your support for the nomination of Mrs. Lynn Fallin to the State Board of Education. The school-community of Waimea Middle School met and worked closely with Lynn for about five years beginning in 2003.

Lynn was then the new Executive Director of the newly established not-for-profit Ho'okako'o Corp., which was enabled by Legislative Act 2/2002 to recruit, manage and support what was intended as an innovative legislative-and-community-initiated strategy to support improved academic outcomes for public school students in Hawai'i. After extensive teacher-staff-family and community discussion and research, Waimea Middle School opted to take advantage of Act 2/2002 by becoming Ho'okako'o Corporation's first public conversion charter school.

The law was brand new and included a valuable partnership for our children with Kamehameha Schools with funding assistance. WMS was then a school of about 550 6<sup>th</sup>-8<sup>th</sup> graders and we had students crammed literally into closets, a bathroom, on the nearby community gym stage, etc. We were then already considered exemplary in implementing schoolwide academic strategies to improve reading and computing, but regardless, many of our students were struggling academically. Our school-community believed we needed greater flexibility to implement programs and strategies better suited to our students' needs. We waded in and did we ever have a lot to learn.

Throughout those early years, Lynn was at our side as guide and mentor, helping us research, define and implement "best practices" as we learned about managing everything from student safety to funding and facilities, She helped ensure we were accountable and transparent academically, fiscally, contractually and organizationally – especially for our high need Special Ed students. She

helped us develop a detailed plan addressing all aspects of public education and also address evolving federal No Child Left Behind mandates.

It was extremely challenging as we continued to burst at the seams with kids who needed substantial academic and social-emotional supports. We were and continue to be fortunate to have a highly motivated, experienced and collaborative teacher-staff team and excellent community involvement, and Lynn was our guide.

I'm not sure in retrospect that being a public conversion charter school has gotten easier over the years, but she helped us lay a solid foundation of accountability and transparency. She supported our teachers and staff in prioritizing student and family engagement and developing strong community partnerships including significant nonprofit partners. A number of the relationships she helped us forge continue to this day.

Lynn's prior experience as a 14-year classroom teacher for regular students and Special Ed, and her prior service with the Governor's Office of Children and Youth served us well. I was not surprised that she was subsequently tapped by the Governor to head up DOH's Child and Adolescent Mental Health Division to improve behavioral health outcomes and access.

Lynn is responsive, respectful, and understands and champions cultural diversity and accountability. She is experienced with managing large budgets and working with both the Administration and Legislature. And she is well connected with the community – labor, business and not-for-profits. Finally, she has high standards for her own deliverables and is a good communicator.
