

Aloha Chair Kidani, Vice Chair Kim and Committee Members,

Please accept this letter of support for the confirmation hearing for Shanty Asher for the Board of Education.

I have not known Shanty but about a year and time is no measure when I meet someone and thru observations and engagement know who she is.

About 10 years ago I asked a public health nurse with the Department of Health to assist me in finding some leaders in the Micronesian Community whom I could meet with. The reason for the request was the troubling reports and stories I was receiving regarding the Micronesian community in health, safety, education, and cultural incongruency to the "local culture."

The nurse helped me to find 6 men originally from Chuuk who were willing to meet with me on a couple of conditions. All of these men were considered Pastors so they were spiritual leaders of their families. There conditions were:

- 1) What do you want, everyone wants something from us?
- 2) We don't represent the Micronesian Community there is no 1 Micronesian Community, we represent our families, do you understand?

I gratefully said that I want to meet to ask a simple question and yes, I simply want to meet with folks who I can ask the question to.

I waited at a McDonald's at 6 pm when the 6 men walked in carrying a sack of burgers and super-sized drinks. The oldest was 67 the youngest was probably in his late 20's. I asked them all to introduce themselves so they did and then explained why I needed to meet with them. I shared that a friend produced a 5-minute video of homeless



people on the Leeward Coast of Oahu and it was so beautiful to see how a service provider was doing amazing work and how grateful those being served were with food, education, and most of all love. I explained that about 70% of the faces in the video were Micronesian and that's what moved me to request a meeting.

I shared that as I watched that beautiful video I saw another video in my mind's eye of atomic bombs being dropped in Micronesia and it caused a revelation that the detonated bomb image caused the effects of the homelessness video. I explained that when the United States tested the bombs in their waters and islands we really blew everything up and since we blew it up now we needed to fix it so we had to throw things at the problems or deficits we created. Money, food, healthcare, religion, free flowing US passage, etc.

"What I wanted to ask you men is since the USA virtually blew your lives up this is who you've become, what I want to know is who were you before we blew you up? Because who I see, I don't think that's who you were but because of the detonations and reparations this is who you've become, so who are you?"

The oldest many immediately started sobbing and the others stoically sat in silence. I asked what they used to eat and they said "we ate banana, sweet potato, taro, breadfruit, and pandanus!"

I said "Sounds healthy". To which one replied enthusiastically "we were, we were strong and healthy!"

For the next hour I shared stories and perspectives that I felt would affirm the brilliance of their heritage misplaced in the recent history of trauma caused by the USA. I shared the gratitude many of us with Hawaiian ancestry have for the people of Micronesian holding the key to unlock the door to the lost knowledge of celestial and ocean wayfaring because of Mau Piailug. To which one man said "we used to know the name of every star in the heavens today I can probably name you 3, do you think your people can teach us the names of the stars again?"

It is amazing that many people conclude that the people of Micronesian didn't want to learn and yet in a short meeting of connection (not correction) a powerful and poignant request to learn was declared.

When I asked the question "who were you?" I didn't ask because I wanted an answer, I asked because I knew the answer and I felt they needed to find and realize the answer. The answer was, they were of the strongest, healthiest, most resilient, innovative, industrious, clean, and brilliant people on the planet. Others are trying to fix and change them instead of help them to recover who they were and truly are.

The reason why this is pertinent to Shanty's appointment and role as a BOE Member is that she exudes the qualities of brilliance and connection (revealed in my question) not only needed for our Micronesian cousins but needed for all children of Hawaii. From Kosrae she has endured prejudice and self-doubt to raise herself with grit, tears, and smiles to be a wise, thoughtful, and well spoken leader. I applaud Governor Ige's selection and full heartily ask that you affirm her confirmation to the Board of Education.

She has the credentials but so do many others. She has the discipline to speak thoughtfully to silence the competing noises so we can be people of reflection, courage, empathy, and action.

Chair Kidani, Vice-Chair Kim, and Members of the Committee:

I am pleased to provide this letter in support of the nomination of Ms. Shanty Sigrah Asher to the Board of Education. Ms. Asher and I work together as fellow directors on the board of The Legal Clinic ("TLC") here in Honolulu. I currently serve as the president of the board.

TLC is a non-profit organization that provides legal, advocacy, education and related services to Hawai'i's low-income immigrant community. We provide direct legal services through our staff attorney and trained paraprofessionals. We also provide legal services through numerous community workshops. For instance, we help immigrants go through the difficult naturalization process to become U.S. citizens, and we assisted others obtain necessary governmental documents. (We continue to provide these services individually, over the internet where possible, during the Covid-19 shutdown.) Our advocacy work includes meeting with community groups to work on solutions to common problems facing our low-income immigrants and seeking to implement them. And, our education efforts include appearing on several radio programs; speaking at churches and high schools; participating in articles for the print media; disseminating information guides and other efforts.

Ms. Asher is an active member of the board of directors of TLC. The board is a particularly diverse one, consisting of a "Dreamer" under the Deferred Action for Childhood Arrivals ("DACA") program; two members of the Muslim community, including the Imam of the Muslim Association of Hawai'i; two Methodist pastors, one of whom is a Tongan radio show host; the former Assistant Vice Chancellor for Student Diversity at the University of Hawai'i at Manoa – a Filipina long-time activist for immigrants and civil rights in Hawai'i and others.

Ms. Asher adds to the diversity of our board. As you likely have seen from her resume, she was raised in Kosrae, one of four states that comprise the Federated States of Micronesia ("FSM"), having graduated from high school there. She went on to obtain her bachelor's and master's degrees here in Hawai'i. She returned to FSM, and has served in both the FSM's Department of Foreign Affairs (as a Deputy Assistant Secretary) and the Department of Justice (as a legal specialist). In her various positions, she has had the opportunity to serve various officials in a wide-array of public policy issues, including with respect to regional compacts with area governments, including with Australia and New Zealand. She also has experience advising on anti-corruption and security related issues. Shanty currently serves as an education law specialist with Pacific Resources for Education and Learning ("PREL") here in Honolulu. PREL has staff throughout the Pacific and collaborates with schools, agencies, and communities to transform schooling and promote dynamic reciprocal learning communities built on strong social and cultural capital.

Shanty is an integral part of our board. As a community leader from one of the nations that make up the Compacts of Free Association ("COFA"), she has brought needed perspective and knowledge to our board about an important part of our community, too often overlooked. She is also hard working and is quick to respond to emerging issues in the immigrant community. For instance, when members of the COFA community were recently prevented from applying online for unemployment insurance because of a bureaucratic glitch in the application form, she was key in bringing together a number of community groups that helped solve that particular problem.

Just as Shanty has brought her knowledge, perspective, community awareness, and hard work to TLC, I am sure that she would do the same for the Board of Education. We commend Ms. Asher to you and believe that she would serve ably as a member of the Board of Education.
