Comments:

The Policy Advisory Board for Elder Affairs (PABEA) strongly supports the nomination of Ms. Beverly Gotelli to the PABEA for a term to expire 06-30-2021.

She has been active in many professional and community organizations and a tireless advocate for retirees. - 3. I believe it is best to keep open communication on what the scams are and making the elderly aware of them. Community networks and various senior meetings are a viable way of communicating.
- 4. Now more than ever to get our seniors engaged in safe social media to be informed.
- (4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

I believe I'll be able to work collaboratively with my fellow Board members in reaching decision making on matters that concern seniors.
