G.M. No. 750

G.M. No. 750 submits the nomination of Liann Ebesugawa to the Hawai'i Civil Rights Commission (HCRC), for Senate consideration and confirmation. If confirmed, this would be Commissioner Ebesugawa's second term. Most recently, Commissioner Ebesugawa has served as HCRC Chair from July 1, 2019, through the present.

The HCRC has enforcement jurisdiction over Hawai'i's laws prohibiting discrimination in employment, housing, public accommodations, and access to state and state funded services. The HCRC carries out the Hawai'i constitutional mandate that no person shall be discriminated against in the exercise of their civil rights. Art. I, Sec. 5.

The statutory qualifications for HCRC Commissioners are laid out in HRS § 368-2(a): "The members appointed to the commission shall be selected on the basis of their knowledge and experience in civil rights matters and on the basis of a demonstrated commitment to the preservation of the civil rights of all individuals."

HCRC staff are appreciative of the contributions Liann Ebesugawa has made as an HCRC Commissioner for the past four years, her leadership as Chair since July 2019, and her willingness to continue to serve. Ms. Ebesugawa brings a wealth of experience and expertise to the Commission, and an impressive record of demonstrated commitment to civil rights for Hawai'i's people. Her background in business, government, law, and civil rights advocacy have added valuable perspective to the work of the Commission, and we welcome the opportunity to work with Ms. Ebesugawa for another term.


I respectfully offer this testimony in **strong support** of Liann Ebesugawa's appointment to the Civil Rights Commission.

Dear Judiciary Committee:

I write to most strongly encourage your confirmation of Liann Ebesugawa for the Hawai'i Civil Rights Commission. Ms. Ebesugawa is a dedicated public servant, has long been actively involved in civil rights and social justice issues, is exceedingly intelligent and knowledgeable about Hawai'i issues of law and justice and is insightful, thoughtful, fair and collegial. She will be a substantial continuing contributor to the important work of the Civil Rights Commission.

I write as the Fred T. Korematsu Professor of Law and Social Justice at the William S. Richardson School of Law (I am writing on my own behalf). My areas of specialty include civil rights and human rights. I teach and write in the field of social justice. I first got to know Ms. Ebesugawa when she was a University of Hawai'i graduate student researching and writing about race and ethnicity in Hawai'i. Her concerns and insights. along with her analytical rigor and her passion for contributing to a better Hawai'i, impressed me. I, and others, encouraged her to acquire legal training as part of the next steps in her professional development. At the law school, Ms. Ebesugawa was an outstanding student in my year-long Civil Procedure course for first-year students as well as a top student in my upper level Racial Justice and Complex Litigation seminars.

Because of her intellect and work ethic and her interest in social justice issues, I asked to her serve as my research assistant and to become a Scholar Advocate (part of a special training program I'd been developing for students with commitments to justice work). Her truly outstanding work led me to collaborate with her as co-authors on a major chapter on redress for the World War II Japanese American Internment in the

seminal International Reparations Handbook in 2006. Our jointly authored chapter is still cited regularly.

After her graduation, Ms. Ebesugawa clerked for a progressive Supreme Court Justice, Simeon Acoba, who was known for his careful opinions on issues of civil rights and criminal justice. During her clerkship and her subsequent work with a major downtown law firm and then the Island Insurance Company we kept in regular touch. I know that her decision later to work for the Board of Education stemmed fully from her desire to make a meaningful contribution to steps forward on perhaps the most thorny and pressing local issue in Hawai`i: public school education.

I also have seen Ms. Ebesugawa actualizing her concern for social justice through her long-standing grassroots and leadership work with the Japanese American Citizens League – Honolulu. The JACL Honolulu is considered the most active and forward thinking of all the JACL chapters across the nation. It has been a leader in support of Native Hawaiian self-determination, same gender marriage, Micronesian medical care, Kamehameha Schools admissions and fair treatment of Muslims in America, among other things. Ms. Ebesugawa has been deeply involved in organizing, analyzing, collaborating, communicating and advocating on these issues – all in a powerful yet very grounded and balanced way. And as she became a key part of the leadership of the Honolulu chapter, I saw her emerge as a genuine leader. And a tireless worker.

Through my interactions with Ms. Ebesugawa, and particularly through her leadership, the JACL Honolulu chapter has become a friend of the court in numerous amicus briefs I co-authored to the Hawai'i Federal District Court, the Ninth Circuit Court of Appeals and the United States Supreme Court, including a brief in the Trump v. Hawaii "travel ban" challenge. It has also been a signatory to op-ed essays to the newspapers and been a sponsor for many public educational forums of civil and human rights issues – including the 75th anniversary commemoration of the Japanese American Internment spotlighting present-day issues of "National Security and Democratic Liberties".

As a Civil Rights Commissioner, and now Chair, Ms. Ebesugawa has been assertive and creative in her work on behalf of Hawai'i's communities. She participated in the hiring of excellent new Commission legal counsel and staff. She continues to network with laypeople, lawyers and community advocates as well as businesspeople, government officials and policymakers. And she engages in important Commission public outreach and education. For example, a Commission/HUD sponsored educational forum that brought together public sector (HUD - local & national, the HCRC, the Commission on the Status of Women), private sector (American Savings Bank), non-profits and union representatives.

For all these reasons, Ms. Ebesugawa is ideally suited to continue her service on the Civil Rights Commission. She thoroughly deserves to be reappointed to the Commission and to be confirmed as its Chair. Her intellect, commitment to justice work, scholarship, organizing skills and vision, thoughtful advocacy, diverse work experiences in the private and public sectors and her collegial approach to problem solving – all

demonstrated by her outstanding recent work on the Commission and her service as Commission Chair – will enable her to make continuing contributions to the Commission's important justice work for our Hawai'i communities.

SENATE COMMITTEE ON JUDICIARY QUESTIONNAIRE

Respondent: Liann Ebesugawa

Re: Nomination to the Civil Rights Commission, Governor's Message No. 750

1. Please describe your understanding of the role and jurisdiction of the Civil Rights Commission.

The Commission is responsible for enforcement of the laws prohibiting discrimination in employment, public accommodations, real property transactions and access to services receiving state financial assistance. Beyond the very technical definition, I believe the ultimate role of the Commission is to ensure a fairer more just community.

2. How do you perceive the role and responsibilities of a member of the Commission?

As a member of the Commission, I see my role as effectuating the duties of the Commission as stated above. Specifically, Commissioners play key roles in ensuring the fair adjudication of contested cases that go to hearing and supporting civil rights policy-making, including rulemaking for the Commission and positions offered in testimonies on legislation. I believe that as a volunteer community member, I have an obligation to serve in my capacity as a member of the Commission to the best of my abilities and in a way that supports and enhances the effectiveness and integrity of the agency.

3. Why do you wish to continue to serve as a member of the Commission? Please note if you initially applied to be nominated to the Commission or if you were invited to apply.

I had applied in 2017 to be a member of the Commission and gratefully, I was confirmed at that time. When my term was nearing completion, I again applied to the Governor's office to serve a second term. I have found the work at the Commission to be extremely rewarding and I believe that the agency does its very best to protect our community. I have been honored to be a part of that work in my capacity as a member of the Commission. I remain deeply passionate about working in our community and ensuring that service and volunteerism is a consistent priority in my life. Additionally, I think my interests and prior experience can continue to be of service to the Commission.

4. Please describe why you believe that you are qualified to be a member of the Commission, and discuss any skills, expertise, knowledge, or volunteer involvement that would aid in your decision-making ability.

I am an active community member with a background in civil rights advocacy, government service and employment law. I believe my work experience and community involvement has been helpful to the Commission. I have both private and public sector experience which has helped me to understand how important the balance of these interests are to a vibrant thriving community. I have had broad private practice experience as an attorney, which allowed me the opportunity to work with a variety of industries and develop skills at various levels of business. I have represented government, union and private industry in employment matters. I have also served as an administrator for a state board. Most recently, I was an attorney for the state's electric utility and I am now an attorney for its publicly traded holding company.

As a community volunteer, I have held leadership roles in professional and non-profit organizations and co-founded a non-profit organization. The leadership roles I have held allows me to understand the importance of having accountability and measurable outcomes, and how to achieve and implement policies to obtain these goals. While serving as president of the Hawaii Chapter of the Japanese American Citizens League, one of the oldest and largest Asian American civil rights organizations, we assisted with Hawaii's successful marriage equality campaign and garnered national organizational support for COFA migrants.

5. What do you hope to accomplish during your second term as a member of the Commission?

As with my first term, I would like to be sure that I have contributed to protecting the rights of our community. I would like to be able to see a community that understands and utilizes the services of the Commission. I would also hope to continue to support the purpose of the Commission so that the office can ensure that it will continue to make significant impact on our communities for years to come.

6. What issues do you believe that the Commission has handled well in the past? What issues do you believe that the Commission should address in the future?

I believe one of the unique benefits of the Commission is that it offers to the state expertise in the area of civil rights issues both through its day-to-day activities of enforcement of anti-discrimination laws and presenting before the legislature. Having the Commission available to bring civil rights perspectives and credible information (not as advocates but as agency experts) on a range of issues, which have sometimes been controversial or unpopular, advances the state's and public's interest in a fairer more just society.

Given the current state of the world, it will be imperative that the Commission address effective provision of services. This will mean exploring alternative technical support systems and ways of working. In essence, the Commission will need to grow and change to accommodate the changing needs of our

communities.

7. Can you foresee any possible conflicts of interests that could arise during your continued service on the Commission? How would you overcome any possible conflicts of interest?

I do not believe there are any conflicts of interest. As Commissioners we recuse ourselves from a case when a conflict arises or to avoid an appearance of a conflict.

8. Is there any other information regarding your experience and background that you believe should be considered for your nomination?

I believe my work and volunteer community experience supports my confirmation to the Commission as it demonstrates a commitment to the betterment of our community and to the development of my knowledge both legal and practical that I hope can continue to assist the Commission in its work.

9. Is there anything in your background that might be deemed as negative or controversial by the Senate?
