1. Please describe your understanding of the role and jurisdiction of the Defender Council.

To oversee, guide, and assist the Office of the Public Defender in the discharge of its duty to provide the best possible legal representation for indigent citizens accused of crimes. Most recently that included specifically the selection of the new Public Defender.

2. How do you perceive the role and responsibilities of a member of the Council?

As noted above the Council should provide guidance and direction with the ultimate goal of improving the ability of the Office of the Public Defender to better serve its clients and the Community.
