Comments:

The defender council consists of at least one member from each of the counties of the state (Honolulu, Kaua'i, Maui & Hawai'i). As a former Public Defender and Maui Prosecutor, I believe Gina Gormely is the best Maui candidate for this position and support her committment to service.

The defender council serves as the governing body of the Office of the Public Defender. One of the primary duties of the council is the appointment of the State Public Defender. I'm currently the managing attorney for a non-profit small family law firm that serves victims of domestic violence. During these unprecendented times, strong leadership is imporatant. Gina is a leader in her community and in the legal field. Gina is a graduate of the Hawaii State Bar Association Leadership Insitute. Gina's practice in criminal defense and immigration are skills directly applicable to this position.

1. Please describe your understanding of the role and jurisdiction of the Defender Council.

The role and jurisdiction of the Defender Council is to be the governing body of the Office of the Public Defender. In addition to this, the Defender Council provides guidance to the Office of the Public Defender in carrying out their mission of providing zealous and effective representation of their indigent clients.

2. How do you perceive the role and responsibilities of a member of the Council?

I have been a solo-practitioner for the last six years practicing criminal defense, family law, and immigration. I was also a deputy public defender for four years on both the island of Oahu and Maui. I have been involved in every single stage of a criminal matter as described in the purpose. I still work by that purpose as a solo-practitioner. I understand the dynamics of that office, the purpose it serves, and its mission.

State Public Defender James Tabe invited me to apply.

4. Please describe why you believe that you are qualified to be a member of the Council, discuss any skills, expertise, knowledge, or volunteer involvement that would aid in your decision-making ability.

In addition to my experience as a deputy public defender and criminal defense attorney, my experience as a solo-practitioner has provided me with invaluable experience. I have been running my solo-practice for the past six years and have learned every aspect of running a business. In addition to criminal defense, I expanded my practice areas to include family law and immigration. As a solo-practitioner, I am afforded the flexibility to serve in different associations and organizations. I serve as Vice-President of the Hawaii Chapter of the American Immigration Lawyers Association. I previously served as Treasurer and New Member Liaison. I am also a volunteer attorney with the Hawaii Innocence Project. I will bring to the Defender Council all of my knowledge and expertise that I gained through my experience.

5. What do you hope to accomplish during your term as a member of the Council?

I hope to accomplish providing effective support for the Office of the Public Defender as a member of the Council. I hope to be a contributing member of the Council to assist the newly appointed Public Defender in dealing with all of the various new issues that have arisen this year due to the health crisis. Overcoming this pandemic and its economic and social effects will likely last for years.
