I served five years as a Surface Warfare Officer in the U.S. Navy, stationed at Norfolk Virginia and Everette Washington. In 2012, I transitioned from active duty service and returned home to O'ahu. Since 2012, I have been an active member in the business community and other organizations within the State.

There are several primary reasons as to why I would like to serve on the Veterans' Services Advisory Board.

First, I view service on this Advisory Board as a responsibility. I have been the beneficiary of amazing Veteran entitlements, entitlements that were sought out by veterans who wanted a better future for those who came after. The time is now for me to do my part ensuring our Veterans are cared for properly.

Second, the Advisory Board needs to better fit the demographic representation of the Hawaii veteran community. Hawaii is a state where the veteran population is contrary to the national average. Hawaii has a higher percentage of younger veterans (those under the age of 44 years old). Fitting into this category I would be an asset to the board. I understand the issues that are experienced. I have gone through them, issues of GI bill entitlement, post military employment, disability ratings, VA health care and many more. Having navigated these issues, I was forced to become a resident expert on where to find help and who to ask.

Lastly, as a service-disabled veteran, I rely on the Veterans Administration as a primary source of healthcare. This allows me the opportunity, and unique experience, to better understand the services available to veterans and the systematic barriers or disconnects within. Having personally experienced these disconnect I do not want others to endure the same frustrations.

I believe I am qualified for the following reasons:

- Honorably served five years in the U.S. Navy as a Surface Warfare Officer.
- Disabled veteran with first-hand knowledge of the VA Healthcare system.
- Understanding of how to navigate VA services.
- Active Community Organizer-Naval Academy Alumni Board Member, Blue and Gold Officer, Varsity Assistant Football Coach, Chamber of Commerce (Kona) Young Leaders Board Member.
- Mentor for actively transitioning or recently transitioned veterans.

As a business leader and active member in our community, I believe I can provide positive insight and guidance to help the Director of Veterans' Service. As a veteran, I hope to continue to help others understand how to access the full range of veterans' services and successfully navigate the transition from military service to the civilian community. My goal is for all veterans to be successful, thriving members of the communities they helped to protect while wearing the uniform.

Thank you for considering me for appointment to the Veterans' Services Advisory Board. I hope to be afforded the opportunity to serve and help better our Hawai'i.
