#### 1. Why do you want to be a member of the Board?

As someone who has spent almost his entire life living a few blocks from Leahi Hospital, the hospital has been a big part of my life. In elementary school, my class and I would go to Leahi Hospital at least twice a school year. As a class, we would spend our time talking with the patients who did not have regular visitors and sometimes even sing to them. This is a tradition that has continued for the school to this day and I am happy to have been a part of it.

I drive past Leahi Hospital almost every single day and it is a constant reminder about the good they have done, and continue to do, in my community. While I have always wanted to ensure that Leahi Hospital be able to continue that good work, my interest in the board did not happen until much more recently. In the current climate, the future of Leahi Hospital and Maluhia, as well the growing need for long term care services for our most vulnerable kupuna, are topics still in need of much discussion, and I would like to be a part of it.

2. What do you perceive are the roles and responsibilities of a member of the Board?

I believe the roles of the board members take many forms. Board members are awarded the responsibility of being protectors of the corporation and the community that uses their services. Being responsible for balancing the furthering of the public interest and ensuring that the corporation will be able to continue its service is a difficult task.

Board members are also innovators. Especially in this difficult time, we are faced with unprecedented challenges, requiring new and creative policies and procedures to effectively manage a delicate system. The board members are responsible for aiding in the development and implementing the best plan that is appropriate for its community.

3. In what ways do you feel that you can help protect the consumer?

While I hope that it will not be necessary to be a consumer of the Hawaii Health Systems Corporation, that possibility is something that is constantly on my mind. I am one of the many members of the public caring for aging relatives. It is my hope that, I will be able to care for them for as long as possible. However, as they grow older, I have had to face the reality that there may come a time when I will not be able to.

As a board member, I would be given a rare opportunity to provide an amplified voice for the concerns that I, and many community members, have been contemplating for years. Issues concerning adequate privacy and space, quality of care, and quality of life are very important questions while providing long-term care to our kupuna.

4. Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

During high school, I was placed into many college classes. As a result, I was able to graduate from University of Concordia, Irvine, in just two years, with a degree in business

management. During my time there, I honed my skill in marketing, accounting, economics, and finance, and information systems, completing project after project, while developing skills in leadership, planning, and strategy to help my team work together and efficiently achieve our goals.

After returning home, I further developed these skills in the House of Representatives. Starting as a staff member during the legislative session, I quickly became the office manager and worked to build a team that could meet its goals each and every session. Each year came with new challenges and opportunities to learn about issues effecting the state, especially with regards to the higher education, finance, and judiciary committees. I did all this while attending the William S. Richardson School of Law.

I am confident that my business and legal education, along with the management, finance, and interpersonal skills I have developed over the past near decade will be an invaluable asset and significant contribution to the board.

5. What do you hope to accomplish during your term of service?

While my main hope as a member of the board would be to ensure the continued function of these essential services, there are two projects in particular that I hope to help accomplish. The first project is something that I think is very important as we move forward. With funding cuts over the last few years, Leahi Hospital was forced to shut down part of their facility. It is my hope that I can be a part of reopening these spaces to help provided service to more of the community.

The second project I would like to focus on is building a secondary parking lot at Maluhia. This is a project that has been in its initial design phase for years but has been unable to break ground. Currently, some staff members are forced to park out in the residential areas and there is limited capacity for visitors. This problem also burdens the residents in the area as it reduces the number of parking spaces available for residents. I would look forward to working with everyone involved in order solve both these problems.

6. Name three qualities that best describe you and how these qualities will benefit the Board.

I am conscientious, calculated, and committed. If confirmed, I can promise that I will be a conscientious servant, doing my best to do what is right and fulfill my duties well and thoroughly. I can promise that every action will be calculated, using all the knowledge and information available to me, to work toward the best solution. I can promise that I will be committed and loyal to the board, the tasks before me, and the community, for as long as you will have me.

7. Name a previous experience you've had that will be beneficial as a Board member.

After passing the bar exam, I took a job at the Managing Director's Office, for the City and County of Honolulu. While the original job was primarily to aid the different departments

coordinate efforts regarding proposed legislation, the onset of the COVID-19 pandemic turned that job description upside-down. Instead, I became tasked with many different projects. Along with my coworkers, we worked together to come up with new programs and ideas to protect the community's safety, provide access to healthcare, and mitigate economic impacts while we all move through this difficult time.

This experience has been, and continues to be, helpful to reinforce problem solving and communication skills, as well as provide knowledge of the most pressing issues facing the community during this pandemic.

8. Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

As an attorney, the most foreseeable conflicts of interest will arise with clients. One of the requirements for passage of the bar exam is to also pass an ethics test. This test is guided by the ethical behaviors that are required of all attorneys by the Office of Disciplinary Counsel. As such, regarding these types of conflicts of interest, I am required to handle them according to those rules. That could mean not accepting them as clients, abstention from voting, and disclosure of the conflict.
