In consideration of GOVERNOR'S MESSAGE 838 SUBMITTING FOR CONSIDERATION AND CONFIRMATION TO THE NATURAL AREA RESERVES SYSTEM COMMISSION, GUBERNATORIAL NOMINEE, ARTI CLARK, FOR A TERM TO EXPIRE 06-30-2024

The Department of Land and Natural Resources (Department) strongly supports Governor's Message 838, nominating Arti Michelle Clark to the Natural Area Reserves System Commission for a term to expire June 30, 2024.

Ms. Arti Michelle Clark graduated with a Bachelor of Arts in Biology (with Honors) from the University of Hawai'i Hilo in 2001, with a major in Conservation Biology, Evolution, and Ecology, and a Minor in Tropical Forestry. She was a Soil Conservationist with the U.S. Department of Agriculture, Natural Resources Conservation Service (NRCS), Pacific Islands Area from 1999 to 2008 on the island of Kaua'i where she helped to develop conservation plans for over 9,500 acres of agricultural and wildlife habitat. She was instrumental in working with the Kaua'i Native Plant Society to create an exhibit at the United States Botanic Garden Conservatory (USBGC) in Washington D.C. Titled "Our Nation's Crown Jewels: Rare and Endangered Plants of Hawai'i", the exhibit resulted in a permanent exhibition room of native Hawaiian plants at USBGC. From 2008 to the present, she has been the Kaua'i Partnerships Biologist with the U.S. Department of the Interior, Fish and Wildlife Service (USFWS) where she collaborates with private landowners, non-government organizations, and the State of Hawai'i to implement conservation projects which aid in the recovery of listed species and threatened ecosystems in a variety of habitats on the island. She works with partners from diverse ethnic and cultural backgrounds in a range of environments from coastal areas to caves, mesic and wet forests, and montane bogs. She is involved in a number of programs and activities
