# H.B. 1164 RELATING TO DEFERRED MAINTENANCE

Chair Johanson, Vice Chair Eli and Members of the Committee, thank you for the opportunity to testify on H.B. 1164 which establishes a deferred maintenance task force within the Office of the Governor to create a standardized schedule and uniform approach to address deferred maintenance projects in the state.

The Department of Accounting and General Services (DAGS) would like to offer the following comments:

- 1. The Directors should be able to send a delegate that would be more familiar with deferred maintenance.
- 2. Additional departments should be included. DAGS is responsible for about 70 facilities statewide while other departments have much more facilities that they are responsible for.
- 3. DAGS is only responsible for office buildings while other departments would have experience with managing many other types of facilities and its deferred maintenance.
