## OPPOSITION to HB 1177 - PURCHASE OF FDC AS REPLACEMENT FOR OCCC

Aloha Chair Luke, Vice Chair Cullen and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai'i for more than two decades. This testimony is respectfully offered on behalf of the families of **ASHLEY GREY**, **DAISY KASITATI**, **JOEY O'MALLEY**, **JESSICA FORTSON AND ALL THE PEOPLE WHO HAVE DIED UNDER THE** "CARE AND CUSTODY" OF THE STATE as well as the approximately 5,400 Hawai'i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that more than 1,600 of Hawai'i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

Purchasing the federal detention center, and old-style prison, has been in the ether for a long, long time. This is a rush to judgement solution for a long-standing problem...overcriminalization and overcrowding.

Why is the House sneaking in this proposal to purchase the 20-year old federal detention facility AFTER the final report of the 2-year correctional reform task force?

If we really want to reduce recidivism and the overpopulation of our correctional facilities, we should take the bold steps many other jurisdictions have taken and implement <u>real</u> sentencing reform.

We cannot continue looking for space instead of looking for solutions. WE KNOW WHAT WE HAVE TO DO. The research is clear – overcriminalization leads to overcrowding and jails are the main drivers of mass incarceration.

Stop talking about buildings and talk about PEOPLE! 74% of our imprisoned population are serving sentences for the lowest felonies, misdemeanors, violations, petty misdemeanors and parole and probation violations. What we are doing is wasteful both socially and economically and this approach to corrections is clearly not sustainable.

Please hold this measure.

### Comments:

I strongly oppose HB 1177 HD1.

Buying the Honolulu Federal Detention Center would be an extremely unwise move. More discussion and community involvement needs to happen so that we do not make a ill-considered decision that will plague the state for decades and saddle Hawaii taxpayers with an inefficient and costly mistake.

Many advances have been made in the implementation of criminal justice, as clear from the experience of many other states. Hawaii needs to learn from the experience of other states.

The HCR 85 Task Force has laid out concrete suggestions. The task force recommendations must be considered if we are ever to make our criminal justice system more efficient, cost effective, and humane.

There is no reason that our jails should be populated with homeless, the mentally ill, and low-level drug offenders. Diversion programs that address specific problems such as presented by these three groups would be more efficient and cost effective than warehousing individuals at a huge cost to the Hawaii taxpayers.
