RELATING TO FEDERAL WORKERS

House Bill (H.B.) No. 1195, H.D. 1, establishes the Federal Furlough Loan Program within the Department of Budget and Finance to provide interest-free loans to furloughed or excepted federal workers to help them cover rent or mortgage payments during the federal government shutdown and provides an undetermined amount of general funds in FY 19 to fund the loans.

The department appreciates the intent of the measure but believes that it is no longer necessary given that funding has been provided to all federal agencies for federal fiscal year 2019.

Prior to the temporary reopening of the federal government, the Office of the Governor was working to establish a contingency loan program in partnership with local financial institutions to provide emergency loans to the affected federal workers. Unlike the department, these entities already have the staff, infrastructure, and expertise to evaluate applications and disburse small loans to qualified individuals. This contingency loan program can be set in motion should the need arise again in the future.
