Support! There is great interest in changing our county charters to provide for professional managment of county operations as opposed to the political appointment process that has prevailed in all Hawaii counties since statehood. Aproximately 23rds of all cities and counties across the nation have a professional county manager running day-to-day operations with the manager hiring and firing subordinate directors. In some cases cities and counties have an elected mayor who hires the manager and in others the mayor is the chair of the council. In either case, the position needs to be free from civil service designation. Here in Maui County the council has twice considered a charter change to provide for professional management of operations and in both instances the question has not gotten out of committee by a hair, but there is tremendous public support for better, more efficient, less political local government and the best way to achieve this is through a change in structure which places a well qualifed, experienced manager in charge of operations. We have progressed greatly since the days after statehood when local governance challenges were less complex. Not so today. I know Kauai County is also interested in exploring this change. Kauai is concerned the manager position might be subject to civil service. Maui County is less concerned because the position will be that of a Director in charge of a Department of the a Managing Director thus placing the position outside civil service perameters as the law is currently written. However, eliminating whatever vaguery exists would be helpful to all who want to move forward with a more modern local governance model. The Hawaii Constitution gives counties great freedom to define local governance structure. This amendment would be consistent with this Constitutional perogative.
