Chair Lee and members of the House Committee on Judiciary, thank you for the opportunity to provide comments on House Bill No. 1327, HD 1. This bill makes a request for an absentee ballot, and an absentee ballot available in Hawaiian.

We would like to confirm that we would be making an absentee ballot available in Hawaiian, rather than a dual language ballot combining English and Hawaiian. Similarly, we would ask that the provision be limited to absentee ballots, as written, as the current direct recording electronic (DRE) voting system is not certified for Hawaiian. The federal law requires the DRE voting system for in-person voting to ensure accessibility for all voters.
