Title of Bill: HB 1485, HD1 RELATING TO VOTER REGISTRATION.

Purpose of Bill: Establishes a process, beginning on January 1, 2020, for automatically

preregistering or registering public school-enrolled students who are at

least 16 years old. (HB1485 HD1)

Department's Position:

The Department of Education (Department) supports the intent of HB 1485, HD1 to increase Hawaii's youth voter participation and encourage civic engagement. This measure proposes to establish a process for automatically preregistering or registering public school-enrolled students who are least sixteen-year-old to vote in our state.

We prioritize civic engagement and efforts to increase voter participation among the future leaders in our public high schools. Towards this goal, the Department supports automatic voter registration as a mechanism to remove barriers to strengthen the voice and involvement of our youth.

The following amendments are respectfully offered for the Committee 's consideration:

Page 5, lines 2-5:

The superintendent of education shall department of education may transmit the voter registration affidavit to the clerk of the county in which the applicant resides, as necessary:...

Page 6, lines 9-13:

The board and the superintendent shall may adopt and communicate guidelines policies as necessary to maximize and facilitate the preregistration and registration of qualifying students to vote as provided in section 11-.

As this proposed measure will involve all Hawaii public high schools, further dialogue is needed to ensure effective implementation of HB 1485, HD1 in regards to the provision of voter affidavits translated in other languages for students and families whose primary language is

other than English.

Hawaii public schools continue to strengthen civic engagement as a critical avenue to cultivate positive change and a shared responsibility for our community well-being.

The Department appreciates the opportunity to provide testimony on HB 1485, HD1.

The Hawaii State Department of Education seeks to advance the goals of the Strategic Plan which is focused on student success, staff success, and successful systems of support. Chair Luke, Vice-Chair Cullen and Committee Members:

The League of Women Voters strongly supports HB 1485 HD1 that would provide public high school students age 16 but not yet 18 and otherwise eligible to vote to be automatically preregistered. This is a very innovative approach to building lifelong voting habits among young people; our hope is it also starts a lifelong habit of being engaged in civic life and becoming informed voters who learn as much as possible about issues and candidates.

Your Committee on Judiciary clarified that students do maintain the option to subsequently opt in or opt out of preregistration or registration. This maximizes the window during which the student may change his mind about pre-registering.

In response to the legitimate student privacy concerns of the Department of Education, the HD1 version of this measure does not require electronic submission of pre-registration forms but does allow the Superintendent to manually transmit the forms to the County Clerk, election officials and the statewide voter registration system. Foregoing the operating cost savings and security of automatic transmission from records maintained by the Department is disappointing, but we certainly defer and respect the provisions of the federal Family Educational Rights and Privacy Act.

In their testimony the Department of Education identified "student voice," as an impact strategy of their Strategic Plan, so the Leagues hopes the Department will reconsider (and advocate) that learning how to register to vote and then actually registering *are* legitimate educational interests. A modest appropriation for this bill is still appropriate as the high school student population is less familiar with how to register to vote than older people. We defer to education officials on what this amount should be.

We note that HB1485, HD1 could be implemented in conjunction with automatic *registration* approaches under consideration this session including HB1217 and SB 412, SD1, both of which require that people automatically be registered to vote if they meet the eligibility requirements to vote when they obtain a driver's license or State Identification card.

We support the measure's effective date of January 1, 2020. Thank you for the opportunity to submit testimony.

Dear Chair Luke, Vice Chair Cullen, and members of the Committee:

Thank you for the opportunity to provide testimony in **SUPPORT** of **HB 1485 HD1**, which would establish automatic voter pre-registration for 16- and 17-year-old public school students in our state.

According to the United States Election Project, fewer than 4 in 10 of Hawai'i's voting-eligible population voted in the 2018 general election, yet again placing us last in the nation.¹

The logistical barriers to pre-registering to vote for our low-income students, since they and their guardians are less likely to have the time, means and/or transportation to register in person or via mail, and also are less likely to have internet access to register online.

Automatic Voter Registration (AVR) would help overcome those barriers. And an AVR system would ensure that the registration process is convenient, accurate, and secure. Implementing AVR would:

- Help the State and Counties be more efficient by saving staff from manually inputting data. It costs almost 30 times more to process a paper application versus an electronic one.
- Make elections more secure and accurate with frequent updates to the voter rolls.
- Make voting more convenient for working and military families who move frequently.

We need to do more to get more than 4 in 10 of our eligible voters to vote in our elections. AVR would be a good start.
