SUBJECT: House Bill No. 1499, Relating to Criminal Trespass

I am Gregory Osbun, Major of District 2 (Mililani/Wahiawa/North Shore) of the Honolulu Police Department (HPD), City and County of Honolulu.

The HPD opposes House Bill No. 1499, Relating to Criminal Trespass, which requires County police officers to remove criminal trespassers from State lands upon request from State departments and agencies.

The HPD believes that addressing trespass violations on State lands should be the responsibility of State law enforcement agencies. Requiring HPD officers to take enforcement action simply based on a request from a State department or agency not only will dramatically increase an HPD officer's workload, but will be problematic. A "request" is simply too vague and broad. A landowner and/or authorized representative should be present to identify trespassers and request removal of an individual(s) from the property.

HOUSE BILL NO. 1499 RELATING TO CRIMINAL TRESPASS

Chairperson Takayama and Members of the Committee:

Thank you for the opportunity to testify on House Bill 1499 relating to criminal trespass. This Bill requires county police officers to remove criminal trespassers from state lands upon request from state departments and agencies. The Department of Agriculture strongly supports this measure.

The Department has a history of unauthorized persons entering agricultural lands and irrigation facilities. We have and continue to experience theft of crops and equipment; vandalism including bullet holes in trespass signs, fence cutting, reservoir liner destruction, ditch lining damage, graffiti, equipment damage, etc.; illegal dumping of abandoned vehicles, non-farm equipment, household appliances and furniture, etc.; and trespassing such as squatting, camping, partying, and sunbathing. Our employees are instructed to call the authorities whenever they witness these types of activities however the Sheriffs often lack the manpower to respond in a timely manner and our success with the County police departments is inconsistent. Often a police officer will give us a courtesy assist by showing up and talking to the trespassers once they are on the county street, however we are always informed that either they can't respond as it is



State land, or if they respond, they can't enter the property for the same reason. Most of the repeat trespassers know this and simply wait the officer out.

This bill will help the Department's farmers, and staff deal with the trespassers by giving the police departments authority to enter State lands and remove the violator.

Chairperson Takayama and Members of the Committee:

My name is James Nakatani, Executive Director of the Agribusiness Development Corporation ("ADC"). The ADC provides the following comments on House Bill No. 1499, which requires county police officers to remove criminal trespassers from state lands upon request from state department and agencies.

The Honolulu Police Department (HPD) has provided critical support and outreach to address the community's concerns regarding illegal squatters on State land in Whitmore Village. With HPD's assistance, ADC staff were able to peacefully issue trespass warning and remove numerous individuals from ADC land. HPD, through their Community Policing Team went above and beyond our expectations by coordinating the enforcement efforts, as well as reaching out to local non-profits to join the enforcement and help provide outreach to any displaced individuals.

In addition, HPD provided knowledgeable Officers who are familiar to the community to investigate the reports of noise complaints, gambling, drug activities, and

prostitution allegedly occurring on State land. The community policing team and its Officers provided invaluable intelligence by scouting the area and relaying critical information to ADC staff to enhance its efforts to reclaim the land. Although the effort to remove criminal trespassers is still ongoing, the ADC staff would not have been able to make any progress without HPD's help and support. However, without a long-term solution to address the homeless crisis on Oahu, these individuals will keep on returning.

Aloha, I'm writing to the regards of HB1499 bill being passed. My particular position is specific and so far, I havent had the help I so dearly need to resolve it. I've been denied help by HPD because the particular trespass is on state property. I live right next to Diamond Head Health Center (3627 Kilauea Ave). My address is 3619 Kilauea Ave, 3rd House. The windows on the left side of my house, both my kitchen and bedroom have the view of the staircase by the dumpsters near the parking lot and over the past year, the homeless have continued to move in to live- both in front of the actual clinic itself, in the parking lot and to my dismay, the staircase and the area the staircase leads to, a grassy covered area on the lower level.

It may be hard to imagine but because of this, my sense of privacy and peace has been taken away. There is a particular homeless woman who walks up and down the stairs at all hours of the night and day. Particually in the middle of the night at about 2AM- 5AM. She has access to bulk trash which has been laying there for months now including some mattresses that she carries up and down the stairs, again in the middle of the night. Myself and many of my neighbors own dogs and because of the disturbances, they bark all night. I have it the worst because my bedroom window is right in front of the staircase and my dog barks for security. I have not had a good nights sleep in months.

Some may say the fix is simple, call the police. But what no one knows is that they have informed me that they are not permitted to help me. The most I can do is call them for patrol and they cannot escort her out because it is state property. They can only by law, patrol drive in and out. This means she is free to live on state property and no one can tell her to leave. Not even HPD. Even though there are clear signs that say PRIVATE PROPERTY, NO TRESPASSING. The homeless continue to thrive at Diamond Head Health Center.

I've tried to speak to her, I've asked her to please just dont walk up and down from late night to early morning and I was met with swear words and threats to "be careful". During daylight hours, my windows fall so close to the staircase that she can peer into my home, taking my sense of privacy.

I've been emailing and calling various departments within the state and city &county only to be bounced around and referred several times over with no one wanting to address it. To date, I've been referred to Department of Health, Department of Transport, Office of the Govener and much more. Each saying they do not take responsibility for trespass on a state owned property.

I've spoken to a clinic worker who have said there is no property owner at the clinic at this time. They too have been frustrated with the homeless and trespass situation but there is no designated person responsible, leaving me over looked and ignored countless times. Again, no one to take responsibilty.

To me, the fix is simple. When an individual is tresspassing on a private state owned property past business hours, in the middle of the night and causing disturbance, I should be able to call HPD and they should be able to take the few steps down the stairs to remove them. But as it stands today, this is not the standard.

I'm truly empathetic to the homeless problem in Hawaii. The cost of paradise is so great. I cannot, however, let this situation go on much longer. As a medical worker myself, I'm appalled that that a state owned medical facility would allow this place to be a dumping ground for bulky items and also aid in protecting aggressive and law breaking trespassers. I'm appalled that this situation has been ignored despite my cries for assistance.

I humbly ask you to consider my testinmony in your discussions and decision on this bill. I love my home and my neighborhood and I'm asking for a chance to take control of my security. Sadly, my situation is the very picture of this bill, my situation was made for this bill. Please hear me out.
