Testimony COMMENTING on H.B. 1509 RELATING TO CIGARETTES

REPRESENTATIVE JOHN M. MIZUNO, CHAIR HOUSE COMMITTEE ON HEALTH

- 1 Fiscal Implications: None
- 2 **Department Testimony:** The Department of Health (DOH) provides comments on the vision of
- a Tobacco-Free Hawaii that this bill aspires to. The Department also suggests amendments to
- 4 include all tobacco products including ESDs, cigars, and smokeless tobacco products.
- House Bill 1509 (H.B. 1509) amends Section 712-1258, Hawaii Revised Statutes (HRS), to alter the definition of 'tobacco product." It adds a new section to part IV which proposes an age prohibition schedule wherein the minimum age of legal sale and furnishing of tobacco will be gradually increased over a period of five years. This new section includes amendments to age
- 9 verification and signage requirements to accommodate the gradual raising of the minimum age
- of legal sales.
- All tobacco products contribute to the health burden of tobacco use in our state and
- country. The evidence shows that smokeless tobacco and cigars cause serious harm to health.
- 13 According to the American Cancer Society, smokeless tobacco causes mouth, tongue, cheek and
- 14 gum cancers, cancers of the esophagus, and pancreatic cancer. Other health problems associated
- with smokeless tobacco use include heart disease, and increased risk of heart attack, stroke and
- increased risk of pre-term or still birth when used during pregnancy. Cigars are causally related
- to similar health outcomes. The Federal Food and Drug Administration (FDA) states "all cigars
- are harmful and potentially addictive (including small cigars, cigarillos, large cigars, and
- 19 premium cigars). Cigar smoking is strongly related to certain cancers (including oral,
- 20 esophageal, laryngeal, and lung cancers), heart disease, and premature death. Cigar smoking can
- cause cancers of the mouth and throat, even for smokers who do not inhale."
- New and novel products like electronic smoking devices (ESDs) also known as e-
- 23 cigarettes are evolving at unprecedented rates. Heated tobacco products are now marketed in

- Asia and Europe and the industry is awaiting FDA approval for the U.S. market. These products
- are slated to eventually replace traditional, combustible cigarettes. Hawaii, and the nation, are
- 3 currently witnessing a tobacco control crisis that threatens -the progress made over the last three
- 4 decades.

- Both the U.S. Surgeon General and the FDA Commissioner have raised concerns on the epidemic of youth ESD use across the nation. From 2017 to 2018, high school youth e-cigarette use rose by 78%, from 12% to 21% in the U.S. iii The Hawaii youth e-cigarette use is 25% statewide, and above 30% in the neighbor island counties. iv The 2016 Report of the U.S. Surgeon General warned that youth are more vulnerable to the negative consequences of nicotine exposure. The brain is developing till 25 years of age, and the effects of nicotine include "addiction, priming for use of other addictive substances, reduced impulse control, deficits in attention and cognition, and mood disorders." Fetal exposure can have negative consequences including sudden infant death syndrome, altered corpus collosum, and deficits in attention and cognition. Children are also at risk from ingesting the e-liquids that can cause acute toxicity and
 - The FDA has encouraged states and localities to enact strict laws for the legal age of sale of tobacco products. The Department recommends that any graduated age strategy include other tobacco products, including ESDs that are marketed to and addicting young people, and that the definitions of Tobacco Products not be amended in Section 712-1258, HRS to exclude cigarettes.

- 21 **Offered Amendments:** Recommend not amending and excluding cigarettes from the Tobacco
- 22 Products definition, therefore retaining the definition from Section 712-1258(7), HRS:
- 23 (7) For the purposes of this section:
- 24 "Electronic smoking device" means any electronic product
- 25 that can be used to aerosolize and deliver nicotine or other
- 26 substances to the person inhaling from the device, including but
- 27 not limited to an electronic cigarette, electronic cigar,
- 28 electronic cigarillo, or electronic pipe, and any cartridge or
- 29 other component of the device or related product.

- 1 "Tobacco product" means any product made or derived from
- 2 tobacco that contains nicotine or other substances and is
- 3 intended for human consumption or is likely to be consumed,
- 4 whether smoked, heated, chewed, absorbed, dissolved, inhaled, or
- 5 ingested by other means. "Tobacco product" includes but is not
- 6 limited to a cigarette, cigar, pipe tobacco, chewing tobacco,
- 7 snuff, snus, or an electronic smoking device. "Tobacco product"
- 8 does not include drugs, devices, or combination products
- 9 approved for sale by the United States Food and Drug
- 10 Administration, as those terms are defined in the Federal Food,
- 11 Drug, and Cosmetic Act.

TESTIMONY OF TINA YAMAKI PRESIDENT RETAIL MERCHANTS OF HAWAII February 7, 2019

Re: HB 1509 Relating to Cigarettes

Good morning Chairperson Mizuno and members of the House Committee on Health. I am Tina Yamaki, President of the Retail Merchants of Hawaii and I appreciate this opportunity to testify.

The Retail Merchants of Hawaii (RMH) as founded in 1901 and is a statewide, not for profit trade organization committed to the growth and development of the retail industry in Hawaii. The retail industry is one of the largest employers in the state, employing 25% of the labor force.

We OPPOSE HB 1509 Relating to Cigarettes that would progressively bans the sale of cigarettes by raising the minimum age of persons to whom cigarettes may be legally sold to 30 years of age in 2020, 40 years of age in 2021, 50 years of age in 2022, 60 years of age in 2023, and then 100 years of age in 2024.

Bans are not the simple solution and will not stop adults from smoking – noting that it is already illegal for minors. This type of ban would only push the sale of cigarettes into the black market and make it even more attractive and lucrative for thieves to steal cigarettes.

We urge you to hold this measure. Mahalo again for this opportunity to testify.

The Coalition for a Tobacco-Free Hawai'i, a program of the Hawai'i Public Health Instituteⁱ provides **Comments on HB 1509** which would gradually raise the minimum age, effectively banning the sale of cigarettes in five years.

The Coalition supports the intent of this measure. We recommend however that the legislature consider other proven and effective interventions to prevent initiation and reduce adult smoking rates.

The CDC and U.S. Surgeon General recommend the following evidence-based interventions that have a proven history to reduce adult smoking rates:

- Fully funded comprehensive statewide tobacco control programs funded at levels recommended by CDC (\$13.7M compared to \$5.9 in current state funding);
- A higher average retail price of cigarettes through increases in tax or discount restrictions;
- Complete protection from exposure to tobacco smoke through comprehensive smoke free indoor air policies;
- High-impact media campaigns;
- Greater restrictions on sales;
- Full access to cessation treatment for nicotine addiction including counseling and medication for all smokers, especially those with mental and physical comorbidities.

The Coalition also requests that all tobacco products be included in this measure.

HB1509 exempts electronic smoking devices and other tobacco products which are included in our Tobacco 21 law. ESDs or ecigarettes and other tobacco products are still harmful to our health. Hawaii has seen significant declines in our adult smoking rate, at 12.8%, yet our e-cigarette use rates continue to skyrocket. With more

than 1 in 4 high school students, and 1 in 6 middle schoolers using these products, we have an urgent need to act. Further, removing ESDs and other tobacco products may create confusion with the interpretation, enforcement, and implementation of our Tobacco 21 law. Although HB 1509 will help to accomplish our goal of a population free of tobacco-related disease "the tobacco end game", the Coalition believes that the feasibility and application of any proposed end game intervention should be based on proven tobacco control strategies.


