HB 1521 HD1 – RELATING TO THE UNIVERSITY OF HAWAII BUDGET and HB 1522 HD1 – RELATING TO THE UNIVERSITY OF HAWAII BUDGET

Chair Luke, Vice Chair Cullen, and members of the Committee:

Thank you for the opportunity to present testimony today. The University of Hawai'i (UH) **supports** both HB 1521 HD1 and HB 1522 HD1. Both bills appropriate funds for fiscal biennium 2019-2021 for the operating budget of the University of Hawai'i (UH). HB 1521 HD1 represents the "base budget" and the totals by Program ID match those found in HB 2 as introduced. HB 1522 HD1 represents the "add ons" to the base budget. The two bills in tandem appropriate funding for UH's operating budget for the upcoming fiscal biennium and because of this, this testimony will speak to the combination of these two bills.

The University hereby notes that HB 1521 HD1 provides funding at the current (existing) fund levels – meaning, funding at current fiscal year levels. To fund as HB 1521 HD1 proposes to maintain programs and services, at least, to current levels. HB 1521 HD1 reflects the appropriation levels as set forth by Act 53, Session Laws of Hawai'i 2018, with adjustments to account for already agreed upon collective bargaining increases and non-recurring expenditures. We do note, however, that while HB 1521 HD1 provides a base level of funding to UH, it still leaves other processes to provide general fund support to Athletics programs at UH's Mānoa and Hilo campuses, as has been provided in recent years:

HB 1522 HD1 incorporates the additional amounts requested in the Board of Regents' budget request as well the transfers and the general fund support for Athletics programs at Mānoa and Hilo.

In combination, the two bills together (HB 1521 HD1 and HB 1522 HD1) constitute a total operating budget that conforms to the Board of Regents' operating request. Because of this, UH supports both measures in tandem.

Through this letter the Maunakea Observatories express their strong support for HB1522 HD1 UOH 210 Wayfinding Education Program. The Maunakea Observatories partner with 'Imiloa Astronomy Center, which is based at the University of Hawai'i at Hilo, on numerous programs and particularly values the advancement of 'Imiloa's wayfinding programs since they naturally relate to astronomy on many levels. The requested funding would support having a master navigator on 'Imiloa's staff to share wayfinding techniques with students across the State. This is a powerful mechanism to advance Hawaiian culture in classrooms, linking sea wayfaring techniques with Hawaiian star lines as navigational aids, all demonstrated by the recent incredible Malama Honua Worldwide voyage of Hōkūle'a. The planned program includes the use of an inflatable planetarium to take to classrooms and leverages the existing full size planetarium at 'Imiloa for students on Hawai'i Island. 'Imiloa's location next to the base facilities of most of the Maunakea Observatories has catalyzed a unique partnership in science and education. One example is the Maunakea Scholars program - 'Imiloa is a founding partner in Maunakea Scholars and is providing on-site cultural educational opportunities to all Maunakea Scholar host schools (12 schools on 6 islands). The funding requested via HB1522 HD1 UOH 210 would effectively leverage what 'Imiloa has provided to the Maunakea Scholars program, creating a larger and permanent educational program at 'Imiloa in the process. Given 'Imiloa's demonstrated ability to design and implement these types of educational programs, the funds requested represent a low risk, high yield investment by the State. If granted, they would enable a vibrant Wayfinding Education Program that taps into the Maunakea Observatories' resource base via the Maunakea Scholars program – a win from every angle.
