HOUSE BILL NO. 1890 RELATING TO AGRICULTURE

Chairperson Creagan and Members of the Committee:

Thank you for the opportunity to testify on House Bill 1890. This measure amends Section 205-2 by adding "livestock production" to the uses allowed on Agricultural District lands. There is no explanation why specification of livestock production is necessary in this Section. If this measure materially benefits Hawaii's very important livestock industry, the Department of Agriculture stands in support.

Section 205-2(d)(2) describes "farming activities or uses related to animal husbandry" as activities or uses allowed on Agricultural District lands. "Animal husbandry" is cited within nine other chapters in the Hawaii Revised Statutes (26, 103D, 134, 142, 205, 205A, 271, 352, and 471). Farmers and ranchers who raise livestock are considered to practice animal husbandry. Should the Committee decide to support this measure, it may be necessary to amend the other statutory references to "animal husbandry" to accommodate "livestock production".

In 2018, cattle was Hawaii's third most valuable agricultural commodity following coffee and seed crops. It is one of the key components to increasing local food self-sufficiency which is a priority for both the Legislature and the Administration.

Chair Creagan and Members of the Committee:

The Department of the Attorney General provides the following comments on this bill.

The purpose of this bill is to include "livestock production" as a permitted use in the state agricultural district.

We believe that the inclusion of "livestock production" as a permitted use in the state agricultural district may be duplicative and unnecessary. The state agricultural district already permits under Hawaii Revised Statutes (HRS) section 205-4(d)(2), "Farming activities or uses related to animal husbandry and game and fish propagation," of which "farming activities or uses related to animal husbandry" would sufficiently encompass "livestock production." There are no definitions of "animal husbandry" or "livestock production" in the HRS; however, the Merriam-Webster Dictionary broadly defines "animal husbandry" as "a branch of agriculture concerned with the production and care of domestic animals," and defines "livestock" as "animals kept or raised for use or pleasure especially: farm animals kept for use and profit." There does not appear to be any particular difference or inconsistency between "farming activities or uses related to animal husbandry" and "livestock production."

We therefore recommend that the Committee determine if and how "livestock production" is inconsistent with or does not fit within HRS section 205-4(d)(2), and further refine or define "livestock production" such that it may be included under permitted agricultural uses without duplicating current permitted uses in the agricultural district.

HB 1890. This bill proposes to amend Section 205-2, Hawaii Revised Statutes, to include livestock production as an activity or use permitted within State agricultural land use districts.

LURF's Position. LURF members include property owners, farmers and ranchers who own, maintain, and engage in agricultural enterprises, and who consider efforts to protect and support agriculture significant to the continued conduct of their operations and to help sustain and preserve farming and ranching businesses into the future. Livestock ranching is a significant component of Hawaii's agricultural sector, being a highly productive, expanding, and extremely valuable industry on all islands with an estimated current annual value of more than \$68 million, with over 142,000 beef cattle on more than 1,300 ranches.

should be upheld, and livestock production should be included as a permitted activity and use within the State land use districts.
