### H.B. 1912, H.D. 1 – RELATING TO THE PACIFIC INTERNATIONAL SPACE CENTER FOR EXPLORATION SYSTEMS

The Hawaii Government Employees Association, AFSCME Local 152, AFL-CIO provides comments for the purpose and intent of H.B. 1912, H.D. 1 which establishes the Pacific International Space Center for Exploration Systems within the Department of Business, Economic Development, and Tourism for administrative purposes.

We are generally supportive, however this measure creates positions exempt from the civil service. We respectfully request that all positions, with the exception of the executive director, are established as civil service positions. The positions currently listed in this measure reflect similar positions within the civil service system and should have the same rights, benefits and protections as a civil service employee. Furthermore, civil service status creates consistency, fairness, stability and longevity that benefits both the employee(s) and the employer.

With respect to the transition of all rules, policies, procedures, guidelines and other material adopted or developed by the Research Corporation of the University of Hawaii to the Department of Business, Economic Development, and Tourism, shall be properly consulted in accordance with Chapter 89, HRS.
