### H.B. NO. 1925, RELATING TO THE DEPARTMENT OF HAWAIIAN HOME LANDS

Hearing: Wednesday, February 5, 2020, 9:00 a.m.

The Office of the Auditor takes **no position** on H.B. No. 1925 and offers the following comments.

The bill directs the Auditor to conduct a financial and performance audit of the Department of Hawaiian Home Lands (DHHL), including a review of:

- (1) Funding sources, including any county, state, federal, private, or other outside funding sources or partnerships, or both;
- (2) Use of funds obtained through the Native American Housing Assistance and Self Determination Act of 1996;
- (3) Offices, including any neighbor island offices;
- (4) Staff travel;
- (5) Personnel, staff positions, and salaries; and
- (6) Technological needs.

We note that DHHL's financial statements are audited annually. We procure the services of independent CPA firms to audit the financial statements of State departments and programs, including DHHL, as well as the State's Comprehensive Annual Financial Report (or CAFR). Akamine, Oyadomari & Kosaki CPA's, Inc. is currently DHHL's financial auditor. The financial audit reports are posted on our website at <a href="http://auditor.hawaii.gov/">http://auditor.hawaii.gov/</a>.

With respect to the performance audit directed by the bill, we have concerns about our ability to assess all the identified areas considering our staffing resources and the time in which we have to complete the audit.

Performance audits provide objective analysis, findings, and recommendations intended to assist management and those charged with governance and oversight to improve program performance and operations, reduce costs, facilitate decision making by parties with responsibility to oversee or initiate corrective action, and contribute to public accountability. Typically, a performance audit assesses a program's operations against appropriate criteria, such as relevant statutes, administrative rules, policies, procedures, and best practices.

We strongly suggest that the committee limit the scope of the audit and identify as specifically as possible the programs or activities that it wants assessed to ensure that we report on those issues that the Legislature is most interested in having us examine.
