HB 2015 RELATING TO INVASIVE SPECIES

Aloha Chair Yamane, Vice Chair Todd, and members of the Committee:

Thank you for the opportunity to testify on House Bill 2015. This bill establishes a pilot program within the Aina Mauna legacy program of the Department of Hawaiian Home Lands (DHHL) to remove and harvest gorse from Mauna Kea and develop it as a marketable product to expand economic opportunities for native Hawaiians. The Department supports the intent of this measure as long as it doesn't affect the priorities identified in the Governor's Supplemental Budget request.

Gorse is a highly invasive thorny shrub that creates impenetrable thickets which can be over 12 feet tall. DHHL Aina Mauna lands contain Hawaii's largest infestation of gorse, covering over 10,000 acres which prohibits homesteading and other land uses. The ecology and characteristics of this invasive species, which include abundant and early seed production, is easily spread and an over 30-year seedbank life, make containment, removal and long-term control of gorse very difficult and costly. The importance of eliminating this plant cannot be overstated. DHHL spends a great amount of time, effort and resources to control gorse annually and continues to look for the most feasible, efficient and effective long term solution to the gorse infestation on the Aina Mauna lands of Humuula and Piihonua. Any assistance in this effort is greatly appreciated.

Dear Chair Yamane, Vice-Chair Todd, and Committee members:

RE: HB 2015 Relating to Invasive Species

HB 2015 is a valuable bill, as the control of this invasive species is very important, not only to the environment on the upper slopes of Mauna kea, but also to prevent gorse's spread to the lower slopes during rain events.

I would suggest that the development of a pilot project include consultation with the Big Island and Hawai'i Invasive Species Councils, DLNR, HDOA, Natural Resource Conservation Service and University of Hawaii specialists, to provide input and guidance to avoid unintended consequences of further spreading the plant, plant parts, or seeds during removal and repurposing of the gorse. I would also suggest that the Hawai'i County Game Management Advisory Commission be invited to consult, since that Commission has long expressed concern about the spread of gorse and the fire hazard it represents.

HB 2015 would improve communication between insurers and independent private physicians who are currently unable to advocate for practice and policy changes as a group. Comments:

BIISC supports this measure. Several industrial uses for gorse have been tested on island and demonstrated to conservation partners and ranch managers. We believe there is strong potential to substantially reduce the core infestation of gorse on Mauna Kea to make these lands usable for agriculture again and to utilize the plant material as an agricultural input, among other uses. Demonstrations showed that possible products including feed pellets and biochar will not create a risk of spreading gorse to new areas. It is also apparent that other invasive species could be used as feed stocks in similar ways as the gorse population becomes depleted. Without a massive effort, gorse will continue to eat up available land and invade native forests, increasing the risk of severe wildfire while eroding our natural resources. As long as the plan is to convert lands from gorse to productive agriculture, and not maintain gorse plantations in perpetuity, we support this effort to capitalize on the readily available materials found in invasive plants.
