On behalf of the Alzheimer's Association, Aloha Chapter I am pleased to extend our **strong support** for House Bill 2099 HD1. This measure amends Act 127, Session Laws of Hawaii 2019, which appropriates funds for the Alzheimer's Disease and Related Dementia Services Coordinator position within the Executive Office on Aging. This important legislation corrects a small error in the Session Laws of Hawaii 2019 to enable the release of funding for this critically important position.

The position of Alzheimer's Disease and Related Dementia Coordinator was established within the Executive Office on Aging by Act 214, Session Laws of Hawaii 2013. That same year, the State of Hawaii recognized the public health crisis of Alzheimer's disease and developed Hawaii 2025: State Plan on Alzheimer's Disease and Related Dementias. Unfortunately, while the Alzheimer's Disease and Related Dementia Services Coordinator position remains unfilled, insufficient progress is being made towards adopting the recommendations and strategies.

Alzheimer's disease is a growing epidemic and is now the nation's sixth leading cause of death. Here in Hawaii, more than 29,000 individuals live with Alzheimer's disease or a related dementia. Additionally, there has been a 294% increase in Alzheimer's deaths in Hawaii since the year 2000.

I appreciate the opportunity to testify in **strong support** of this legislation and applaud your leadership in bringing it forward.

In Hawaii their are currently 29,000 islanders diagnosed with a dementia diagnosis. We believecthat number is half if the total and at least 65,000 of our resudence are suspending their careers to care for a loved one.

Dementia/Alzheimers individuals requires specialized care from qualified staff specifically skilled to understand and care provide for a Dementia/Alzheimer's unique needs.

I'm trying to understand the small error in Act 217 of Session Laws of Hawaii 2019 that's effecting the Alzheimer's coordinator position we discussed and saw approved in our last session. The Dementia/Alzheimer's community is hopeful this up won't delay the release of funding much longer, for the critically important position we've needed for many years. I trust you understand the importance of the Alzheimers Coordinator position and will find a way to vote in favor of the amendment to Session Laws of Hawaii 2019.

Advocates have been advocating with faith, hope and prayers for a full-time Alzheimers Coordinator position for many years. And I was named RYLA's (Rotary Youth Leadership Awards) Co-Chair. I'm still an active HPGS (Hawaii Pacific Gerontological Society) Board Member and Club 100 lifetime member.

My mother continues to struggle with dementia, but our family and her neighbors do what they can to help her out. I talk with her frequently. Some days are very hard for her. She refuses most of the helpful options available to her. And that makes caring for her difficult. She's like many who struggle with Dementia related issues. However, in her lucid moments, she'll look around, think and say, 'I'm doing better than most people at my age. Who knew I'd be doing so well & 85 in September? Not bad, huh?'

My family usually sigh and say, 'she's going to out-live us all, isn't she?' And I never share the fact, that 50% of the untrained family caregivers pass away before the person they're caring for does.' I joined The Dementia in The Family Workshops as their Caregiver Self-Care and Mindfulness Trainer. We do quarterly traings (free) on Oahu & will soon go outer island. Anything we can do to help folks dealing with Dementia/Alzheimers issues would appreciated.
