Chair Woodson and Members of the Committee:

The Hawaii State Teachers Association supports HB 2150, relating to education.

This bill would require the DOE to employ at least one full-time equivalent teacher for each grade level in grades kindergarten through six in each public school with a student enrollment of one hundred fifty or less students, excluding charter schools, beginning with the 2020-2021 school year. This bill also appropriates funds to do so.

Since the passage of Act 51 in 2004, Hawai'i has experimented with a weighted student formula (WSF) to equalize school funding, intended to make funding for public education more equitable, transparent, and decentralized. WSF had the unintended consequence of limiting academic programming for children in small and rural schools with limited student enrollment, thus limited funds received through the weighted student formula. A recent report commissioned by the Hawai'i Department of Education and completed by the American Institutes of Research reveals that "small or isolated schools do not have adequate funding under WSF and that the formula does not account adequately for diseconomies of scale associated with small schools or for additional costs due to geographic isolation."

Small and geographically remote schools sometimes lack sufficient funds to cover programming above and beyond basic operations. Isolated communities lack the economic breadth available to their urban counterparts, while experiencing distance from essential services and less access to technology. The AIR, therefore, suggested that "extra support" be provided to schools that are small or isolated, including a recalculation of WSF to "accurately account for the differential costs of providing an

equal opportunity for all students to achieve, regardless of their individual needs or circumstances (such as geographic location)."

Because student populations at remote and small schools vary dramatically from year to year, funding for positions at such schools also changes annually, creating turbulence in staff requirements and course offerings. Challenges faced by small and remote schools because of inadequate WSF funding include staffing shortages, cutbacks to courses, a lack of librarians, and more. At times, such schools do not have teachers to staff every grade level, if the school is an elementary school, or all core classes, if the school is a secondary school, presenting problems in the provision of minimum educational requirements to students. We cannot allow these schools to continue to struggle because of enrollment and geographical factors beyond their control.

To provide all of Hawai'i's children with access to a quality education, the Hawaii State Teachers Association asks your committee to **support** this bill.

As the Complex Area Superintendent of the Castle-Kahuku Complex Area, I support HB2150 as this will directly impact two of my smallest schools: Waiĕ hole and Ka'a'awa Elementary Schools.

A small school provides a more individualized educational experience for the students, further developed relationships between the students and parents with the school and faculty, and a positive learning environment promoting ownership and the power of individual voice. Unfortunately however, our small schools face the obstacle of limited financial resources due to our weighted student formula.

HB2150 defines a "small school" with a student enrollment of 150 students or less, and will ensure that one full-time teacher shall be in each grade level K-6. HB2150 also supports the recommendation by the Committee of Weights XI which stated the need to identify a "threshold" or number of students per school to determine an individual school's viability.

To fund the one teacher per grade level K-6, I would want to also ensure that these funds are provided by a new appropriation source, and not funded by the school's weighted student formula, complex area funds, or other sources of funds currently in the Department.

My father was a principal at King Intermediate School and farmer in Waikane Valley. So education and agriculture is in my D.N.A. Since I retired from the D.O.E. and left the U.S.D.A. for advocacy, I started attending town hall and committee meetings of the Waikane Community Association.

The two scenarios that I have heard so far is to:

- 1. Consider keeping the school open because of the cultural value of the integrated teaching and activities there.
- 2. Designing a site for a community center, school and comprehensive emergency shelter.

My thoughts, that I have not shared with the WWCA is a site for a school and D.O.E. Windward District offices. If the governor's plan is for most complexes to have middle schools, King Intermediate will need to accommodate sixth graders from eight feeder elementary schools. The W.D.O. will have to vacate the three story building which was built in the 1970s for the future S.W. King High School. So like Koko Head, Wilson and Benjamin Parker, one scenario is using Waiahole School for translocated district personnel and services.

There are others, but these three scenarios are worthy of saving the school and facility in light of the value of culture-based learning, increased storms due to climate change and long term D.O.E. design.

I, Kathryn Hurd, mother of a 1st grade student at Waiahole Elementarty School, strongly support HB2150. Small schools are important to our community. Small schools are in need of everyones support to continue to provide quality education to some of Hawaii's most at-risk keiki. Small schools are already creative in how they use their resources, and just a tiny bit more help, financially, will certainly go a long way. It is not uncommon for the principal to stay with the after-school kids until everyone has been picked-up, so other staff do not have to stay late and accumulate over-time hours or to serve lunch in the cafeteria, if staff are out sick. Infact, every staff memember goes above and beyond, wearing multiple hats to "make it work" at Waiahole Elementarty. In my opinion, what they are doing with their small school and limited resources IS working- but they need the support of the community and State to keep it up! The kids are happy and healthyeveryone knows everyone- literally- and their is rarely an incident of bullying on the small (>90 student) campus. Kids get individual attention and benefit from small class sizes by getting personalized attention from staff. Title of Bill: HB 2150 RELATING TO EDUCATION.

Purpose of Bill: Requires the DOE to employ at least one full-time equivalent teacher for

each grade level in grades kindergarten through six in each public school with a student enrollment of one hundred fifty or less students, excluding charter schools, beginning with the 2020-2021 school year.

Appropriates funds.

Department's Position:

The Department of Education (Department) supports the intent of this bill to the extent that it seeks additional funding for small schools.

As written, the bill removes the flexibility of principals to staff their schools based upon the unique characteristics of each school. This bill will impact nine schools, after applying the definition of small schools and removing specialty schools that have separate funding sources (e.g., Hawaii School for the Deaf and Blind and Olomana School).

The Department's Committee on Weights has consistently acknowledged the needs of small schools and currently provides base funding as part of the Weighted Student Formula (WSF) to support small schools. This allows the school to have the necessary staff to support their schools' needs without having to set aside additional WSF funds to cover these positions.

The Hawai'i State Department of Education is committed to delivering on our promises to students, providing an equitable, excellent, and innovative learning environment in every school to engage and elevate our communities. This is achieved through targeted work around three impact strategies: school design, student voice, and teacher collaboration. Detailed information is available at www.hawaiipublicschools.org.

Please accept our testimony in strong support of the subject measure. KEY Project has served the communities residing in Northern Ko'olaupoko and Ko'olauloa for the past 50 years, working in close collaboration with community organizations, resident and farm families in each of the many ahupua'a throughout this lengthy coastal area. Our work has often and continues to be by providing support for the small schools in our service area, directly or indirectly. Collectively, over these many years, we have relied upon the various venues - from the schools themselves and their unique character(s) and our own community center on Waihe'e Road (just below Kahalu'u Elementary School) - as excellent learning sites, entry points for youth and adults alike to identify with their own ahupua'a and to be able to host those who come to those venues or, through them, to the rich areas they represent. Each has its own unique handle on natural, cultural, environmental, recreational and educational attributes. "Small Schools", such as those that will benefit from passage of this bill are far more than just schools; they are gathering places and serve a far larger population than just those who happen to be attending in any given year. Like KEY Project, they are community centers, a "port in a storm" (with high potential for serving, to a much greater extent than currently acknowledged, as Emergency Shelters). My name is Shane Kumashiro, School Counselor and Student Services Coordinator (SSC) at Waiahole Elementary School. I am in support of HB2150, which would allow small schools with 150 students and below to have one teacher per grade level.

I am in support of HB2150 because this bill would allow small schools under 150 students to have one teacher per grade level. Over the past 6 years that I have been a School Counselor and SSC at Waiahole Elementary School, I have seen a range of combination classes over the years based off of student enrollment. Some years I have seen a combination class of 2nd and 3rd grade, another year 3rd and 4th grade, and this year, 5th and 6th grade. I have seen both veteran and new hire teachers as combination class teachers and each time, it has, in my opinion, been a disservice for both teacher and students. Teachers were expected to teach multiple grade level standards to two different grade levels just because our school didn't have enough funds for a separate teacher position due to lack of funds through the weighted student formula (WSF). Students struggle to master their grade level standards because the teacher has to split the teaching between two grade levels. Our students deserve to have their own dedicated teacher and our teachers deserve to have a dedicated class of students.
