Testimony of SUZANNE D. CASE Chairperson

Before the House Committee on WATER, LAND, & HAWAIIAN AFFAIRS

In consideration of HOUSE BILL 2176 RELATING TO SAND ISLAND

House Bill 2176 proposes to require and appropriate funds for the Department of Land and Natural Resources (Department) to conduct shoreline remediation at the Sand Island state recreation area. The Department strongly supports this measure provided that its passage does not replace or adversely impact priorities indicated in the Executive Supplemental Budget request and proposes amendments.

The Sand Island State Recreation Area (Sand Island SRA) is a 140-acre shoreline park in urban Honolulu. While it appears to be underused, partially due to the fiscal restraint associated with replacing the dysfunctional irrigation system and the cost of water to sustain landscaping and turf, there are several long term recreational activities that are conducted. In addition to simple day use, camping and shoreline fishing, there are several canoe clubs that practice here, a state of the art bicycle BMX course, the island's only remote-control car course, and both softball and baseball fields. Additionally, for several years, an area has been set aside via a Board of Land Natural Resources permit for the Honolulu Sea Water Air Conditioning project.

The Department notes that in addition to those uses, Sand Island SRA is subject to a fluctuating but pernicious homeless population, occurrences of socially unacceptable behavior and hosts one of the largest feral cat populations within a State Park unit.

There is an increasing amount of historic and manmade military and other metal debris emerging along the shoreline that is creating public safety implications, exacerbated by sea level rise and king tides.

This measure, in addition to responding and mitigating these shoreline debris issues, would also enable the department to engage in exploring innovative methods for both shoreline stabilization and resiliency to address sea level rise. Recognition of the implications of sea level rise must be factored into other park

A BILL FOR AN ACT

RELATING TO SAND ISLAND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds the Sand Island state		
2	recreation area [has] needs enhanced management and while it is		
3	utilized [been underutilized] by the public, additional		
4	investment in shoreline and fast land improvements would make		
5	the park unit more desirable to optimize public enjoyment.		
6	Additionally, concrete and metal debris have been found along		
7	the area's shoreline; the debris is a health and safety hazard		
8	to the visitors who frequent the area, and until the debris is		
9	addressed, it may pose[s] a threat of injury to visitors of the		
10	shoreline area. Addressing the debris and other issues in		
11	facing the shoreline at the Sand Island state recreation area		
12	will revitalize and keep the area clean, which will attract more		
13	residents and visitors to the area. Sea level rise associated		
14	with climate change will likely expose more of the historic		
15	debris over time. Additional funding and planning directed to		
16	Sand Island state recreation area will also allow for		
17	consideration of the application of new and emerging techniques

- 2 sea level rise.
- 3 The purpose of this Act is to require and appropriate funds
- 4 for the department of land and natural resources to conduct
- 5 shoreline remediation at the Sand Island state recreation area.
- 6 SECTION 2. The department of land and natural resources
- 7 shall conduct shoreline remediation and park improvements in at
- 8 the Sand Island state recreation area. In carrying out the
- 9 shoreline remediation and park improvements, the department
- 10 shall remove concrete, metal debris, and hazardous items any
- 11 garbage found along the shoreline and in the park of the Sand
- 12 Island state recreation area.
- 13 SECTION 3. There is appropriated out of the general
- 14 revenues of the State of Hawaii the sum of \$5,000,000 or so much
- 15 thereof as may be necessary for fiscal year 2020-2021 for the
- 16 department of land and natural resources to conduct shoreline
- 17 remediation at and park improvements in the Sand Island state
- 18 recreation area pursuant to section 2 of this Act.
- 19 The sum appropriated shall be expended by the department of
- 20 land and natural resources for the purposes of this Act.
- 21 SECTION 4. This Act shall take effect on July 1, 2020.
