Re: H.B. No. 2273 RELATING TO WAGES

I. OVERVIEW OF PROPOSED LEGISLATION

HB2273 proposes to amend sections 387-12 and 388-10(b), Hawaii Revised Statutes (HRS), by increasing the penalty for violation of wage laws to a class C felony.

DLIR <u>supports</u> this measure.

II. CURRENT LAW

Section 387-12, HRS, provides for a fine of \$50 to \$500, or imprisonment for up to one year or both fine and imprisonment, to any employer, employer's agent, or any officer or agent of a corporation who agrees to or pays an employee less wages than the employee is entitled to under the Wage and Hour Law.

Section 388-10(b), HRS, provides for a fine of \$100 to \$10,000, or imprisonment for up to one year or both fine and imprisonment, to any employer or any officer of a corporation who fails to pay an employee's wages in accordance with the Payment of Wages Law.


III. COMMENTS ON THE HOUSE BILL

The DLIR supports the intent of increasing penalties for violation of wage laws. The DLIR notes that the \$50 to \$500 fine in Section 387-12, HRS has remained

unchanged since 1965.

The DLIR notes that in the Administration measure HB2350HD1, the civil penalties for Section 387-12, HRS, violations are proposed to increase from \$50 to \$500 to \$500 to \$5,000, based on the Bureau of Labor Statistics' Consumer Price Index Inflation Calculator for the equivalent amount in May 2019. The DLIR is supportive of HB2273 and recognizes the deterrent effect that fines have in curtailing illegal behavior.
