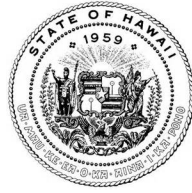
House Committee on Public Safety, Veterans and Military Affairs

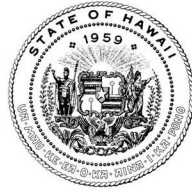
Chair Takayama, Vice Chair Gates, and committee members:

As the current state disaster recovery coordinator, I thank you for the opportunity to provide comments in Support for **House Bill 2331**.

House Bill 2331 proposes the establishment of a unified long-term recovery authority, inclusive of State and County government, community, and private sector representatives. Convened by the state disaster recovery coordinator, this leadership structure will help to facilitate recovery efforts statewide, beginning with support for recoveries currently under way and extending to mitigation of and building relationships and processes for future disaster scenarios.

In 2018, communities across the State were affected by major natural disasters, including Kaua'i and O'ahu flooding, the Kīlauea eruption and Hurricane Lane. Two out of three federally-declared disasters, primarily affecting Kaua'i and Hawai'i Counties, require long-term, complex planning and implementation involving many partners to recover.

Nearly two years after these incidents, federal recovery funds including FEMA Public Assistance and HUD Community Development Block Grant-Disaster Recovery are still pending – and will take a multi-year process to spend down once available.

Via **House Bill 2331**, the Governor's Office and the Hawaii Emergency Management Agency are prioritizing post-disaster coordination and pre-disaster planning to:

- Ensure holistic, inclusive and well-coordinated recoveries for past disasters; and
- Capture effective strategies and lessons learned for application via a repeatable, State-level framework for future disasters

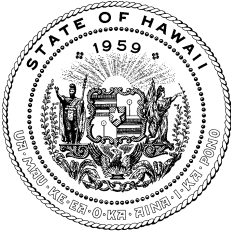
A State recovery framework, as a component of a Comprehensive Emergency Management Plan, is anticipated as an outcome of recovery planning and implementation in progress. The State framework will mirror frameworks currently in development at the County level with the goal of building complementary recovery leadership structures.

Centralized, clear, and well-organized coordination via the State is essential to support our local communities in off-setting the long-term, complex, and cross-jurisdictional nature of recovery.

Through the long-term recovery authority and the state disaster recovery coordinator, the State will be empowered to engage and maximize state agency and other relevant support, contribute strategic guidance, and provide financial oversight. These functions will help to ensure programmatic consistency and effective use of available funds, and to identify and address recovery unmet needs.

The Hawaii State Energy Office (HSEO) appreciates the intent of and offers comments on HB 2331, which enhances the capacity of the government, relevant agencies, and the community to recover from the impacts of disasters and seeks to build resilience and sustainability by establishing the Long-Term Recovery Authority to work with the State Disaster Recovery Coordinator.

State, public, and private organizations all share in providing for the public's health and safety, including when preparing for disaster response and recovery. 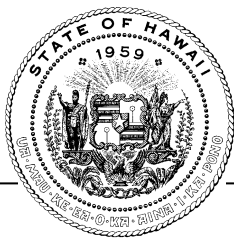
Aloha Chair Takayama, Vice-Chair Gates and Members of the Committee:

Chair Takayama, Vice Chair Gates, and Members of the House Committee on Public Safety, Veterans, & Military Affairs.

The Office of Planning (OP) **supports** the intent of this measure offers the following **comments** on HB 2331. In 2018, communities across the State of Hawai'i were affected by flooding, hurricane, and volcano disasters resulting in major damage to land, homes, infrastructure, and the economy. Three federally declared disasters, primarily affecting Kaua'i and Hawai'i counties, require long-term, complex planning and implementation to recover.

The Office of Planning supports the development of a long-term recovery authority to, among other responsibilities, recommend policy decisions and set strategic direction for resilient recovery planning. The Office of Planning finds that this long-term disaster recovery authority is complimentary to the long-range planning goals set in the purpose of the Hawai'i State Planning Act (HRS §226-1) and the long-range comprehensive planning and coordination responsibilities described in HRS §225M-1.

The Office of Planning notes that the Hawai'i State Legislature recently established the State's Sustainability Coordinator position within the Office of Planning, pursuant to the Supplemental Appropriation Act of 2016. The Office of Planning further finds that the 2018 State of Hawai'i's Hazard Mitigation Plan recommended:

"Develop a Sustainability Program at the state-level, headed by the Sustainability Coordinator. Currently, the Sustainability Coordinator position is funded, but has no operating budget. Task Coordinator with developing the program, establishing a clearing house for sustainability information and initiatives, coordinate with departments and agencies, and track implementation of projects and programs."

The Office of Planning's Sustainability Coordinator looks forward to assisting this proposed long-term disaster authority and working in collaboration with the State's Disaster Recovery Coordinator to recover from the impacts from disasters and build resilience and sustainability for the State of Hawai'i.
