<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) supports this bill as it will make it a standard practice for youth organizations to have in place established written policies and practices on addressing and preventing bullying in their programs. DHS defers to the Department of Health, Department of Education, and the University of Hawaii that worked on the Hawaii School Health Survey Workgroup that addressed the issue of bullying. DHS appreciates the amendments of House Committees of Lower & Higher Education and the Human Services & Homelessness.

**PURPOSE**: The purpose of the bill requires all entities that provide educational or recreational activities to youths to establish, maintain, and enforce written policies and procedures on bullying, harassment, and retaliation, and provide staff with appropriate annual training, regardless of whether the entity receives any government funding. Takes effect on 7/1/2050. (HD1)

The Department currently contracts with various organizations that provide for services mentioned in this bill and would be able to add a clause in future contracts stipulating that this shall be a requirement. It may be beneficial if minimum standards be adopted for consistency.

Title of Bill: HB 2483, HD1 RELATING TO BULLYING.

**Purpose of Bill:** Requires all entities that provide educational or recreational activities to

youths to establish, maintain, and enforce written policies and

procedures on bullying, harassment, and retaliation, and provide staff with appropriate annual training, regardless of whether the entity receives any government funding. Takes effect on 7/1/2050. (HD1)

### **Department's Position:**

The Department of Education (Department) supports the intent of HB 2483. The Department is committed to provide training to all school administrators, faculty, and staff on the amended Hawaii Administrative Rule, Chapter 19 Student Misconduct, Discipline, School Searches and Seizures, Reporting Offenses, Police Interviews and Arrests, Restitution for Vandalism, Complaint Procedure and Investigation of Discrimination, Harassment (Including Sexual Harassment), Bullying and/or Retaliation (HAR Chapter 19).

In September 2019, the Board of Education unanimously approved amending HAR Chapter 19 and HAR Chapter 89 Civil Rights Policy and Complaint Procedure for Student(s) Complaints Against Adult(s) (HAR Chapter 89). These rules became effective in January 2020.

HAR Chapter 19 expands the definitions for bullying, harassment, and cyberbullying. New protected class definitions and offenses can also be found in this amended rule. A complaint procedure for bullying, harassment (sexual harassment), discrimination and retaliation was also added. Additionally, a new Behavior Management System was implemented in January 2020 to capture student behavior incidents.

There were over thirty (30) HAR Chapter 19 and HAR Chapter 89 mandatory training sessions provided to school and district administrators from October 2019 through December 2019. Currently, HAR Chapter 19 and HAR Chapter 89 make-up training sessions are being provided to school and district level administrators and staff.

To ensure the empowerment of student voice, the Department implemented the "Speak Now" anti-bullying mobile application for intermediate and high school students. This mobile

application will be made available to elementary students in Fall 2020. The Speak Now mobile application provides students with another mechanism to report incidents of bullying on Department campuses, during transportation and during Department-sponsored activities.

As a note, the Department acknowledges that this measure attempts to make adjustments to Title 10 of HRS - Public Safety and Internal Security. As such, the Department defers to the appropriate state agency for implementation and looks forward to working with them to better safeguard Hawai'i's keiki.

HB 2483 HD 1 requires all entities that provide educational or recreational activities to youths to establish, maintain, and enforce written policies and procedures on bullying, harassment, and retaliation, and provide staff with appropriate annual training, regardless of whether the entity receives any government funding.

Bullying is the number one reason LGBTQIA+ youth miss school.

Every study shows that bullying puts youth at increased risk for depression, suicide, using drugs and alcohol, and risky sexual behavior all of which negatively impacts their academic performance. For LGBTQIA+ youth these risks are even higher.

Every organization that has youth as their clients needs to have everything that HB 2483 calls for especially the training and prevention.

For all these reasons the LGBT Caucus fully supports HB 2483 HD 1.

### Comments on HB 2483 HD1 Related to Bullying

Hawaii Youth Services Network (HYSN), a statewide coalition of youth-serving organizations, is providing comments on HB 2483 HD1 Relating to Bullying.

There is no doubt that bullying is a serious issue in our schools and other programs for children and youth and we welcome legislative action that will increase the capacity of schools and service providers to prevent and intervene.

We agree that all children and youth-serving organizations should have antibullying policies and procedures in place and should provide training to staff and volunteers on the topic.

This bill does not provide any mechanism for determining whether an organization has adopted a bullying policy or provide staff/volunteer training. No government agency is named to monitor compliance and there is no mention in the bill of penalties or actions if a youth-serving organization is not compliant. In short, there is no mechanism for enforcement specified in the bill.

HYSN recommends amendments to the bill to limit the requirement for an anti-bullying policy and training to organizations that have state contracts. Then the state agency issuing the contract could monitor for and enforce compliance.

### Comments:

Rainbow Family 808 Strongly supports HB2483 HD1 because Bullying and Harassment have been a problem for over 20 years with numerous attempts made to address this issue.

As a Social Worker for 20 years, my first experience in 1995 was supporting a family AFTER their high school student was harassed and bullied with the bullies chasing the student, attacking him which ended with the loss of sight in one eye. The sage of this student started with bullies harassing him for being gay. The school required the student:1) Spend a period in an empty classroom reading selected bibilical passages directed by a teacher (Violation of the student's Freedom of Religion, one is not to force their religion on another; 2) then the school transfered the student to another high school where a new set of students taunted, bullied and outran him which ended up with the attack and the lost of sight in one eye and hospitalization. This injustice happened on Oahu.

Then still in the 1990's, community groups rallied with the establishment of a procedure added to the Code of Conduct for the entire state which identified and set standards for the protection of the students from being bullied. The documented added to the Statewide establishment on the issue of bullying, harassment in the Code of Conduct only to watch as the guidelines were not implemented in the schools. This fits my old adage that guidelines, rules, decorum are only valuable when they are ENFORCED. That's why HB2483 HD1 needs to be amended to it's original state and intent.

I counciled a father whose children were harassed because he was gay, not the boys. After years of asking for relief, the family moved out of state as the teachers did not enforce the safety requirement to end the bullying. This case happened on the Big Island.

Now I call for Justice for students around this State that will be ENFORCED for their protection and safety. I have first hand experiences of students involving bulling, harassment and more on Kaui and Maui as well. Unless those responsible for the safety and protection of students ENFORE any measure docified, we waste our time and the students age out or Drop Out. This is not a responsible solution for our children. They are NOT to suffer during the most important time of their learning years.

If we continue to write one bill after another, one decade after another, we neglect to do our duty as a responsible society. Please pass the original bill as submitted. Those wanting to change the bill do the students harm. Thank you for hearing my plea for HB2483 HD1.
