#### HB 24 - RELATING TO ANIMAL SEXUAL ABUSE

Establishes the criminal offense of sexual assault of an animal. Provides for impoundment and forfeiture of a sexually assaulted animal.

Chair Creagan, Vice Chair DeCoite, and Members of the Committee:

My name is Dale Sandlin, and I am Managing Director of the Hawaii Cattlemen's Council. The Hawaii Cattlemen's Council, Inc. (HCC) is the Statewide umbrella organization comprised of the four county level Cattlemen's Associations. Our 150+ member ranchers represent over 60,000 head of beef cows; more than 75% of all the beef cows in the State. Ranchers are the stewards of approximately 25% of the State's total land mass.

The Hawaii Cattlemen's Council provides **opposes specific portions** of HB 24 in its current form, as it greatly expands existing sections of the Hawaii Revised Statutes.

An animal's health and well-being is considered the utmost priority of our industry. While we have no concerns with the initial intent of the bill, the amendments to sections "§711-1109.1 Authority to enter premises; notice of impoundment of animal; damage resulting from entry" and "§711-1109.2 Forfeiture of animal prior to filing of or final disposition of criminal charges" are particularly concerning.

In each of these sections, the bill removes the terms "pet" and "equine animal" from the existing definition and broadly applies the statutes to <u>ALL ANIMALS</u> including livestock regardless if the violation pertains to the offense outlined in the bill's original intent.

While we support the original intent of the bill, we believe that the application of "§711-1109.1" & "§711-1109.2" can be applied without amending the full sections of the existing statutes or prohibit the enforcement of any violation of the original intent outlined in the bill.

We respectfully ask for the portion of the bill regarding the proposed amendments to "§711-1109.1" & "§711-1109.2" be removed from the original language of this bill and replaced with "Any violation of this measure shall be subject to HRS "§711-1109.1" & "§711-1109.2" in regards to any animal type including those excluded in the aforementioned statutes."

We appreciate the opportunity to provide testimony in this matter.

#### H.B. 24 RELATING TO ANIMAL SEXUAL ABUSE

**Position: Support** 

Dear Chair Creagan and members of the House Committee on Agriculture,

On behalf of our members and supporters in Hawaii, the Humane Society of the United States appreciates the opportunity to submit this testimony in strong support of H.B. 24 to prohibit the sexual abuse of animals (also referred to as bestiality). Animal sexual abuse is a serious crime with links to human sexual violence and child pornography. Hawaii is one of only five states that does not prohibit sexual contact with animals, so we are grateful that the legislature is considering this bill.

Animal sexual abuse is not the isolated deviant behavior you might think it is, but it is a prevalent and violent offense. It frequently precedes child sexual abuse, sexual homicide, and other violent acts and it should be considered an omen of what is to come.

In a study of over 44,000 adult male sex offenders, bestiality was identified as the number one indicator and predictor of a person who will sexually abuse a child. FBI studies have found high rates of sexual assault of animals in the backgrounds of many serial sexual homicide perpetrators. This is why bestiality is now tracked by the FBI as a separate crime in the same category as rape and murder. Additionally, children and victims of domestic violence have reported being forced to sexually interact with animals by their abuser. We believe tracking bestiality as a separate crime from animal cruelty is important because it allows law enforcement to identify potential sexual predators and, hopefully, intervene before they harm a human.

The internet facilitates this crime and, with no legal prohibition, allows it to flourish. Perpetrators use various websites to seek out one another where they often trade, rent, and sell animals for sex. A popular bestiality website has hundreds of users from all areas of Hawaii. In the last two weeks alone, there have been dozens of posts from owners offering their dogs for sex with strangers or people seeking animals for sex, many of them visitors to the islands.

Animal sexual abuse is not covered under existing animal cruelty laws for several reasons. The act does not always result in physical injury to the animal. When large breed dogs or livestock are sexually abused it can be extremely difficult for prosecutors to prove that pain or suffering was caused. Many cases are not brought about from physical injury to the animal but from an eyewitness complaint or videos found well after the act occurs and the evidence needed to establish injury is not available to prosecutors. Advertising or offering an animal for sex or coercing others to do so is also not covered under the animal cruelty laws. H.B. 24 would prohibit those acts as well.

There are clear exemptions for animal husbandry practices such as artificial insemination, veterinary procedures, and conformation judging. Of the 45 other states where this is law, no case has ever been prosecuted against farmers or ranchers engaging in acts related to artificial insemination or animal care. The intent of this bill is to give law enforcement and prosecutors the ability to arrest and charge true sexual predators rather than turn them away and send them back into our communities as they do now.

House Bill 24 recognizes that animal sexual abuse is one of the earliest signs of a conduct disorder and the need for mental health intervention. By identifying animal sexual abuse as a dangerous, predatory behavior courts can order necessary psychological counseling to break the cycle of abuse and prohibit offenders from contact with animals, and law enforcement can identify and monitor dangers in their community to keep their animals and children safer.

Aloha Chair Creagan, Vice Chair DeCoite and Committee Members,

On behalf of the Hawaiian Humane Society, thank you for considering our support for House Bill 24, which establishes the criminal offence of sexual assault of an animal. It further provides for impoundment and forfeiture of a sexually assaulted animal.

This is a crime against a powerless population and people who abuse animals in this way are extremely likely to target vulnerable human beings as well.

Recognizing that animal sexual abuse is often linked with child pornography, 45 states now outlaw bestiality. Studies have shown that bestiality is the single greatest predictor of people who will molest children. In 2016 the FBI began tracking animal cruelty crimes, including bestiality, in recognition of the link between animal abuse and crimes against people.

Please pass HB 24 to protect Hawaii's animals and its people. Mahalo for your consideration and please let me know if I can be of assistance.

It is astonishing that a bill such as this should be required. But as the "Me Too" movement has made clear, sexual abuse is quite common among humans. In addition to protecting animals, this bill will provide a first step in reducing human sexual abuse as well. Dear Officers of the House Agriculture Committee of the State of Hawai'i – aloha!

I write, in reference to the debates in the Legislature this coming Friday, on behalf of *The Animal Interfaith Alliance*, an international alliance of faith groups founded in Britain concerned about the welfare of animals. Our member organisations and individual members include Buddhists, Christians, Hindus, Jains, Jews, Muslims and Sikhs. We are all united by our common concern for animals, based on our various faiths. Our member organisations are listed below.

May we please submit the following:

#### "Testimony in support of HB681"

We would like to support HB681. Allowing companion dogs in restaurants, at the restaurant owners' discretion, will create a more compassionate society in that it will normalise the affectionate links we have with our animal companions.

#### "Testimony in support of HB200"

We would like to support HB200 which would prohibit the use of certain restraints and tethers that endanger, or deny sustenance, to a dog. To be restrained in often inadequate conditions and sometimes for all their lives, is cruel and disrespectful.

#### "Testimony in support of HB930"

We would like to support HB930 which would prohibit pet store operators from selling a dog, cat or rabbit unless the animals were obtained from certain humane sources such as a shelter or rescue and, importantly to keep records showing the sources of the animals for sale. There can be much neglect and even cruelty in this trade and it fosters breeding when the rescues are full of animals needing good homes.

#### "Testimony in support of HB24"

We would like to support HB24 which establishes the criminal offence of sexual assault of an animal. We understand that the state's existing animal cruelty laws could be used to prosecute cases where there is evidence of physical harm to the animal, but these are not sufficient, and, in any case, to allow sexual assault goes against all norms of civilised society, which we believe Hawai'i to be.

#### "Testimony in support of HB716"

We would like to support HB716 which would prohibit the importation of wild animals for exhibition in a circus, carnival, or other live animal act or performance. We were delighted to be informed that this bill would codify last year's hard-won rule change at the state Department of Agriculture on the same subject.

### "Testimony in opposition to HB127"

We would like to oppose HB127 which would create a littering penalty that would apply to anyone caring for an animal who leaves faecal waste on public or private property.

Of course, we support the requiring of guardians to clean up after their animals, but this measure could be used to punish the volunteers who care for Free-Roaming cats. This would be wholly unacceptable, as it would make it impossible to care for these needy cats, which is a duty on all societies.
