<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) supports this bill to increase to the Personal Needs Allowance (PNA) and offers comments. DHS appreciates the amendments of the House Committee on Human Services & Homelessness.

<u>PURPOSE</u>: This bill amends the monthly needs allowance for individuals residing in foster homes, care homes, domiciliary homes, and other long-term care facilities. Amends the state supplemental payment ceiling for domiciliary care paid to recipients who are eligible for federal supplementary security income or public assistance, or both. Takes effect on 12/31/2059. (HD1)

The State's Optional Supplemental Payment (SSP) appropriation is used for domiciliary care payments, as specified in section 346-53(c), Hawaii Revised Statutes (HRS), for PNA for individuals residing in settings specified in section 346D-4.5(a), HRS, and for SSP administrative fees paid to the Social Security Administration (SSA) to add the SSP amounts to individual's monthly Supplemental Security Income (SSI) check.

An increase in the amount of PNA would benefit recipients as it would allow recipients to pay for more personal items such as clothing, hairstyling services, beauty and grooming products, reading material, small gifts, family outings, and other incidentals. If the proposed

change went from a monthly PNA increase from \$50 to \$85 for approximately 2,293 individuals in domiciliary homes, the annual SSP expenditures would increase by \$963,060.00. If monthly PNA increased from \$50 to \$85 for a total of 183 individuals in nursing facilities, annual expenditures would increase by \$76,860.00. These increases would be within the current SSP budget amount of \$17,810,955.

An increase would support the State's Maintenance of Effort (MOE) agreement with the Social Security Administration (SSA) that requires an annual minimum expenditure of \$16,785,143.91 in SSP payments, as specified in Title 20, Code of Federal Regulation, section 416.2096(a). In 2019, to further expend the balance of the budgeted amount to remain compliant with the MOE, the Adult Protective & Community Services Branch (APCSB) made a one-time retroactive SSP payment to eligible residents in care settings specified in 346-53(d), HRS.

The Medicaid program did further analysis of this proposed change and concluded that no additional appropriation would be needed for Medicaid. At this time, Med-QUEST does not anticipate that additional individuals would become eligible for Medicaid. There are beneficiaries living in domiciliary homes and Community Care Foster Family homes that are currently eligible for Medicaid through the "medically needy" eligibility category. They contribute some of their income to cover the cost of their care when they have income above Medicaid income eligibility standards. The PNA increase would reduce this contribution marginally for some individuals, which would mean that Med-QUEST would expend some additional dollars on their medical care. However, the loss of the beneficiaries' contribution would be negligible and there would be no need for an additional appropriation.

SUBJECT: HB 2615 HD1 – Relating to Social Services

The State Council on Developmental Disabilities **STRONGLY SUPPORTS HB 2615 HD1**. The purpose of the bill is to increase the monthly needs allowance for individuals residing in foster homes, care homes, domiciliary homes, and other long-term care facilities.

The needs allowance is intended for residents to spend at their discretion on clothing, shoes, toiletries, bedding, towels, wash cloths, furniture, transportation (other than medical visits), personal postage costs, snacks, a meal out with friends, movies, recreational activities, hobbies, reading materials, and other incidental expenses of day-to-day living (cable, internet, cards/presents to send to family/friends, sun screen, lotion, etc.). Federal regulations prohibit long-term care facilities from charging residents' needs allowance for services that are included in Medicaid payments such as toothpaste, toothbrush, tissues, shampoo, and incontinence products.

Act 96, Session Laws of Hawaii 2007 increased the personal needs allowance from \$30.00 to \$50.00 a month. That increase amounted from \$1.00 per day to \$1.66 per day. The passage of HB 2615 would increase the needs allowance from \$50.00 per month to, we hope at least \$75.00 per month, or from \$1.66 per day to \$2.50 per day.

Thank you for the opportunity to present testimony in strong support of HB 2615 HD1.
