**Purpose of Bill:** Establishes the agricultural technology transfer and workforce

development program and provides for a coordinator position to provide support for secondary education agriculture and Future Farmers of

American programs. Appropriates funds.

### **Department's Position:**

The Department of Education (Department) supports HB 2682 to establish and fund an agricultural coordinator position in the Department of Agriculture to coordinate an agricultural technology transfer and workforce development program in partnership with the Department provided it does not adversely impact the Department of Agriculture's budgetary priorities.

Currently, the Department's Natural Resources pathway promotes student choice, interest and aptitude in conservation and environment, food and non-food production, as well as natural resource management. Student leadership is cultivated through a renewed interest and investment in FFA Hawaii that serves as a conduit to promote agriculture and entrepreneurship as a career. Schools at all levels continue to expand their gardens as learning laboratories embedded within their unique school design to integrate agricultural experiences across the content areas.

### Re: H.B. No. 2682 RELATING TO WORKFORCE DEVELOPMENT

### I. OVERVIEW OF PROPOSED LEGISLATION

HB2682 proposes to amend Chapter 141, Hawaii Revised Statutes (HRS), by establishing within the Department of Agriculture an agricultural technology transfer and workforce development program. DLIR <u>supports</u> this measure, provided it does not conflict with the priorities identified in the Governor's Supplemental Budget requests.

My name is Michael Robinson, Vice President, Government Relations & Community Affairs at Hawai'i Pacific Health. Hawai'i Pacific Health is a not-for-profit health care system comprised of its four medical centers – Kapi'olani, Pali Momi, Straub and Wilcox and over 70 locations statewide with a mission of creating a healthier Hawai'i.

<u>I write in support of HB 2682</u>. which establishes the agriculture technology transfer and workforce development program and provides for a coordinator position to support the secondary education agriculture and Future Farmers of America programs. HPH acknowledges that the link between access to food and health is important. The development of healthy food systems requires development of agriculture and the fostering of future farmers who will be successful in sustaining our vital food source.

With the declining agricultural workforce, its ripple effects on our fragile food systems requires multiple solutions. In 2013, an agriculture skills panel reported that increasing youth education and training as the most common theme arising from county discussion groups on agricultural issues. Related goals included developing agricultural career interests; increasing agriculture programs in public secondary education, including internships and mentorships; and developing clear pathways to post-secondary education in agriculture.

To produce a new generation of innovative agriculturalists and natural resources stewards who are informed by the best cultural practices and by the tools and methods of research, the State needs to intensify training for secondary education agriculture teachers and students. The State also needs to support them with skill sets appropriate to foster agricultural growth in present and future Hawaii. The next generation of farmers need a deep toolkit to measure and manage plant and livestock production, nutrients, fair and inclement weather, fuel and energy consumption, and finances. The groundswell of

interest in agriculture, sourced in elementary schools and nurtured by the sustainability movement, has created a generation of informed students who must have quality secondary agricultural education destinations to foster their agricultural interests and support potential careers in agriculture. Secondary agriculture education is part of the department of education's natural resources career pathway.

Aloha Chair Johanson, Vice Chair Eli, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

**The Hawaii Farm Bureau supports HB 2682,** which establishes the agricultural technology transfer and workforce development program and provides for a coordinator position to provide support for secondary education agriculture and Future Farmers of American programs.

Hawaii's farmers and ranchers are aging. The average age exceeds 60 years old and if they were in other professions would be retired. Yet many of these farmers are those that provide to KTA, Safeway, Times, Costco, restaurants, and hotels and truly make a difference in reducing imports. Unfortunately for many, succession plans do not exist and as they retire, the lands go out of agricultural production. To maintain and expand production levels, it's clear that we need a new generation of farmers and ranchers equipped to assume the task of growing crops and livestock. There is an urgent need for interns or apprentices that are willing to not only work on these farms but take over their operations.

In 2013, the Hawaii State Legislature saw fit to establish the Agriculture Workforce Advisory Board. This Board convenes, in part, to execute the recommendations of the Hawaii Agriculture Skill Panel Report. The board established a program by which educators and school administrators can be exposed and incentivized to adopt existing broad-based agricultural curriculums. This was an important step toward the future of agriculture by helping to address Hawaii's agriculture labor shortage. This measure proposes to build on the Agriculture Workforce Advisory Board's program.

Hawaii's FFA program is vitally important to the future of agriculture in Hawaii. The passion and direct interaction of volunteer farmers and ranchers with young people will help grow and perpetuate the ranks of the next generation of farmers and ranchers. The FFA program has a proven track record of not only exposing and educating young people to positive, hands-on experience in agricultural production but is also a program that instills leadership and life skills in a wide variety of projects.

It is clear that we must strongly support agricultural education for our young people if we are to increase Hawaii's long-term resilience and sustainability.

Thank you for this opportunity to testify on this important subject.

Chair Johanson and Members of the Committee:

The Hawaii State Teachers Association <u>strongly supports HB 2682</u>, establishes the agricultural technology transfer and workforce development program and provides for a coordinator position to provide support for secondary education agriculture and Future Farmers of America programs. Appropriates funds.

Secondary agricultural education is part of the Department of Education's natural resources pathway. This bill will also provide information to public schools, including charter schools, on agricultural education needs, opportunities, including innovative technology awareness. It will also foster entrepreneurship through Future Farmers of America work-study programs, assist public schools, including charter schools with increasing student participation and teacher collaboration, while also providing secondary agriculture teachers with and food system workshops, provide mentoring and project funding for on-campus work-study internship training, provide workshop and conference for students and teachers to engage in agricultural leadership activities, identify partners to co-fund Future Farmers of America projects grant applications for additional funding.

According the Hawaii State Department of Education, "Career and Technical Education is an educational structure that allows students the opportunity to explore and learn through the practical application of academic and technical skills and knowledge. The support and involvement of business and industry in CTE is critical to the preparation of tomorrow's skilled workforce."

There is concern among CTE stakeholders (teachers, industry experts, and employers) about the lack cutbacks to CTE programming. As a result of a federal and state emphasis on high stakes accountability over the past decade, secondary schools

across have diverted CTE funding to core content areas, especially English Language Arts and mathematics, and cutting CTE programs.

A majority of all current job openings, both locally and nationally, are for positions that do not require a college degree. While education reform rhetoric extols "college and career readiness," job projections by the Hawai'i Department of Labor show that, overall, more than 70 percent of the state's projected openings through 2022 require a high school diploma or less. For comparison, about 15 percent of future openings require a bachelor's degree and only 4 percent require a master's, doctoral, or professional degree.

Workforce development offerings must be expanded to allow young people to design their own futures. According to a national study, only 25 percent of polled job seekers reported receiving career pathing in high school, with 41 percent saying that they wished they had received more vocational guidance. Careers taught through the department's vocational programming—from financial management to civil engineering to teaching—are at the core of our local economy, requiring real-world skills that benefit both students and employers alike.

Vocational training, now called CTE, should be a viable alternative to college, which is increasingly cost prohibitive for high school graduates and their families (though, notably, students who obtain CTE certifications attend college a higher rate than students who do not). This bill will allow Hawai'i high school graduates who do not seek post-secondary education at four year institutions to have more opportunities to receive industry-based skills and certifications required to join the 21st Century job market.

The establishment of a Workforce Readiness Program will help ensure that when a student graduates from high school they are prepared to be a productive member of society and able to be gainfully employed. This will have a pronounced beneficial impact on society for generations to come.

Aloha Members of the Labor & Public Employment Committee,

Thank you for the opportunity to testify in **strong support of HB2682** relating to workforce development.

My name is Chynna Chun and I am the current Hawaii FFA State Treasurer and O'ahu County VP. I am also a freshman at UH Manoa with the College of Tropical Agriculture and Human Resources (CTAHR). As a representative of Hawaii FFA, I ask that you support and advance HB2682 with the end goal of providing teacher training in FFA and in emerging ag technologies, student leadership activities, and FFA ag work study funding to hire more students to work on ag related projects after school while also improving ag facilities.

Interest in agriculture education and workforce is growing at the high school and college levels and we are constantly in need of legislative support to implement more programs and opportunties to further our agriculture passions. Currently, we are in the Hawaii FFA Renaissance period. After hitting an all-time low in 2012 with only 10 active FFA programs with a total FFA membership of 126, we are resurging in numbers with 22 active FFA programs and 400+ members. Likewise, we also placed first, second, and third in the nation at the 92nd National FFA Conference in Indianapolis for Agriscience, Extemporaneous Public Speaking, and Prepared Public Speaking.

These achievements would not have been possible if it wasn't for FFA. In fact, FFA develops premier leadership which prompted me to run for state office this past year. From here, I was given the opportunity to speak at the 2019 Ag Conference as a panelist, facilitate county council workshops, be a keynote speaker at the O'ahu Districts competition, and connect with students who also share the same passion in agriculture as me. Being a spokesperson for Hawaii FFA has shaped me to become more aware of the current state of agriculture here in Hawaii. Food insecurity, the lack of farmers, ag lands being bought out for the sake of tourism? I cannot say I would be able to advocate for any of these without being in FFA.

Hawaii FFA is special in that it truly leads the way for future farmers, future leaders, and future advocates in ag. We are the melting pot of diversity in ideas, concepts, and people. We look at the world with both cultural and scientific lenses and help in inspiring

the future generation to testify and advocate for bills and issues they seem worthy. ### Greetings,

I write in support of HB 2687 as a second generation ag teacher and now as an FFA volunteer in my retirement.

I also offer my voice on behalf of agriculture teachers and FFA advisors and FFA members I have known for over sixty years.

- Ag teachers have a history of going all out to support our students. In 1993, our agriculture education strategic plan included these belief statements:
- All students are our customers.
- Ag ed programs teach basic academic skills, technical skills and interpersonal skills such as honesty and integrity through the FFA.
- Ag ed programs provide integrated learning, contextual hands-on learning, practical results and nurturing and fulfilling experiences.
- Ag teachers are dedicated, cohesive, highly skilled, team players, risk takers, leaders, inspirers and able to serve all students.

Our vision elements said:

- We see programs that interact with businesses, universities, and the community to maximize partnerships, resources, and student learning.
- We see a diversified ag program as including Ag Mechanics, Aquaculture, Horticulture, Native Hawaiian Agriculture, Agriscience, Crop Production, Agribusiness, FFA and Animal Science.

This was 27 years ago, before STEM was popularized. It was 27 years ago too, that we looked to the wisdom of Hawaiian cultural practices, and it was 27 years and more ago, that we served students of very diverse backgrounds. In fact, our teachers were doing much of this for over 91 years, since the time the Hawaii FFA was chartered in 1929. It was also 35 years ago, when one program used Apple IIe and Commodore 64 computers to control farm irrigation systems and to measure soil moisture. We were experimenting with precision agriculture in 1985 and we had "modern" instructional practices already embedded in our curriculum.

Please also consider the testimonies of our youth, and note that this current generation of FFA students has not only validated our tradition of innovative ag education and leadership training, but has developed a highly informed voice that inspires agriculture teachers and supporters to keep our programs alive and growing. Please help us to nurture future generations of highly-skilled workers and leaders.

1. Explain or describe the program, purpose of request, and number of students/faculty involved.

The FFA (Future Farmers of America) is the biggest CTSO (Career Technical Student Organization) in the world having about 700,000 members in the nation and we have about 15 members in our Waipahu Chapter. # HOUSE BILL NO. 2682 RELATING TO WORKFORCE DEVELOPMENT

Chairperson Johanson and Members of the Committee:

Thank you for the opportunity to testify on House Bill 2682. This measure establishes the agricultural technology transfer and workforce development program; creates a coordinator position within the Department of Agriculture to provide support for secondary agriculture education and Future Farmers of American programs; and appropriates funds. The Department of Agriculture supports the intent of this measure and offers the following comments.

The Department has been a longstanding supporter of Future Farmers of America and its programs and agrees that additional support for secondary agriculture education is needed. However, a workforce development program already exists within the Department of Labor and Industrial Relations that provides similar coordination between educational/vocational training with employment opportunities that may be better suited to the important goals of this measure. Due to their experience with educational outreach and job placement, the Department believes an initiative such as this would be better served by those existing programs rather than creating a new program within the Department. The Department is also concerned that it currently lacks sufficient office space and operating resources to carry out this function effectively so if this Committee is inclined to move this measure forward, we respectfully recommend the inclusion of additional resources to ensure that it is implemented successfully.

Good day Committee Members. My name is David Fuertes from North Kohala. I attended Waimea High School on Kauai and was in the FFA program for 4 years from 1962-66. At that time, it was only for boys and most of us were labeled, "under achievers "where college was beyond expectation. My teachers Mr. Kunimitsu and Mr. Kajihara were the only teachers that acknowledged my talents which was being able to outwork any student, growing vegetables and raising animals that supplemented our family's (10 of us) food source. I also enjoyed some profits from my FFA Entrepreneurial projects. I quit any extracurricular activities including sports after my freshmen year so I could concentrate on helping to feed our family while also supplementing our family income from selling my crop produce and animals. My biggest accomplishment was when I received the State Farmer Pin at the State Convention as a senior in Oahu.

Encouraged by my Ag teachers to attend college, I majored in Agriculture and between the Viet Nam war I was able to receive my BS degree at UH Manoa. I elected to continue for my professional diploma so I could teach Agriculture, have my own FFA Chapter and become like my Mentors, the Ag teachers who influenced students to "Achieve to their highest with Aloha and respect for others." During my career as Ag teacher at Kohala High School, our small Kohala FFA Chapter produced 5 State Presidents, 6 state Officers and countless State contests winners. As a result, most of the leaders in our community are former FFA members that are entrepreneurs in Agri Business, Agri Tourism, and Administrators in the Hotel industry and public sectors. My former student Sylvia Hussy just became the CEO for Office of Hawaiian Affair.

The FFA program in most high schools have diminished through DOE initiatives in the past years. Only until 5 years ago when your legislature created funding thru DLIR and DOA through the "Ag Advisory Workforce Committee" we have made epic strides in rebuilding the FFA programs in our DOE system. FFA are now established in younger grade levels, middle schools, increase of Chapters, increase of members, increase of participation on National levels, and now winners on the National levels. Hawaii have not seen a National winner in almost 50 years when former Libby Viduya from Lanai High School ranked in Public Speaking contest. Mr. Viduya became a State DOE complex Superintendent. Compared to when I was in FFA, our students were from the SPED students and now, with attracting higher caliber academic students focus in on planning their destiny while appreciating and caring for our Aina making a positive difference on our planet.

As a retired Ag teacher and now Executive Director for a non-profit, "Kahua Pa'a Mua", we work with DOE Ag. Teachers and sponsored workshops in; Leadership, Record Keeping, Planning, and Korean Natural Farming. We see the surge of high interest in many teachers wanting to provide FFA opportunities for their students. While the demand is high and the DOE, CTE resources are limited, additional help is needed to assist the FFA program survive once again. It's worries me to revert back almost 20 years when the FFA was almost completely lost. Twenty years ago CTE (Career Technical Education) had (1) specialist for each area: Agriculture, Home Economic, Industrial Arts, Business, Home Economics, but today, CTE has only one specialist for all five areas.

Please support HB2682. in hopes that we can provide effective Education to our future Leaders so some day they will be engage in Food Resilience endeavors.
