The Hawaii Paroling Authority (HPA) supports House Bill 320, HD2, which seeks to require the Department of Public Safety provide a certificate of completion to each inmate upon completion of rehabilitative programs. Aloha Chair Nishihara, Vice Chair Wakai and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the families of **ASHLEY GREY**, **DAISY KASITATI, JOEY O`MALLEY, JESSICA FORTSON AND ALL THE PEOPLE WHO HAVE DIED UNDER THE "CARE AND CUSTODY" OF THE STATE** as well as the approximately 5,500 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that more than 1,600 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

HB 320 HD2 requires the department of public safety to issue certificates to incarcerated persons upon completion of rehabilitation programs.

Community Alliance on Prisons supports this measure that helps incarcerated people track their own success. In some cases, receiving a certificate of completion might be the first time the individual has ever been awarded anything.

The very best part of this acknowledgement is the hope and pride it instills in someone showing that they *can* complete something!

We urge the committee to pass this simple, but important bill!

Chair Nishihara, Vice Chair Wakai, and Members of the Committee:

The Department of Public Safety (PSD) supports House Bill (HB) 320, House Draft (HD) 2, which requires PSD to issue certificates of completion to offenders who have completed a prison rehabilitative program with an established curriculum, such as, substance abuse, mental health, sex offender, vocational, religious, nutritional, or other program conducted by PSD or a service provider contracted by PSD, upon completion of the program.

The Department already maintains careful records of inmate program completion, as these are key to tracking the inmate's progress in working towards furlough and other reentry programs. The issuance of certificates would formalize the process of recognizing an inmate's achievement and forward progress. PSD also notes that certificates of completion are commonly issues at other correctional institutions.

Dear Honorable Legislative Members,

I am in support of this bill. As a retired Substance Abuse Specialist - 5 of the Department of Public Safety, I used to manage the Bridge Program at LWFC when I used to work for the Department. When I was the program manager of the program, we (my staff and I) used to always present the offenders who completed the program with both certificates and discharge summaries stating completion of the program, and clinically discharged. If this no longer is the practice, I do not know why that would be occuring. I think more investigation by the legislature should be conducted to check into the re-entry program of the the offenders who are leaving the department of public safety - at least at the convicted felons status.
