Chair Takayama, Vice Chair Gates, and Members of the Committee:

The Department of Public Safety (PSD) supports House Bill (HB) 320, which will require PSD to issue certificates of completion to offenders who have completed a prison rehabilitative program with an established curriculum, such as, substance abuse, mental health, sex offender, vocational, religious, nutritional, or other program conducted by PSD or a service provider contracted by PSD.

The Department presently maintains careful records of inmate achievement, as these are key to determining the inmate's progress in working towards furlough and other reentry programs. The issuance of certificates would formalize the current process and serve as recognition of an inmate's achievement and forward progress. PSD notes that certificates of completion are commonly issued at other correctional institutions and has no objection to establishing the practice.

Chair Takayama, Vice Chair Asuega, and Members of the Committee:

The Hawaii Paroling Authority (HPA) opposes House Bill 320, which seeks in part to have the Department of Public Safety provide verification of completed rehabilitative programs by the former inmate to the potential employer. Included in the list of "rehabilitative programs" are substance abuse, mental health, sex offender programs, and others. HPA's concerns are with the release of potentially protected health care and/or treatment information as it relates to substance abuse, mental health, sex offender treatment programs, and any other rehabilitative program where the program provided treatment that is considered protected under State and/or Federal law.

As written, House Bill 320 does not address how the information will be used by the potential employer, what the potential employer will do with the information, and does not prevent potential employer from disseminating and/or sharing the information with others as no disposition regarding the release of the information is provided. Further, no penalties are listed for the unauthorized release of the information by potential employers.

Aloha Chair Takayama, Vice Chair Gates and Members of the Committee!

My name is Kat Brady and I am the Coordinator of Community Alliance on Prisons, a community initiative promoting smart justice policies in Hawai`i for more than two decades. This testimony is respectfully offered on behalf of the families of ASHLEY GREY, DAISY KASITATI, JOEY O'MALLEY, JESSICA FORTSON AND ALL THE PEOPLE WHO HAVE DIED UNDER THE "CARE AND CUSTODY" OF THE STATE as well as the approximately 5,500 Hawai`i individuals living behind bars or under the "care and custody" of the Department of Public Safety on any given day. We are always mindful that more than 1,600 of Hawai`i's imprisoned people are serving their sentences abroad thousands of miles away from their loved ones, their homes and, for the disproportionate number of incarcerated Kanaka Maoli, far, far from their ancestral lands.

HB 320 requires the department of public safety to issue certificates to incarcerated persons who complete rehabilitation programs.

Community Alliance on Prisons supports this measure and suggests the following amendment:

On Page 1 - lines 6 and 7:

6 shall provide a certificate to the inmate no later than the 7 earlier of the inmate's parole or release date.

REPLACE WITH:

6 shall provide a certificate to the incarcerated person
7 at the completion of the rehabilitation program.

Program completion is an achievement and these certificates mean a lot to people who have completed programs – in many cases, it has been the first recognition a person has received!

Community Alliance on Prisons urges the committee to pass this bill,
