TESTIMONY ON HOUSE BILL 410 RELATING TO RESTITUTION FOR VICTIMS OF CRIME.

Chair Lee, Vice Chair San Buenaventura, and Members of the Committee:

The Department of Public Safety (PSD) supports House Bill (HB) 410, which will clarify the intent of Section 706-646, Hawaii Revised Statues (HRS), to reimburse crime victims fully for all reasonable and verified losses resulting from the defendant's offense.

HB 410 expands the definition of medical expenses to include mental health treatment, counseling and therapy. The measure also allows compensation for all Funeral and Burial expenses, deleting "as a result of crime," and adds, "Lost earnings, which include paid leave."

These changes will accrue to the benefit of crime victims.

TESTIMONY ON HB 410 - RELATING TO RESTITUTION FOR VICTIMS OF CRIME

Chair Lee, Vice Chair San Buenaventura, and Members of the Committee:

The Department of the Prosecuting Attorney, County of Maui, SUPPORTS HB 410 - Relating to Restitution For Victims of Crime. HB 410 would make it clear that a sentencing court has the authority to award restitution involving: 1) lost earnings; and 2) medical expenses pertaining to mental health treatment, counseling, and therapy. Indeed, these types of losses are in fact real, and but for the criminal act(s) of the defendant, the victim would not have suffered these types of losses. Hence, these expenses should be compensable as restitution.

Furthermore, there are safeguards written into the statute HRS § 706-646, which prevents a sentencing court from simply "rubber stamping" a restitution request. Specifically, HRS § 706-646(2) mandates that the losses involved in the restitution request be "reasonable and verified." Moreover, these losses suffered by the victim, must be as a result of the defendant's offense.

Finally, there is no automatic right to restitution unless the sentencing court is satisfied that the prosecution has met its burden of proof as it relates to the restitution request.

Accordingly, the Department of the Prosecuting Attorney, County of Maui, SUPPORTS the passage of this bill. We ask that the committee PASS HB 410.
