## I. OVERVIEW OF PROPOSED LEGISLATION

HB532HD1 adds a new section to Chapter 27, Hawaii Revised Statutes (HRS), to establish a Chief Data Officer within the Office of Enterprise Technology and a data set task force to assist the Chief Data Officer in developing the State's data set policies, procedures, standards, and format standards to be used by all agencies in making their data sets available.

DLIR supports the intent of the measure and proposes an amendment.

## II. COMMENTS ON THE SENATE BILL

The Department supports the intent of this measure. DLIR participates in data sharing with other departments and would like to participate in discussions about open data policies. Therefore, the Department proposes amending the measure to include the DLIR Director or the Director's designee as a member of the Data Task Force.

My name is Murray Clay and I am Managing Partner of Ulupono Initiative, a Hawai'i-based impact investment firm that strives to improve the quality of life for the people of Hawai'i by working toward solutions that create more locally produced food; increase affordable, clean, renewable energy; and better manage waste and fresh water resources. Ulupono believes that self-sufficiency is essential to our future prosperity and will help shape a future where economic progress and mission-focused impact can work hand in hand.

Thank you for the opportunity to submit testimony on this bill, which would create a Chief Data Officer (CDO) and a Data Task Force within the Office of Enterprise Services (ETS). The Office of Information Practices (OIP) supports the intent of this bill to increase availability of data held by state agencies both to the public at large and to other agencies, but **requests clarification of OIP's role in the development of data policies and procedures and has suggested an amendment** to the bill, similar to the one that this committee made in S.B. 1001, S.D. 1 (also retained in S.D. 2).

Currently, OIP is charged with assisting the Chief Information Officer (CIO) to develop open data policies and procedures, as those policies and procedures must take account of what information is or is not public under the Uniform Information Practices Act (UIPA), chapter 92F, HRS, which OIP administers. This bill would not remove OIP's statutory responsibility to assist, although the CIO's statutory role in administering open data would be assumed by the new CDO. However, the newly created Data Task Force would also be charged with assisting the CDO to develop open data policies and procedures. of the Data Task Force and presumably would consult with it regarding open data policies and procedures during its meetings, but since OIP is not represented on the Data Task Force as proposed by this bill, OIP would not be part of that process. Thus, it is not clear what OIP's role would be in the development of open data policies and procedures.

If the intent was to have OIP act as a resource for the CDO without the constraints the Sunshine Law (part I of chapter 92, HRS) would place on discussions between the CDO and another member of the Data Task Force outside a meeting, OIP would recommend amending this bill in the same way this Committee amended its companion, S.B. 1001, to make OIP's director or the director's designee a nonvoting ex officio member of the Data Task Force who would not be counted toward quorum. This would clarify that OIP's representative was expected to attend and participate in discussions of open data policies and procedures during Data Task Force meetings, but OIP's representative would not be counted as a member for the purpose of the Sunshine Law's permitted interactions (which permit a strictly limited number of board members, typically less than a quorum, to discuss board business outside a meeting in specified circumstances). Thus, the CDO would still be able to consult with OIP's representative outside a meeting about whether information was considered public under the UIPA. The following language, added to the end of the proposed subsection 27-44(d) (bill page 5), would accomplish this:

<u>The director of the office of information practices or the</u> <u>director's designee shall serve as a nonvoting ex officio</u> <u>member of the task force and shall not be counted toward</u> <u>quorum.</u>

My name is Christine Sakuda and I serve as the executive director of Transform Hawai'i Government (THG), a coalition of organizations and individuals who believe in improving government services and business practices through technology to ensure that policymakers, State employees, local residents and businesses have convenient and secure access to reliable information and data on demand.

THG strongly supports House Bill 532, HD1, Relating to Government Data, which establishes a chief data officer and data task force to develop, implement, and manage statewide data policies, procedures, and standards.

Access to empirical data is essential to providing information to decision-makers, both within and external of government, so they are able to make informed decisions. Data governance is among the top 10 priorities among state chief information officers nationwide, according to the National Association of State Chief Information Officers (NASCIO).

In 2018, members of the Information Technology Steering Committee to include the State chief information officer, other government agencies and the public met to craft the State's IT strategic plan. Establishing a chief data officer was among their priorities.

In 2012, the State of Hawai'i launched its official data website, data.hawaii.gov, to increase public accessibility to public data. However, since then, data management continued in a decentralized manner typical of many state governments: fragmented, seldomly refreshed, hard to find and less than accessible. As a result, opportunities for integration are severely limited.

It is time to commit resources to update and develop a long-term vision, goals and objectives to enable all branches and departments of our State government to work together in a coordinated fashion and finally establish an open data strategy. This includes facilitating vital sharing of data between State agencies, where possible, so that data shared across agencies contributes to the effective, efficient, and transparent delivery of information resources and services.

HB 532, HD1 will ensure that sufficient and appropriate resources are available to develop policies and procedures to implement standards with the goal of making data sets available to decision-makers and data users, as intended under Section 27-44.3, Hawai'i Revised Statutes.

## In consideration of HB 532 HD 1 RELATING TO GOVERNMENT DATA

# Aloha Chair Keohokalole, Vice-Chair English, and Members of the Senate Committee on Technology:

Elemental Excelerator respectfully submits our **support for HB 532 HD 1**, which establishes a Chief Data Officer and Data Task Force in the Office of Enterprise Technology Services to develop, implement, and manage statewide data set policies, procedures, and standards.

Elemental Excelerator is a Honolulu-based growth accelerator program founded and operating in Hawai'i. We have awarded over \$30 million to 82 companies resulting in 56 demonstration projects in Hawai'i & Asia Pacific. Each year, we select 15-20 companies that best fit our mission and fund each company up to \$1 million. We recruit innovative entrepreneurs from around the world to come to Hawai'i and find transformative solutions to help us achieve our 100% clean energy goals.

In April 2018, Elemental Excelerator commissioned a study entitled *Transcending Oil: Hawai'i's Path to a Clean Energy Economy.* The study found that in Hawai'i, transitioning to renewable energy is cheaper than sticking with fossil fuels. The faster we go, the cheaper it will be. The study also recommended creating an open data environment as an enabling tool to realign incentives with clean energy goals.<sup>1</sup>

**We support HB 532 HD 1** because we believe a well-resourced chief data officer provides our state the opportunity to implement an open data environment that will help us make more informed decisions to ensure transparency and grow innovation solutions to our most urgent environmental problems, including sectors we enable: energy, water, agriculture, mobility, and the circular economy. About 15% of Elemental Excelerator's 82 portfolio companies, such as Kevala focus on clean energy-related data that is meaningful, transparent, and broadly accessible, demonstrating a growing opportunity to attract innovation with forward-thinking policies.<sup>2</sup>

Transcending Oil states that "[a]ccelerating the transition [to clean energy] could reduce oil consumption by 85 to 267 million gallons and spur as much as \$2.8 billion additional cumulative investment by 2030, compared to Business as Usual. It could also create up to 1,500 net new jobs per year, on average, between 2021 and 2030. To realize these outcomes, we find Hawai'i will need to build a more efficient and open electric grid equipped with AMI and

implement regulatory frameworks that allow distributed PV, DR, and other flexible resources to provide an array of grid services. Increased energy efficiency investments can make the acceleration more attainable. **Data sharing and transparency** can make sure all of these resources and frameworks operate efficiently and cost-effectively.<sup>13</sup>

Dear Chair Keohokalole, Vice Chair English, and Members of the Committees:

The City and County of Honolulu Office of Climate Change, Sustainability and Resiliency (Resilience Office) **supports** House Bill 532 HD1, which requires the Office of Enterprise Technology Services Chief Information Officer to update the state information technology strategic plan every four years, and establishes a Chief Data Officer and Data Task Force in the Office of Enterprise Technology Services to develop, implement, an manage statewide data set polices, procedures, and standard.

There is an increasing amount of government data available that can be opened up with a deliberate effort on the part of the State. This data can spur innovation, improve government efficiency, and contribute to more informed decision making across the State. However, without a lead entity to open up these data sets, it can be very difficult to access. This bill is a move in the right direction, as it prioritizes making these data sets available and clearly assigns responsibility for doing so.

The City is in the process of planning for and implementing ambitious energy, transportation, and climate resilience initiatives. The Resilience Office is responsible for developing a resilience strategy and climate action plan for the City. Having a Chief Data Officer to oversee overall data operations and practices to prioritize transparency, access, usefulness, and integrity of data will promote a variety of mutually-beneficial
