Chair Keohokalole, Chair Wakai, and Members of the Committees:

My name is Ji Sook "Lisa" Kim, and I am the Cable Administrator of the Department of Commerce and Consumer Affairs' (Department) Cable Television Division. The Department supports this bill.

The purposes of this bill are to: (1) establish the Hawaii Broadband Office within the Department of Business, Economic Development, and Tourism (DBEDT), including the creation of a state broadband strategy officer position to head the office; (2) rename the Broadband Assistance Advisory Council to the Broadband Advisory Council and amend the council's membership and duties; and (3) transfer the amended duties of the council to DBEDT.

The Department recognizes the strong relationship between broadband access and economic development, as well as broadband's importance in fostering education, health, community building, and civic engagement throughout the State. Accordingly,

the Department supports the approach taken by this measure to create a central office solely focused on facilitating the availability of affordable broadband access services through the development of the State strategy and policies, coordination of efforts among public and private broadband stakeholders, and the securing of funding and investment for broadband infrastructure, services, and programs. The Department defers further comment to DBEDT with respect to the overall program scope of the proposed broadband office and its required funding.

Broadband is fundamental to life and business today and to Hawaii's future. It is the retail operation instantly transmitting sales to its bank account. It is a visitor reserving a helicopter tour. It is the orthopedic surgeon accessing a patient's X-ray instantly from the diagnostic lab. It is the telescope operator of a defense contractor capturing images of objects in space. It is the utility precisely identifying trouble spots in its smart grid. It is a student developing a solution to connect a need with a resource.

We cannot live without it today and we can only thrive as island economies in the decades to come by enhancing and expanding it.

The Economic Development Alliance of Hawaii (EDAH) supports this bill. Planning ahead to best position Hawaii statewide for this vital infrastructure is therefore critical. Creating the Broadband Office and the Strategy Officer would convey that a robust broadband is a State priority for its residents and businesses and give this goal the attention and investment it needs.

In 2015, the Economic Development Alliance of Hawaii was tapped by the State of Hawaii to spearhead the most recent Comprehensive Economic Development Strategies (CEDS) process. This process is prescribed by the U.S. Department of Commerce's Economic Development Administration (EDA). It is a collaborative process engaging numerous stakeholders statewide to articulate an economic roadmap for the stable, long-term economic vitality for all residents of the state. The CEDS process utilized cluster-based strategies which identified actionable initiatives to nurture economic resilience and growth. The 2015 CEDS report underscored the expansion of broadband as an essential component and major objective in achieving the state's economic development goals in the Research, Innovation, and Technology Sector.

EDAH is a 501(c)(3) nonprofit corporation. It is comprised of the leaders of the state's four Economic Development Boards, Hawaii Business Roundtable, the University of Hawaii, and the business community. EDAH works with the public and private sectors and community-based organizations and individuals to spur economic growth and sustainability throughout the State of Hawaii. We stand ready to work with the Office to realize the mutually sought objectives.
