#### Comments:

I am a retired college professor/network engineer. The level of internet service offered in rural areas is significantly lacking. Satellite internet service (Viasat) is inadequate, particularly with the heavy rainfall in some areas here on the Big Island.

Hawaiian Tel tells us they are out of sockets in certain areas and cable connections are based on a number of connections in a geographical area. In order for them to install infrastructure, they want 25 or more households.

Various governments (county and state) should be lobbying providers to go after FCC grants to provide service to underserved populations. In is the best interest of businesses (particularly real estate) to pursue better internet service. It is often the "deal breaker" for lack of good internet service. With 5G technology already being implemented, this is even more important.

If we had really good internet, some of the tech support that is off shore could create job here in Hawaii.
