Chair McKelvey and Members of the Committee:

My name is Ji Sook "Lisa" Kim, and I am the Cable Administrator for the Department of Commerce and Consumer Affairs' (Department) Cable Television Division. The Department supports this bill.

The purposes of this bill are to: (1) establish the Hawaii Broadband Office within the Department of Business, Economic Development, and Tourism (DBEDT), including the creation of a state broadband strategy officer position to head the office; and (2) transfer certain duties relating to the Broadband Assistance Advisory Council to DBEDT.

The Department recognizes the established relationship between broadband access and economic growth and development, as well as broadband's importance in fostering education, health, community building, and civic engagement throughout the State. Having a single office responsible for strategic planning and setting the State's overall broadband direction would assist in the development of broadband services.

Accordingly, the Department supports the approach taken by this measure to create a centralized broadband office responsible for establishing statewide broadband policy and strategic plans, as well as facilitating coordination between public and private broadband stakeholders.

In Consideration of HB 533 RELATING TO BROADBAND

Chair McKelvey, Vice Chair Kitagawa, and Members of the Committee.

The Department of Business, Economic Development, and Tourism (DBEDT) offers **comments** on HB 533 which establishes the Hawaii Broadband Office in DBEDT, establishes the position of State Broadband Strategy Officer and a second exempt position, requires the Director of DBEDT, or designee, to convene and chair the Broadband Assistance Advisory Council (BAAC), and appropriates \$200,000 to be expended by DBEDT.

DBEDT believes it would be premature to take a position on this bill at this time for the following reason. HB 533 calls for an expanded role for DBEDT which we have not had an opportunity to discuss and plan for with our sister state agencies, the county agencies, and private sector stakeholders.
