Testimony in SUPPORT of HB580 RELATING TO MENTAL HEALTH

1 Fiscal Implications: None.

Department Testimony: The Department of Health supports this bill because it can increase the 2 3 capacity to provide mental health services for adolescents who may want to receive counseling without having to have permission from a parent or without disclosing their reason for seeking 4 help to a parent. When the original bill changing the age of consent for mental health services to 5 14 was passed by the legislature in the 2016 session, it was a helpful step forward in ensuring 6 7 that youth who are suffering emotionally can get help. However, it applied only to services provided by licensed mental health professionals. As you may be aware, most of the readily 8 9 available and low- or no-cost services in Hawaii are provided – not by licensed professionals – but by unlicensed professionals who are in the process of meeting all the requirements for full 10 licensure under the supervision of a licensed professional. This includes interns, practicum 11 students and newer graduates who have not completed all the requisite hours of experience or 12 passed the examination necessary for licensure. In general licensure as a mental health 13 professional of any kind in Hawaii requires at least a year of full-time supervised practice after 14 graduating with the relevant degree. The purpose of this bill is to authorize these mental health 15 professionals working under the supervision of a licensed mental health professional to provide 16 mental health treatment or counseling services to minors without parental consent when this is 17 18 clinically indicated.

- 1 This bill is a product of a task force led by the Department of Health (DOH), Child and
- 2 Adolescent Mental Health Division (CAMHD) as mandated by Act 13, SLH 2018. The task
- 3 force was comprised of legislators, representatives of health insurers, state agencies, advocates,
- 4 and community members. A list of task force attendees and a summary of task force findings

7 The task force focused primarily on questions regarding counseling practices with lesbian, gay, 8 bisexual, transgender, questioning (LGBTQ) youth. As detailed in the report, local Hawaii data 9 reveal that homosexual and transgender youth are at significantly heightened risk of substance 10 abuse, mental health difficulties and suicide. These youth often feel alienated from their parents 11 and other family members or fear revealing their struggles around their sexual orientation and/or 12 gender identity to their parents. The ability to find a counselor without having to involve a parent 13 can be especially crucial for these youth.

- Offered Amendment: We would like to offer a friendly amendment to the wording of the bill where it defines "mental health professional," to clarify and ensure all relevant professions are included. An edited version of that definition is offered below.
- "Mental health professional" means a person who is working under the supervision of a
 licensed mental health professional and either: 1) is enrolled in an accredited training
- 19 program <u>or 2</u>) has completed all licensing requirements <u>except the hours of supervised</u>
- 20 post-degree experience and/or the examination required for state licensure, for licensed
- 21 mental health counselors pursuant to chapter 453D, for licensed marriage and family
- therapists pursuant to chapter 451J, for <u>clinical</u> social workers pursuant to chapter 467E,
- 23 <u>for psychologists pursuant to chapter 465</u> or for advanced practice registered nurses
- 24 pursuant to chapter 457."

The Hawai'i Psychological Association (HPA) supports HB580 with an important recommended amendment. HPA supports this bill because it is consistent with our interest in ensuring access to quality mental health services to the diverse people of Hawai'i. If passed this bill would help increase the capacity of our public and private mental health systems to provide mental health services for adolescents who are seeking counseling, but who do not want to obtain permission from a parent or do not want to disclose their reasons for seeking help to a parent.

When the original bill changing the age of consent for mental health services to 14 was passed by the legislature in the 2016 session, it was a helpful step forward in ensuring that youth who are suffering emotionally can get help. However, the current statute applies only to services provided by licensed mental health professionals. As you may be aware, most of the readily available and low- or no-cost services in Hawai'i are provided – not by licensed professionals – but by unlicensed professionals who are in the process of meeting all the requirements for full licensure under the supervision of a licensed professional. This includes interns, practicum students, and newer graduates who have not completed all the requisite hours of experience or passed the examination necessary for licensure. In general, licensure as a mental health professional of any kind in Hawai'i requires at least a year of full-time supervised practice after graduating with the relevant degree. The purpose of this bill is to authorize these mental health professionals working under the supervision of a fully licensed mental health professional to provide mental health treatment or counseling services to minors without parental consent when this is clinically indicated.

This bill is a product of a task force led by the Department of Health (DOH), Child and Adolescent Mental Health Division (CAMHD) as mandated by Act 13, SLH 2018. The task force focused primarily on questions regarding counseling practices with LGBTQ youth. These youth often feel alienated from their parents and other family members or fear revealing their struggles around their sexual orientation and/or gender identity to their parents. The ability to find a counselor without having to involve a parent can be especially crucial for these youth. In addition, some youth are reluctant to disclose their concerns to their parents for a wide variety of other reasons, such as undisclosed sexual abuse, substance abuse problems, and situations of high family conflict.

HPA would like to support the amendment to the wording of the bill being recommended by the Department of Health to clarify the definition of a "Mental Health Professional" and ensure all relevant professions are included. We are particularly dismayed that Psychologists as a group were omitted from the text of the bill, apparently by an oversight. We request the following amendment to Section 1 on page 4, lines 1 through 9:

"Mental health professional" means a person <u>who is</u> working under the supervision of a licensed mental health professional and <u>either: 1</u>) is enrolled in an accredited training program <u>or 2</u>) has completed all licensing requirements <u>except the hours of supervised post-degree experience and/or the examination required for state licensure</u>, for <u>licensed</u> mental health counselors pursuant to chapter 453D, for licensed marriage and family therapists pursuant to chapter 451J, for <u>clinical</u> social workers pursuant to chapter 467E, <u>for</u> <u>psychologists pursuant to chapter 465</u>, or for advanced practice registered nurses pursuant to chapter 457."

Thank you for the opportunity to provide input into this important bill.

Aloha,

I am a parent on the island of Kaua'i, and my family strongly supports HB 580 and urges you to pass this bill. I know firsthand how important it is for young people to have access to mental health support; my daughter experienced depression and anxiety as she entered adolescence, and there was no support availlable at her school. We were most fortunate to have health insurance that helped us to cover it, but I know so many families do not have this benefit and still need it. Many teenagers would not feel comfortable approaching their parents about seeing a counselor, and some would actually be in danger if they did if they are suffering from abuse. It's critical that students have access to mental health professionals who can help them with whatever their issues might be.

My daughter is now a happy and healthy 18 year old attending college on the mainland, and she credits the work she did with her therapist for helping her to end her suicidal thoughts, learn to manage her anxieties and depression in healthy ways without using prescriptions, and to cope with the many difficulties of growing up in this modern world. It's critical to have that opportunity extended to all young people in Hawai'i, especially given our high rate of teen suicide. Please support this bill and help it to become law, and part of our education budget.

Hello, good afternoon committee members. My name is Stephanie DeMello and I am a masters student at the University of Hawaii at Manoa, I am also a longtime childcare worker on the Marine Corps Base of Hawaii and am currently doing my practicum with Hina Mauka at the Women's Community Correctional Center. I strongly support H.B No. 580, Relating to mental health, which would authorize mental health professionals, under the supervision of a licensed mental health professional, to provide mental health treatment or counseling services to minors.

The earlier mental health is addressed in a person's life the better chance they have at developing positive coping skills to deal with their mental illness. Adolescents and youth are often left to deal with their mental illnesses on their own or within their family units. I believe, working with adolescents as long as I have, that we need to destigmatize mental health services so adolescents can talk out their problems in such a big time in their lives with licensed professionals who know what stages of life they are going through. This population of youth are often pushed aside and left to deal with heavy emotions, changing hormones and bodies as well as told their feelings are invalid due to hormones. This is a good preventative measure to take to help prevent emotions from bottling up as well as a good screening measure for youth who may have mental health needs but it goes unnoticed or pushed aside.

I urge the committee to pass H.B. No. 580. Thank you for this opportunity to testify.
