In consideration of HOUSE BILL 590 RELATING TO THE WILDLIFE REVOLVING FUND

House Bill 590 proposes to require the Department of Land and Natural Resources (Department) to use monies received into the wildlife revolving fund for certain purposes and requires that the Department consult with the Game Management Advisory Commission prior to making any wildlife revolving fund expenditures. **The Department opposes this bill.**

Pursuant to Section 183D-10.5, Hawaii Revised Statutes (HRS), the wildlife revolving fund is established as a repository for moneys collected as fees from hunting licenses, tags, etc. as well as fines or bail forfeitures for violation of Chapter 183D, HRS, or any provision of Chapter 195D, HRS, concerning native, threatened and endangered species protection. Section 183D-10.5, HRS, also limits expenditures to the following:

- Implement or enforce Chapter 183D, HRS;
- Implement or enforce Chapter 195D, HRS;
- The acquisition of the use, development, or maintenance of trails and accessways to lands where hunting or hiking by the public is authorized;
- Research programs and activities concerning wildlife conservation and management; and
- The importation, management, preservation, propagation, and protection of game or wildlife in the State.

This bill proposes to further restrict expenditures from the wildlife revolving fund, requiring all expenditures be used "to preserve, protect, and promote public hunting." This will potentially

LAND STATE PARKS disallow expenditures for endangered species protection. Should fines for violating Chapter 195D, HRS, be deposited in the wildlife revolving fund for killing endangered species, for example, those funds could not be used to mitigate for the violation. This bill would require the fines be diverted to support public hunting, contrary to the intent of Section 183D-10.5, HRS.

Further, Section 183D-4.5, HRS, establishes the Game Management Advisory Commission (GMAC) to serve in an advisory capacity to the Board of Land and Natural Recourses and defines the roles and responsibilities of the GMAC.

This bill would require that the Department coordinate with the GMAC prior to authorizing any expenditures from the wildlife revolving fund and to use the funds "as directed by the game management advisory commission." However, Section 183D-4.5, HRS, does not give the GMAC authority over the Department's fiscal responsibility, nor does it give the GMAC direct oversight of day-to-day management and expenditures of the Division of Forestry and Wildlife. This bill would provide an unprecedented and inconsistent level of power for an advisory commission.

The Department does provide the annual wildlife revolving fund's legislative report to the GMAC and has discussed the use of the revolving fund for specific hunting-related projects, which the Department will continue to do. The Department greatly appreciates the collaboration and advice the GMAC provides and will continue to consider GMAC's advice and recommendations; however, the Department feels this bill oversteps the intent of Section 183D-4.5, HRS.

Hawaii's game animals were introduced to the Islands as an alternative source to ocean protein dating back to the arrival of early Polynesians. They have become a fixture in our culture as a sustainable food resource.

Properly managed, they contribute to our Islands self-sufficiency, generate income, and provide recreational opportunity for the people of Hawaii.

To further enjoy this lifestyle a more balanced approach to resource management is required. This means more balance in policy making and implementation.

Current forest conservation and watershed management plans do not address long term mixed use resource management practices.

The difference between preservation and conservation must be understood.

Preservation is usually based on the principle that things simply have the right to exist, therefore they must be protected. In other words, to keep possession of and no touch no access.

Conservation implies that the reasons behind protecting something are based on using and managing that resource wisely.

Wildlife management is challenging, engaging, and often controversial. The beauty of working collaboratively with all parties of interest allows us to take down barriers and build partnerships to overcome differences while completing important work on the ground. This is especially important in the face of habitat fragmentation, drought, human population expansion, and conflicting agendas that could be disastrous for wildlife, for hunting and gathering, and for other types of outdoor recreation that we all hold so dear.

Dear Committee on Water, Land, and Hawaiian Affairs,

I am in support of HB 590. And would like to share a few comments.

I currently serve as East Hawaii Representative on the State Game Management Advisory Commission and organize the facebook group of the Hawaii Sportsmen's Alliance.

In the years of working with the DLNR, there is an issue with hunter generated revenue in the Wildlife Revolving Fund (WRF) and managing game mammal species for long term hunting as perhaps outlined in duties of HRS 183D-2-12. The existing WRF statute is typically accompanied by a Department policy that WRF monies be matched with Pittmann-Robertson Federal monies. This is generally a good thing until funds are sought to manage the long term viability of game mammal species in Hawaii. Generally, when State monies are matched with federal monies, the federal rules apply. One of which is Section 7 of the Endangered Species Act which, in general, states no federal funds can be used toward anything deemed detrimental to the existence of endangered species. This Section 7 review is conducted by the Fish and Wildife Service Pacific Region and, in general, they have a policy that any game mammal management activities are detrimental to endangered species regardless of site specific circumstances. This DLNR policy and subsequent federal review generally prohibits the State from spending money on game mammals they otherwise would have State prerogative to manage on State land. The hunting public I serve would like to urge the DLNR and the legislature to find a reasonable fix to this issue as it is one obstacle to completing game management plans.

Game Management Plans in State land, deemed suitable for sustained yield use, desperately needs to be completed and approved. If plans are not created, the aforementioned Fish and Wildlife Service policy deeming game mammals detrimental to endangered species regardless of location or site specific circumstances will indirectly promote more game mammal eradications on public land and result in the loss of public game mammal hunting which is contrary to HRS 183D-2-12, "To preserve, protect, and promote public hunting." If we lose the resource because of no planning, we will lose the public hunting. No resource, no hunting.

I support protection of priority environmental issues, to include endangered species. However, the DLNR has made efforts to plan for game mammal management activities given these issues and they continue obstructed. The State Game Management Advisory Commission needs the support of the legislature and DLNR to get these plans done. Unlocking hunter funded resources may be one step in the direction of progress.
