House Bill 620, Proposing an Amendment to the Hawaii Constitution to Require the Election of Members of the Board of Education and House Bill 621, Relating to Education

Dear Chair Woodson, Vice Chair Perruso, and Members of the Committee:

The Board of Education ("Board") would like to provide comments on HB 620, which would propose a constitutional amendment to change the Board to an elected board, and HB 621, which would implement an elected Board should the constitutional amendment pass.

The Board takes no position on this measure, as it relates to the Board's governance structure, and the Board believes it is most appropriate for the Legislature, Governor, and people to decide such matters.

The current Board consists of volunteer members of the community who are dedicated to public education and appointed by the Governor. It is important to note a provision in HB 621 (page 10, lines 15-16) would provide compensation to elected Board members, which is an understated additional proposed change in governance. The current Board opts to be entirely voluntary, as its members believe as many resources as possible should go toward supporting schools.

The Board, like the Legislature and all policymaking bodies, has to make some hard decisions. Each member of the Board believes public education is one of the most important services the State provides, and we want what is best for our students. We leave the important task of determining the best way to govern our public education system to you and the people.

TESTIMONY Janet Mason, Legislative Committee, League of Women Voters of Hawaii

Chair Woodson, Vice-Chair Hashem, Vice-Chair Perruso and Committee Members:

The League of Women Voters of Hawaii opposes HB 620 that proposes amendments to the Hawaii Constitution. HB 620 proposes two amendments to the Hawaii Constitution in a single question. One amendment proposes changing the way school board members are selected from an appointed to an elected board. The second concerns changing the now single school board district to two at-large school board districts. Each topic would require a constitutional amendment. We are left wondering what the intended content of the Proposed Constitutional Amendment is and what option voters have if their preference for one part of this Proposal conflicts with the other part.

We are not clear why an elected school board is suggested. It wasn't long ago, in 2010, that Hawaii voters chose an appointed Board over an elected Board in an apparent bid for accountability in decision-making, So far as breaking up the single district, dedicated financial support to the centralized system has meant economic parity for all of Hawaii's children, whether they lived in urban or rural areas. Will the same dedicated financial support that guaranteed parity to Hawaii's children remain should the single school district be divided into two districts?

If legislators are advocating changing the breakup of the single school board district, this needs to be proposed in a separate amendment to the Hawaii Constitution. If they are advocating changing how board selections are made, this is its own separate issue; i.e. governance, and not to be combined with a question of decentralization of the school board. Because of this confusion we cannot support the bill.

POSITION: Support.

RATIONALE: The Democratic Party of Hawai'i Education Caucus supports HB 620, proposing an amendment to the Hawai'i Constitution to require election of Board of Education members.

Our keiki are our future. When our children succeed, our society becomes more equal and our economy more prosperous. Delivering the schools our keiki deserve, then, is a responsibility that must be shared by all of our state's citizens. Hawai'i voters regrettably abdicated that responsibility by voting for an appointed BOE in 2010, following recession-based furloughs that left our state with a four-day school week and our teachers struggling to get by.

We are no longer facing a fiscal crisis. Moreover, the idea that empowering the governor to appoint members of the BOE would create clear lines of accountability and increase student achievement has been proven false, as the appointed BOE has continued to pursue outdated policies, such as an overreliance on standardized tests to evaluate student learning and school success. Allowing the people of the islands to democratically elect board members, on the other hand, would ensure that the BOE is accountable to the only interest that matters: the people's interest.

I believe that an elected representative State Board of Education (BOE) is equipped better to accomplish its Constitutional mission: to protect public funds and interests in the formation of statewide educational policy, appoint the Superintendent of Education, remain free from for-profit or sectarian control and promote community Hawaiian education programs.

Ninety-six percent of school districts in the nation have elected school boards. Our 1959 State Constitution had a governor appointed School Board. In 1964, an amendment passed to support an elected board. Twice after that, voters rejected amendments that would have returned the state to an appointed board.

In Nov. 2, 2010 the amendment passed by 57.4 percent to replace the elected board of education with one appointed by the governor. The board consists now of 9 voting members, 1 non-voting representative of students and the military. To democratize public education the community school movement challenge is to ensure that the people and communities vested in neighborhood public schools have a real voice in both planning and governance at district level as well as at the school level.
