DEPARTMENT'S POSITION: The Department of Human Services (DHS) defers to the

Department of Commerce and Consumer Affairs (DCCA) testimony on this bill, and offers comments.

<u>PURPOSE</u>: The purpose of this bill is to establish the Hawaii comprehensive healthcare task force in DCCA. The task force shall review the following four healthcare issues:

- 1) The adequacy of capitation rates for health insurance plans;
- 2) The unfunded liability of the Hawaii employer-union health benefits trust fund;
- Health insurance policies and coverages for treatment of mental health conditions; and
- 4) Medical tourism.

DHS defers to the analysis of DCCA on this legislation.

However, DHS as one of the named members of the taskforce, notes that we may not have expertise in all issues to be reviewed by the task force. DHS does not have expertise in medical tourism or the financial status of the Hawaii employer-union health benefits trust fund. DHS also does not have expertise in the issues related to health insurance insofar as those issues relate to the Insurance Article or activities covered under the Insurance Article.

DHS does have expertise if the language surrounding "health insurance" is meant to include Medicaid coverage of mental health and/or the status of the QUEST Integration Medicaid managed care program.

Chair Mizuno and Members of the Committee:

My name is Colin Hayashida, and I am the Insurance Commissioner of the Department of Commerce and Consumer Affairs' (Department) Insurance Division. The Department opposes this bill and offers comments.

The purpose of this bill is to establish a comprehensive healthcare task force established for administrative purposes in the Department to study and report on: (1) the adequacy of capitation rates for health insurance plans; (2) the unfunded liability of the Hawaii employer-union health benefits trust fund; (3) health insurance policies and coverages for treatment of mental health conditions; and (4) medical tourism. Task force members: include the Insurance Commissioner; the Director of Finance or the Director's designee; the Director of Health or the Director's designee; the Director of Business, Economic Development and Tourism, or the Director's designee; the President and Chief Executive Officer of the Hawaii Tourism Authority or the President's Testimony of DCCA H.B. 666 Page 2 of 2

designee; and the Administrator of the Med-QUEST Division of the Department of Human Services or the Administrator's designee. The task force is to submit a report to the Legislature no later than 20 days prior to the convening of the Regular Session of 2020.

The Department opposes this bill because the scope of issues for review by the task force, while laudable, is too broad to allow for meaningful review and analysis within the prescribed period. Each of the four topics is worthy of separate discussion by the appropriate stakeholders.

Also, this bill requires the Department to provide administrative and clerical support to the task force and provides that task force members "shall be reimbursed for reasonable expenses necessary for the performance of their duties, including travel expenses." This measure, however, does not provide for funding to the Department for these purposes.

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act shall be known as the "Hawaii Comprehensive Healthcare Act."

["comprehensive healthcare" defined as medical, prescription drugs, skilled nursing, rehabilitation therapy, [mental health services], vision and dental services provided by physicians and other licensed professionals who maintain and/or restore an individual's physical, and mental health and wellbeing.]

SECTION 2. (a) There is established in the department of commerce and consumer affairs for administrative purposes only the Hawaii comprehensive healthcare task force. The task force shall review the following five [seven] healthcare issues:

(1) The appropriateness of capitation rates for health insurance plans;

(2) The unfunded liability of the Hawaii employer-union health benefits trust fund; (3) Health insurance policies and coverages for treatment of mental health conditions;

(4) Medical tourism;

(5) [Potential challenges to the State's present healthcare system as a result of recent changes to the federal Affordable Care Act;]

(6) Projected costs of a prospective shift to a statewide [comprehensive health care plan as specified in section 1; and]

(7) [Review how to] support outreach efforts, plan, develop, oversee and monitor state-wide outreach and educational program to promote awareness of existing health plan options, savings programs and/or launch of new health initiatives through a combination of workshops, localized grassroots efforts and mass-marketing campaigns utilizing print, television, and radio will be utilized to alert individuals to programs that reduce cost sharing.

(b) The membership of the Hawaii comprehensive healthcare task force shall be as follows:

(1) The insurance commissioner or the commissioner's designee [shall serve as chairperson of the taskforce, designee must come from the commissioner's department;]
(2) The director of finance or the director's designee;
(3) The director of health or the director's designee;

(4) [The director of business, economic development, and tourism, or the director's designee;]

(5) The president and chief executive officer of the Hawaii tourism authority or the president's designee;] The

director of labor and industrial relations or the director's designee;

(6) The chief administrative officer for the Hawaii health systems corporation or the chief administrative officer's designee; and

(7) The administrator of the med-QUEST division of the department of human services or the administrator's designee.

(c)Task force members [<u>may further recommend to the task</u> <u>force chairperson</u>] that additional members with appropriate specialized expertise, subject to approval by the chairperson.
