Chair Lowen and Members of the Committee:

The Department of the Attorney General submits comments.

The purpose of this bill is to add, as an alternative punishment, impounding of a vehicle used in the commission of the offense for the felony and petty misdemeanor offenses of disposal of solid waste, as set forth in sections 342H-37 and 342H-39, Hawaii Revised Statutes (HRS, respectively).

The Department considers violators of environmental laws serious offenders whose actions threaten the health of Hawaii's people as well as our precious environment. The Department appreciates the intent of the bill, but shares these comments.

The provisions allowing for the impounding of any vehicle used in the commission of the offense, as an alternative punishment, are vague. For example it is not clear what the parameters of the impoundment process are, when the impounding may take place, who will be responsible for impounding the vehicle, storing it, and maintaining it and what is to become of the impounded vehicle.

Alternatively, forfeiture as provided in chapter 712A, HRS, might be more appropriate. If so, we recommend amending section 712A-4 to include felony disposal of solid waste as an offense for which forfeiture is available.
