**Bill No. and Title:** House Bill No. 713, House Draft 1, Senate Draft 1 Relating to Homelessness, Homeless Employment Grant Program; Appropriation

**Purpose:** Establishes a three-year Homeless Employment Grant Program that provides homeless individuals with work opportunities and connects them with service providers. Requires the Department of Human Services to submit a report to the Legislature prior to the 2020 Regular Session. Appropriates funds. Takes effect 1/1/2059. (SD1)

## **Judiciary's Position:**

The Judiciary supports the creation of this program to provide homeless individuals with an opportunity to improve their lives through public service and increased access to essential social and quality-of-life services. The proposed Homeless Employment Grant Program would share many goals with the Judiciary's growing Community Outreach Court program and would seek similar positive outcomes for its participants. This shared mission could provide a great opportunity for increased partnerships between the Judiciary and the Department of Human Services and enhance the ability of both agencies to implement and expand their homeless outreach efforts.

<u>POSITION</u>: The Governor's Coordinator on Homelessness supports the intent of this measure, respectfully offers comments, and appreciates the amendments of the Senate Committee on Human Services to clarify that contracts between the Department of Human Services (DHS) and a service provider to administer the homeless employment grant program are exempt from section 103F, Hawaii Revised Statutes.

<u>PURPOSE</u>: The purpose of the bill is to establish a three-year Homeless Employment Grant Program that provides homeless individuals with work opportunities and connects them with service providers. The bill also appropriates funds for the program, and requires DHS to submit a report to the Legislature prior to the 2020 Regular Session.

Job training and apprenticeship programs are key strategies to assist homeless individuals in growing income and preventing returns to homelessness following housing placement. In 2009, the Hawaii Community Development Authority (HCDA) implemented a Job Training Program in partnership with the Next Step shelter in Kakaako. By providing custodial and maintenance jobs to Next Step residents, the program provided on-the-job training to homeless individuals and assisted with the maintenance and beautification of the park properties under HCDA's jurisdiction. Today, HCDA continues to contract with Next Step to maintain and perform custodial duties at Kakaako Waterfront Park, the Kakaako Gateway Parks,

and Kewalo Basin Park. Since 2017, the County of Maui has funded and administered a similar program that employs homeless individuals to clean and maintain County sidewalks in Wailuku.

The Coordinator notes that this bill is modeled after a similar program in Albuquerque, New Mexico that is administered with the City of Albuquerque's Department of Solid Waste. In the Albuquerque program, the Department of Solid Waste hired homeless individuals to assist with landscape beautification and garbage removal, and provided the individuals with direct on-site supervision. While DHS administers a variety of employment and job training programs for public benefit recipients, these programs are more general in nature than the City of Albuquerque program that the Employment Grant Program is modeled after.

Hawaii Youth Services Network (HYSN), a statewide coalition of youth-serving organizations, supports HB 713 HD 1 SD 1 Relating to Homelessness

Homeless youth who are living on their own on the streets without support or guidance from their families are the most vulnerable segment of our homeless population. They are children who have not completed their education and lack employment experience.

While on the streets they have few options for meeting their basic survival needs. Homeless youth often trade sex for food, money or a place to sleep. They may be forced to eat food from garbage cans or panhandle.

An employment program would give them safer ways to meet basic needs while building the relationships and trust with support staff that will lead to leaving the streets. They would gain work experience that could lead to longer-term, competitive employment. And it would give them opportunities to contribute to their community by removing graffiti and litter.
