Aloha Chair Creagan, Vice Chair DeCoite, and Members of the Committee:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau supports HB 778, which appropriates funds to the Department of Agriculture for the acquisition of a mobile animal harvesting unit.

Many small family farmers who have found a ready market for their livestock directly to local consumers, restaurants, and stores have difficulty converting their live animals into a product that can take advantage of it. The challenge for many of these small producers is that they often do not have USDA inspected processing facilities available within a practical distance and an affordable cost.

A mobile animal harvesting unit mounted on a trailer that comes to the farm has advantages for small producers such as low capital costs, convenience, improved animal welfare by avoiding long-distance shipping, and low processing costs.
