My name is Jason Bradshaw and I am testifying in favor of HB86 PROPOSING AN AMENDMENT OF THE HAWAII CONSTITUTION RELATING TO THE RESINATION OF STATE SENATORS. I am testifying on behalf of the Labor Caucus of the Democratic Party of Hawaii.

The proposed constitutional amendment before the committee attempts to address two issues: fairness and stability.

Fairness can be explained by the recent example of is the past election for Lieutenant Governor. Senator Willie Espero was in the middle of his four-year term while Senator Josh Green was at the end of his four-year term.

Under the current situation, it required Senator Espero to resign his senate seat upon filing by the deadline of June 7th. Senator Green, on the other hand, was able to serve in office as a state senator until the day of the General Election.

This isn't fair to any senator who happens to run for a state office while in the middle of the four-year term.

It also isn't fair to the constituents of the district since there will be no representation until a replacement is appointed.

This brings up the issue of stability and continuity. In Senator Espero's case, upon his resignation, the Democratic Party from that senatorial district had 30 days to submit a list of three names to the governor for consideration. If by chance, the governor appointed the sitting House member, it would have again triggered a 30-day process to appoint a replacement for the House seat. In this plausible scenario, the appointed House member would serve a very short time thereby depriving the district of representation while this whole process is ongoing.

It would be simpler and fairer to have anyone irrespective of whether it is a mid-term or end-or-term scenario to end the term on the day of the General Election. It would enable anyone seeking the open seats to run in the same way as all other candidates with the same timetable. It would also ensure that the affected districts have seamless representation.
