Chairpersons Creagan and Lowen and Members of the Committees:

Thank you for the opportunity to testify on House Bill 872. This bill seeks to ban the use of glyphosate on or within 100 feet of school property during normal school hours. The Department offers comments on this measure.

Glyphosate is a general use pesticide, available from hundreds retail locations in Hawaii and countless online distributors. There are currently about 200 products licensed for sale in Hawaii with glyphosate as an active ingredient. Unlike the buffer restriction of use of Restricted Use Pesticides (RUPs), sales of which are reported to the Department monthly, glyphosate is a general use product, and the Department would have no way of knowing who is purchasing these products. Because of this, outreach to the general public would be extremely difficult. Additionally, enforcement would be almost impossible for any applications unless they generated a complaint. The passage of Act 45 in 2018 allowed the Department to communicate extensively with all certified applicators and RUP Dealers to help everyone be aware of and comply with the changes in Act 45. Because glyphosate is a general use product, this restriction would apply to every resident of Hawaii, and the same level of outreach and education would not be feasible. Furthermore, using general use pesticides on homeowners' own

property does not require recordkeeping, and proof of identifying who the applicator was may not be possible, particularly if a homeowner does not allow our inspectors onto their property for inspection and sampling.

Most glyphosate and other pesticide labels have label language prohibiting drift into untreated areas, or to areas with unprotected persons. Almost all, if not all, glyphosate products include language that prohibit entry until sprays have dried. Additionally, Chapter 149A-31(2) states "No person shall . . . use, store, transport, or discard any pesticide or pesticide container in any manner which would have adverse effects on the environment(.)" Because of this, the Department feels that existing label language and State Pesticides Law is sufficient in protecting children from glyphosate drift.

- 1 **Fiscal Implications:** No funding is provided to implement this measure.
- 2 Department Testimony: This measure seeks to restrict the use of glyphosate on school
 3 properties or within 100 feet of schools during normal school hours.
- 4 The Department of Health (Department) believes that the health of our keiki and other sensitive
- 5 communities should be protected from exposure to hazardous chemicals, and believes that buffer
- 6 zone determinations should be data-driven and pesticide specific.
- 7 The Department has concerns about the conflicting science reported in this measure. While the
- 8 2015 IARC determination of glyphosate as a probable human carcinogen received a lot of
- 9 attention, it was not based on the latest available data, including the results of the landmark 2017
- 10 National Institute of Health's Agricultural Health Survey which followed 44,932 farmers who
- used glyphosate for over 25 years and did not find a statistically significant association between
- 12 glyphosate and cancer. In addition, IARC's conclusions are not supported by subsequent
- 13 evaluations by multiple worldwide regulatory agencies. Comprehensive reviews by US EPA
- 14 (2017), the European Union's European Chemical Society (2017), and the environmental
- regulatory agencies of Japan, Canada, Australia and New Zealand have all concluded that there
- 16 is no evidence to classify glyphosate as a human carcinogen.

- 1 Based on all the available toxicological information, the Department believes there is no
- 2 scientific basis to add specific additional restrictions for glyphosate.
- 3 The Department continues to provide technical and scientific support to the Department of
- 4 Agriculture (DOA) regarding pesticide monitoring, safety and exposure.

HB 872 – RELATING TO ENVIRONMENTAL PROTECTION

Chairs Creagan and Lowen, Vice Chairs DeCoite and Wildberger and members of the House Committee on Agriculture and Committee on Energy and Environmental Protection:

Thank you for the opportunity to testify on HB 872 relating to environmental protection with the intent of requiring a 100 foot buffer around schools when glyphosate is applied. The University of Hawai'i at Mānoa, College of Tropical Agriculture and Human Resources <u>opposes</u> the intent of this bill and we respectfully provide the following information to substantiate our position.

The World Health Organization's (WHO) International Agency for Research on Cancer (IARC) has classified that glyphosate is a probable carcinogen. However, this is in conflict to assessments by the U.S. Environmental Protection Agency and the European Food Safety Authority. In addition, the findings of IARC have been called into question due to a board members statement that IARC did not review all studies available.

There has been concern expressed, based on a recent court case that glyphosate has been linked to non-hodgkins lymphoma. However, the National Institutes of Health did a comprehensive study (the Agricultural Health Study) that included 54,000 licensed pesticide applicators and found no link of non-hodgkins lymphoma with glyphosate. Pesticides are toxic and one way to look at them is to compare toxicities. While this is not completely accurate, it can be illuminating and give perspective. The information below uses the LD50, which estimates the lethal dose that would result in mortality of half the test sample.

The same type of evaluation can be made using different measures of toxicity with similar results.

Another way to evaluate the danger posed by glyphosate, using IARC's own classification is to look at what it considers to definitely cause cancer. That would be agents in one category more dangerous than glyphosate. For example, processed meat is in Group 1 (carcinogenic to humans) as is estrogen. Glyphosate is in Group 2A (probably carcinogenic to humans).

Therefore, we <u>oppose</u> this bill at this time based on the fact that the evidence does not warrant a specific buffer strip prescription for the use of glyphosate based on its low toxicity relative to other common products and the credible evaluation of national agencies.

Aloha Chairs Creagan and Lowen, Vice Chairs DeCoite and Wildberger, and Members of the Committees:

I am Brian Miyamoto, Executive Director of the Hawaii Farm Bureau (HFB). Organized since 1948, the HFB is comprised of 1,900 farm family members statewide, and serves as Hawaii's voice of agriculture to protect, advocate and advance the social, economic and educational interests of our diverse agricultural community.

The Hawaii Farm Bureau opposes HB 872 for the following reasons:

- The stated purpose of the bill (page 3, line 18 and 19) is to restrict the use of glyphosate <u>on school properties</u>, yet the bill restricts the use of glyphosate on private and public property outside of school properties.
- Before restricting use of a legal product, we should first identify the problem and then develop an appropriate solution.
- Glyphosate has been reviewed by regulatory agencies around the world; they have found no link to carcinogenicity or other negative human health outcomes when used according to directions. The U.S. Agricultural Health Study, published in the Journal of the National Cancer Institute, which is the largest epidemiology study of this kind, following over 50,000 applicators and their families over 20 years found no link between glyphosate herbicides and any type of cancer.
- Public policy to restrict EPA-approved and registered pesticides should be based on science and evidence. There is no scientific justification for randomly restricting glyphosate use.
- There are benefits to the prudent use of glyphosate -- it can control excessive or otherwise unwanted vegetation that can harbor mosquitos, slugs, ticks, fleas, and other vectors that spread deadly diseases.

• Enforcement will be problematic, as many homeowners and others may need to use glyphosate during daylight hours on weekdays. Not only farmers, but homeowners, state and local governments, and parks use it as a simple and cost-effective way of controlling invasive weeds and noxious plants in gardens, parks, sidewalks, roadways and wildlife habitats.

Dear Chairs Creagan and Lowen:

On behalf of the Western Plant Health Association (WPHA), I am writing to express our **opposition** to HB 872, which would prohibit the application of any glyphosate product on or within one hundred feet of a school property during normal school hours. WPHA represents the interests of fertilizer and pesticide manufacturers, agricultural biotechnology providers, and agricultural retailers in Hawaii, California, and Arizona.

WPHA appreciates the author's interest in assuring the safe use of pesticides. However, we believe HB 872 mischaracterizes the risks posed by glyphosate products. HB 872 states that California's Office of Environmental Health Hazard Assessment (OEHHA) has listed glyphosate as a Proposition 65 chemical based on a controversial recommendation of the International Agency for Research on Cancer (IARC). What is not included is that upon review by U.S. federal courts, it was found that while under OEHHA's listing mechanism, they could list glyphosate, the science utilized for the listing, including the IARC finding, was so flawed that it would be a disservice to the public to require manufacturers to include the Proposition 65 warning on product labels. This finding by the courts has been upheld on appeal and California does not require any label warning about the risk of glyphosate as a carcinogen.

Glyphosate is perhaps the most studied herbicide that has been registered for use. The bill findings cite the IARC report as a basis for concern over the safety of glyphosate. It does not include the fact that there are over 800 studies confirming the safety of glyphosate, including as an example recent studies from the United States, European Union, Canada, Korea, Japan, New Zealand, and Australia among many other countries. California's own Department of Pesticide Regulations has conducted a risk assessment and found that glyphosate does not pose a health risk to the public. In addition, three other agencies within the World Health Organization which houses IARC have found that glyphosate does not pose a health risk.

It has been demonstrated that the cost of moving to alternative products poses substantial costs to schools and municipalities. WPHA could better appreciate the desire to require precautionary safeguards if there were scientifically factual studies indicating risk. However, with the overwhelming weight of science demonstrating virtually no risk from the use of glyphosate, we believe that to force schools or local governments to absorb these costs based on allegations and not scientific fact is a disservice to the impacted parties. We also believe that to require application prohibitions that are not based on science sends an inaccurate message suggesting risks not based in science.

WPHA supports the safe application of pesticide products in all situations. However, as there is no demonstrated risk from glyphosate products, we believe HB 872 goes beyond what is appropriate from a health and safety standpoint and from an unnecessary cost standpoint for schools. For this reason, we ask for a "**no**" vote on HB 872. We believe that the better process to address safety concerns would be to assure that any school personnel that applies pesticide products has been trained to follow label requirements. We would recommend that perhaps funding for training school personnel would be a more effective way to address concerns. This would then assure the appropriate application of any product based on label directions used in or around schools. We thank you for your consideration of our comments. My name is Dan Clegg, Hawaii Business Operations Lead for Bayer Hawaii. Bayer Hawaii operates multiple farms in Hawaii and we have over 600 dedicated employees who live in our local communities and attend the schools on Maui, Molokai and Oahu. Bayer is one of the manufacturers who produce and sell a variety of pest control products that contain glyphosate.

Thank you for allowing us to comment on HB 872 which prohibits the use of glyphosate herbicides on or within 100 feet of a school during school hours. We understand that people want more information and appreciate the opportunity to discuss this with anyone. First and foremost, our priority is the safety and well-being of our employees, our families, and the communities we all live and work.

Hawaii's environment and its natural resources are also some of the most important assets we all want to protect now and into the future. Invasive species is one of the largest issues impacting Hawaii's native forests and watershed areas. Using herbicides like glyphosate is a very important tool to restore our streams, restore habitat for animals and make recreational areas more assessable. Miconia is an example of how one aggressive invasive plant can quickly establish itself in a tropical environment like Hawaii.

Pest control products benefit our society. Pest control products that contain glyphosate are used to control weeds. Weeds near our homes and schools may cause harm to our families by producing pollen that trigger allergies, or they may harbor insect pests, snails or slugs and rodents that cause or carry diseases, or they may be general pests in our lawns and landscaping. Weeds near our roads may be an impediment to safe driving conditions by limiting our vision of lanes or roadside signs. Weeds in our crops cause a decrease in yields and ultimately threatens our ability to sustainably farm. Pest control products that contain

glyphosate, when used according to the label, are some of the safest, effective and most efficient products on the market today for controlling weeds in a variety of settings.

Removing options to control unwanted vegetation impacts us all. The Land Use Research Foundation of Hawaii (LURF) is a private, non-profit research and trade association whose members include major Hawaii landowners, developers and a utility company. One of LURF's missions is to advocate for reasonable, rational and equitable land use planning, legislation and regulations that encourage wellplanned economic growth and development, while safeguarding Hawaii's significant natural and cultural resources and public health and safety.

LURF and its members also strongly support the long-term use and protection of Important Agricultural Lands (IAL) for agricultural use, and have worked with the State Department of Agriculture (DOA), Hawaii Farm Bureau Federation, Hawaii Cattlemen's Council and other agricultural stakeholders to pass the IAL law, the purpose of which is to provide agricultural incentive programs to promote agricultural viability, sustained growth of the agricultural industry, and the long-term use and protection of important agricultural lands for agricultural use.

However, LURF must **oppose HB 872**, which may be well-intended, but it misrepresents facts; is not based on reliable facts or research; lacks consultation with and support of key agricultural stakeholders; would have the unintended negative consequences of prohibiting the use of private property and agricultural lands; and could be counter-productive to the State's goals relating to agricultural sustainability.

HB 872. The stated purpose of this measure is to restrict the use of glyphosate on school properties based on unverified environmental and human health risks allegedly posed by exposure to glyphosate.¹

The unfortunate and unintended effect of this unfounded bill, however, will be to unnecessarily prohibit the use of agricultural lands by farmers, ranchers and other agricultural stakeholders, as well as use of private property by private landowners who are not engaged in agricultural activities.

LURF supports science-based government laws and regulations related to the voluntary disclosure and notification of pesticide use which are a result of the expertise of the EPA, as well as the DOA's Pesticide Branch, in collaboration with the DOH, the University of Hawaii College of Tropical Agriculture and Human Resources, federal agencies, county governments, and the agricultural operators who are trained, and certified to safely use pesticides (collectively Agricultural and Pesticide Experts and Stakeholders).

Given the facts and circumstances, LURF must **oppose HB 872** because this measure:

- 1. Reflects a failure to consult with, seek input from and collaborate with the Agricultural and Pesticide Experts and Stakeholders;
- 2. Fails to take into regard EPA's current system of pesticide testing, approval and regulation, which includes years of study and tests based on scientific research to reduce risk and ensure health and safety;
- 3. Is contrary to the statutory responsibilities and regulatory framework of HRS Chapter 149-A, the Hawaii Pesticides Law, which specifically designates the DOA as the state agency that is responsible for regulating pesticides; and
- 4. Lacks the support of reliable evidence or studies.

LURF's Opposition to HB 872 is Based on the Following Facts and <u>Concerns</u>:

• HB 872 is unnecessary, because the EPA already regulates, registers, monitors and imposes science-based restrictions and prohibitions on the application of pesticides. The EPA strictly regulates all pesticides, especially restricted use pesticides, and does not allow pesticide to be marketed or used unless it deems that the product can be used safely and without unreasonable adverse effects on health and the environment. The EPA already

¹ Drafters of this bill expressly state that "[t]he legislature admits there has been mixed research regarding the efforts of glyphosate, such as a human health risk assessment released by the United States Environmental Protection Agency (EPA) suggesting a correlation between glyphosate and cancer is unlikely."

LURF further recognizes the existence of a number of current and credible studies and reports issued by experts and regulatory agencies worldwide, including the EPA, which conclude that glyphosate has NOT been found to be a carcinogenic risk of concern to humans.

> evaluates and registers pesticides to ensure that they will not harm people, nontarget species, or the environment. LURF understands that pesticide registrants who use products around sensitive population centers must provide the EPA with proof of their safety through multiple rigorous studies designed by the EPA to ensure safe use protocols are developed; and EPA specifically establishes use requirements in recognition of the uses in such settings. When EPA's scientific evaluation determines that buffers, including vegetative buffers, are necessary to protect surrounding communities or sensitive populations, that requirement is imposed by the product label and enforced. Registered commercial agricultural farming operations are already legally required to comply with these safeguards as part of their EPA application protocols.

- HB 872 imposes unspecified arbitrary, non-science-based restrictions and conditions. This proposed bill, which relies upon admittedly unconvincing "mixed research" regarding the effects of glyphosate, fails to address and describe practical considerations such as the criteria or process for implementing the measure including identification of "school" properties and "normal school hours;" and further fails to provide needed information regarding the establishment of proposed buffer zones.
- The prohibition of the use of private lands as proposed in HB 872, could create an unconstitutional "regulatory taking," because it restricts the use of private lands without just compensation. LURF believes that land owners affected by this proposed measure can successfully assert that the restrictions on use of private lands can be said to force them to surrender the use of such lands without just compensation, in violation of Article I, Section 5 of the Hawaii's State Constitution ("*No person shall be deprived of life, liberty or property without due process of law, nor be denied the equal protection of the laws…*"), as well as the Fifth Amendment ("*Nor shall private property be taken for public use, without just compensation.*") and 14th Amendment (application to the states) of the United States Constitution.

The United States Supreme Court has held that a "regulatory taking" occurs when government regulation limits the uses of private property to such a degree that the regulation effectively deprives the property owners of economically reasonable use or value of their property to such an extent that it deprives them of utility or value of that property, even though the regulation does not formally divest them of title to it. Under such circumstances, the government action proposed by this bill could be deemed a violation of the Fifth Amendment of the U.S. Constitution.

• This measure will unnecessarily and negatively restrict commercial agricultural farming operations. The bill could impose restrictions on every category of agricultural production which would reduce the income of farmers by prohibiting agricultural production on useable farm lands, thereby increasing the already unsustainable costs currently suffered by agricultural stakeholders.

- This bill could have broad, unnecessary, and negative financial consequences on sustainable and diversified agriculture and Important Agricultural Lands. This measure negatively impacts agriculture in Hawaii, by restrictions that prohibit agriculture uses on agricultural lands and reduce the acreage of agricultural production. These prohibitions have a negative impact on large agricultural operations and IAL landowners; and identical negative impacts on smaller affordable parcels of agricultural lands sub-leased by those landowners to new, small, and family farmers who produce sustainable or diversified agricultural products.
- HB 872 will exacerbate losses and destruction to the State already being caused by invasive species. Invasive species such as insects, disease-bearing organisms, weeds, and other pests pose the greatest threat to Hawaii's economy, tourism, agriculture, the natural environment, native species and to the health and lifestyle of Hawaii's people. Invasive species already cause millions of dollars in crop losses, the extinction of native species, the destruction of native wet, moist and dry land forests, and the spread of disease, but many more harmful pests now threaten to invade all of the Hawaiian Islands and wreak further damage, including damage to the State's top grossing agricultural commodities.

Despite efforts to control the spread of such invasive species, methods must be implemented and maintained to control the incursions. Herbicides such as glyphosate are an important and necessary means to mitigate the threats and impacts of uncontrolled spread of invasive species to avoid devastation of the State's agricultural industry, as well as restore Hawaii's habitat and environment.

For the reasons stated above, LURF **must strongly oppose HB 872** and respectfully requests that this bill be <u>held</u> in your Committees.

The Hawaii Crop Improvement Association strongly opposes HB872 Relating to Environmental Protection

In 2018 this Legislature passed SB3095 SD1 HB1 CD1 Relating to Environmental Protection, which was signed into law by Governor Ige as Act 45 (2018). The Department of Agriculture is in the process of completing the Chapter 91 rule making process for implementation. Many community members throughout the State were allowed to participate and to provide input, in the rule making process. We strongly believe that the current rules should have an opportunity to work itself out through the process before this Legislature steps in with more restrictive regulations.

In addition, this Legislature must weigh the costs of implementing restrictive legislation. We all believe that Hawaii's people and the environment that we all live in are valuable assets that should be protected. However, any proposed protections must be wisely applied. Glyphosate is a product that has been used for many generations under the more common name - Roundup. It is a product that helps keep Hawaii's environment and its people safe from invasive species, the growth of weeds on our highways and homes, and yes, it is used to protect our keiki as they play outside after school from the overgrowth of vegetation that can take over any area without any type of maintenance and vigilance.

HB 872 requires that Roundup cannot be applied on or within 100 feet of school property during normal school hours, which puts a burden upon all schools and state and county roadways. There are many pre-schools that are within private residences or small business buildings. Application of Roundup after school hours would put our keiki at risk because they play in school yards, in rivers, baseball fields, etc., after school hours. Also, as each day ends and daylight fades, the State and Counties are putting its employees at risk as they must then spray along highways and other public areas during the busy afternoon traffic hours.

We strongly urge you to consider the impacts of this measure upon all communities and hold this measure until the rule making process of Act 45 can be thoroughly assessed.

YPDA is in **support of HB872 relating to environmental protection**.

This measure continues the progress made by Act 45 and leading up to it and is quite timely due to the not so distant 2018 verdict of Dewayne Johnson's lawsuit against Monsanto. As HB872 itself also mentions, a San Francisco jury found in 2018 that the usage of glyphosate was involved in Dewayne Johnson's non-Hodgkin lymphoma, his previous work as a school groundskeeper and pest manager had him constantly exposed to glyphosate in herbicides, most notably weedkiller Roundup, this verdict coming after a legal deliberation that was important due to Johnson's legal team being given permission to also present scientific arguments [1].

YPDA was a part of the coalition that supported the passage of Act 45 in 2018. One of the reasons for doing so was due to our continued dedication to our keiki and their future in the advocacy work that we do, striving to create a better world for them. We need to take a stand for those keiki and the school staff that take care of them and help them develop, by ensuring that Glyphosate's usage is not allowed on or within 100 feet from school property when school is in session. This allows for our keiki to be able to learn without being potentially exposed to Glyphosate. The World Health Organization points out that unlike adults, children are at a stage where they are continuously developing their nervous systems, immune systems, digestive systems, etc and exposure to environmental toxicants can lead to irreversible

damage [2]. The keiki are our future, we ask you to please help in protecting the future leaders and innovators of tomorrow. YPDA **urges you to support HB872**, and pass it out of your committee.

Hawai'i Alliance for Progressive Action Strongly Supports HB 872

Aloha Chair Creagan, Chair Lowen & Members of the Committee,

On behalf of the Hawai'i Alliance for Progressive Action (HAPA) we submit this testimony in strong support of HB 872 which will prohibit the use of glyphosate herbicides on or within 100 feet of a school during normal hours.

As a statewide environmental, social and economic justice organization HAPA engages over 10,000 local residents throughout Hawai`i annually. Our supporters are passionate about establishing better measures to protect our children from the impacts of pesticide exposure.

With growing evidence showing the carcinogenic and endocrine disrupting nature of glyphosate it is clear that our children should be better protected from potential exposure while at school.

Children are at higher risk for health effects from exposure to pesticides than adults, because their internal organs are still developing and maturing (1). The body of evidence in scientific literature shows that pesticide exposure can adversely affect a child's neurological, respiratory, immune, and endocrine system, even at low exposure levels (2).

The American Academy of Pediatrics, an organization made up of 60,000 pediatricians (3), has repeatedly warned about the risks of children being exposed to pesticides. In 2012 there was an official statement recommending we reduce children's exposure to pesticides (4).

In 2015 a 'Statement of Concern' written by scientists and directed to scientists, physicians, and regulatory officials in the Environmental Health journal highlighted changes in the scope and magnitude of risks to humans and the environment stemming from applications of glyphosate-based herbicides concluding that ⁽⁵⁾:

(1) Glyphosate is the most heavily applied herbicide in the world and usage continues to rise;

(2) Worldwide, glyphosate often contaminates drinking water sources, precipitation, and air, especially in agricultural regions;

(3) The half-life of glyphosate in water and soil is longer than previously recognized;

(4) Glyphosate and its metabolites are widely present in the global soybean supply (meaning that children are already heavily exposed in food);

(5) Human exposures to glyphosate are rising;

(6) Glyphosate is now authoritatively classified as a probable human carcinogen;

(7) Regulatory estimates of tolerable daily intakes for glyphosate in the United States and European Union are based on outdated science.

World Health Organization's International Agency for Research on Cancer recently concluded that glyphosate is "probably carcinogenic to humans" .

Last year a California jury awarded \$289 million to a school groundskeeper, Dwayne Johnson, after ruling that he indeed contracted non-Hodgkin's lymphoma because of his repeated exposure to glyphosate while applying it around a school. Given the above information it should be perfectly clear that this pesticide should not be applied on or around schools. Nothing is more important than protecting our growing children. There are other options of more integrated pest management that the Department of Education can implement to better manage pest issues without putting students, teachers and janitors at risk ⁽²⁾.

We strongly believe that the health of our children is of primary importance. We must do better to protect our children from the unintended impacts associated with exposure to glyphosate, and all pesticides.

Anyone who has been downwind of an area being sprayed or having been recently sprayed with weedkillers, such as those containing glyphosphates, knows one can smell the chemical from quite far away.

All scientific studies have shown that the rapidly-growing bodies of children are more susceptible to the harmful effects of chemicals. There is now a scientific consensus that the active ingredient of weedkillers, glyphosphate, is toxic. Glyphosate should be banned from school properties. Although it has not received much publicity, there are 960 studies and reviews in the national library of medicine analyzing the toxicity of glyphosate-containing products. The vast majority of these have been published in the past five years (AFTER the studies which concluded that glyphosate was safe) and most of these new studies show toxicity.

There is also the well-publicized recent lawsuit concerning glyphosate and cancer that resulted in a 78 million dollar judgment. The possibility of glyphosate- containing products causing cancer is the subject of intense debate around the world, but it should be noted that the majority of the studies noted above indicate that glyphosate is ALSO toxic in many other ways besides possibly causing cancer.

The studies describe harm to the cell lines of both land and sea life forms both by damaging cellular function and by genetic damage. There is also increasing evidence that these products adversely affect the so called "good" bacteria that inhabit almost all life forms. Two other features should also be kept in mind when considering the safety of these products: In the recent Monsanto lawsuit, evidence was presented of a coverup of the possible toxicity of Roundup. Other compelling evidence has been published further describing these possible coverups. There is also more recent evidence showing that glyphosate or its breakdown products remain in the soil far longer than has first been described.

Putting all this together, there is no doubt that our school grounds should be glyphosatefree zones. Thank you for considering my testimony.

I am completely in favor of this bill to prohibit the use of Glyphosates near our children.

Studies suggest a number of health risks associated with exposure to glyphosate. Children and fetuses are most vulnerable to pesticide exposures due to their developing organ systems and differences in the way they metabolize toxins. In addition, developmentally nor-mal hand-to-mouth behavior, close proximity to the ground where pesticides settle, and high respiratory rates result in higher expo-sures in children compared with adults.

Cancer: Glyphosate is classified by the World Health Organization's International Agency for Research on Cancer (IARC) as probably carcinogenic to humans based on strong evidence that it causes cancer in laboratory animals, and some evidence that it increases cancer risk in humans.1

Hormone disruption: Studies have shown that glyphosate is an Endocrine Disrupting Chemical (EDC), meaning that it inter-feres with hormones in the body. EDCs can interfere with the development of the brain as well as the function of organ systems, such as the nervous and reproductive systems.

Birth defects: Elevated rates of birth defects have been observed in animals fed with glyphosate-treated crops and in farming communities in areas where large quantities of glyphosate are used.

Nervous system toxicity: Laboratory studies suggest that glyphosate is toxic to the nervous system.

Antibiotic resistance: Glyphosate has the potential to make bacteria less sensitive to antibiotics.

I respectfully request that you pass this bill to protect our children!
