TESTIMONY ON HOUSE BILL 878 HD1, RELATING TO EXEMPTIONS FROM JURY DUTY

Before the Senate Committee on PUBLIC SAFETY, INTERGOVERNMENTAL, AND MILITARY AFFAIRS

Aloha Chair Nishihara, Vice-Chair Wakai and Members of the Committee:

The Hawaii Emergency Management Agency (HI-EMA) strongly supports House Bill 878 HD1.

House Bill 878 HD1 exempts active members of the Hawaii Emergency Management Agency and county emergency management agencies from jury duty. In 2018, Hawaii Emergency Management Agency responded to the 7.9M earthquake in Alaska in January, Oahu and Kauai's severe storms, flooding, landslides and mudslides in April, Kilauea's unprecedented volcanic eruption in the Big Island from May to August, Tropical Storms Lane in August and Olivia in September. HI-EMA activated for these events, deployed many personnel to Kauai and Big Island and continuing to support the long-term recovery efforts in the Big Island.

The county emergency management agencies have more activations since they also respond to county specific events, such as flooding, landslides, and wild land fires. In many of these cases, HIEMA will monitor and standby to support without activating.

HI-EMA defines an "active member" as a full-time (permanent or temporary) employee of HI-EMA that is assigned to an Emergency Response Team (ERT) for an activation. We have two ERTs, A and B, to cover 12 hour shifts during an activation. At any time during the year, we will have approximately 5 to 10 employees deployed, on leave, training, sick, etc. that are not available for activation. Please also note that while these members are activated, their normal day-to-day emergency management work requirements are put on hold and must be done post event.

Note: My comments represent HI-EMA concerns at the state emergency management level only. I would defer to the separate comment/testimonies of the county emergency management agencies, as they would be the jurisdictions impacted by this legislation at the local level.

Bill No. and Title: House Bill No. 878, House Draft 1 Relating to Exemptions from Jury Duty.

Purpose: Exempts active members of the Hawai'i emergency management agency and county emergency management agencies from jury duty. (HB878 HD1)

Judiciary's Position:

The Judiciary respectfully offers the following comments on House Bill No. 878, House Draft 1:

During 1998, Chief Justice Ronald T. Y. Moon convened the Hawai'i Committee on Jury Innovations for the 21st Century consisting of almost 30 judges, administrators, legislators, attorneys, and former judges. A Sub-Committee on Juror Fees (the Committee) studied, among other things, the issue of juror exemptions pursuant to House Concurrent Resolution No. 107, Session Laws of Hawai'i 1998 and recommended that § 612-6, HRS, should be amended by deleting all exemptions except for jurors who have served within the last year.

In making its recommendation, the 1998 Committee found that the majority of the states have two or fewer juror exemptions. And of these states, at least 24 have no exemptions at all. In contrast, Hawai'i currently exempts elected officials; judges of the United States, State, or County; physicians; dentists; members of the armed forces or militia; active members of

emergency medical services agency; persons living more than 70 miles from the court requiring jury services; people who have served as jurors within one year; persons 80 years of age or older; and mothers breastfeeding their child up to two years from the birth of the child.

The Committee also found that in 1993, the American Bar Association (ABA) recommended that, "The opportunity for jury service should not be denied or limited on the basis of race, national origin, gender, age, religious belief, income, occupation, or any other factor that discriminates against a cognizable group in the jurisdiction." To implement this, the ABA recommends that, "All automatic excuses or exemptions from jury service should be eliminated."

With regard to the current bill, the Judiciary is prepared to close down the courthouses should a crisis or disaster occur, including emergency hotline call-in numbers for employees to communicate with each other about shut down alerts and all-clear announcements. These communications would be pushed out to the members of the public as well. During a natural disaster, jurors would not report for jury duty. Further, the Judiciary understands that emergencies may arise prior to a juror reporting for jury duty and will not be able to fulfill their civic responsibility at the time they are summoned. Those jurors can request to have their jury service rescheduled to a later time without penalty or request to be excused. To our knowledge, jury duty exemptions for emergency management workers are not the norm in other States.

Thank you for the opportunity to testify on this measure.

SUBJECT: Support for House Bill 878, HD1, Relating to Exemption from Jury Duty

The City and County of Honolulu Department of Emergency Management (DEM) stands in strong **SUPPORT** for the passage of HB878, HD1, Relating to Exemption from Jury Duty.

DEM and other state and county emergency management agencies are tasked with preparing for, responding to, and recovering from natural and man-made disasters like the ones we saw in 2018 here in Hawaii and elsewhere around the world. While jury duty is an essential part of our civic infrastructure, emergency managers can best serve our communities by staying on the job and continuing our operations.

I would also like to take this opportunity to address the misconception that this bill is not necessary because the courts are expected to be closed during any event that would require emergency management agency response. Emergency management mobilization typically begins prior to event onset and continues well after the effects are felt by the wider community. For example, when a hurricane is approaching, emergency managers begin coordinating and planning actions well before impact and the work continues not only throughout the storm, but also until well after community activities begin returning to normalcy.



In summary, although emergency management officials are most visible during the acute phases of emergency events, they are in fact performing critical public safety functions not only during that time, but also before and after emergency events. During those pre- and post-event activities, courthouses are very likely to be open. It is for this reason that HB878, HD1 is so necessary to assure the health, welfare, and safety of the people of Hawaii.
