The Hawai'i State Public Charter School Commission ("Commission") appreciates the opportunity to submit this testimony in **STRONG SUPPORT of HB 996.**

HB 996 will allow the Hawai'i State Public Charter School Commission to administer the charter school prekindergarten classrooms. This will sustain the 18 high quality prekindergarten programs in charter schools currently funded by the federal Preschool Development Grant beginning school year 2019-2020.

The State Public Charter School Commission will ensure that quality measures will continue to align with those of Hawai'i's public pre-K programs using national quality standards.

Upon the inception of this grant beginning in 2015, the State Public Charter School Commission has been working closely with the legislature by providing annual informational briefings and public testimony. The intent of the Preschool Development Grant was to provide federal startup funds to begin new pre-K programs. Thereafter, states were to sustain the programs following the completion of the grant. The Hawai'i State Public Charter School Commission has been seeking alternate funding through the Keiki Funders group, other philanthropic organizations and other funding sources. All agree though, that base funding should be provided by the State.

Currently, the Hawai'i State Public Charter School Commission is in fourth and final year of the four-year grant, implementing 18 prekindergarten programs in 11 charter schools statewide.

Providing the funding to sustain this high quality prekindergarten program means that potentially 360 children and families across the State of Hawai'i will benefit from high quality preschool experiences. This nearly doubles the number of children enrolled in public pre-K programs in Hawaii.

Another important aspect of **HB 996** is its expanded support to working families by expanding the eligibility criteria. This change will increase access to high quality prekindergarten programs for children and families, particularly those who may be living in remote, rural areas of our state.

Testimony from a mother of a student currently attending the Kualapu'u Public Charter School prekindergarten program urges support for this program: "Please keep our pre-K program. It's an excellent program, excellent teacher and an administrator who is behind it 100% and with a community that needs it. We are a small community, and we don't have many options. So, please, please continue to fund the pre-K. We are very invested."

Another mom from our prekindergarten program at Na Wai Ola Public charter in Mountain View, Hawai'i shared: "It's amazing! She's gone from shy, timid and very enclosed to just freespirited. She talks to people and makes friends. For me personally as a mom, to see your child bloom... she used to keep to herself. Now, she's goes out and she wants to learn. She wants to go to school. To see her just share what she learned throughout the school day and bring it home and say, 'I want to show you (be)cause this is what I learned in class.' The whole family is a part of her learning. It's something special."

For these reasons, the Hawai'i State Public Charter School Commission respectfully requests that the committee pass this bill.

The Early Childhood Action Strategy (ECAS) is a statewide public-private collaborative designed to improve the system of care for Hawai'i's youngest children and their families. ECAS brings together government and non-governmental organizations to align priorities for children prenatal to age eight, streamline services, maximize resources, and improve programs to support our youngest keiki. We strongly support HB 996, which would appropriate funds to the state Public Charter School Commission for the 2019-2020 school year to maintain eighteen existing charter school prekindergarten classrooms.

Research finds that Hawai'i's youngest children benefit tremendously from early learning programs. Keiki that attend preschool enjoy both short-term and long-term benefits, including improved academic and school readiness, higher graduation rates, and lower incarceration rates. Currently, there are eighteen pre-kindergarten classrooms operating in eleven charter schools statewide, including Native Hawaiian Immersion classrooms.

These classrooms can service 920 children over the span of 4 years. It's important to ensure our youngest keiki continue to have access to the benefits of early learning programs by sustaining these existing pre-kindergarten classrooms. We urge the committee to pass HB 996 and maintain and continue the current charter school pre-kindergarten classrooms. Thank you for this opportunity to provide testimony.

I have had the pleasure to work at Na Wai Ola's pre-k program, and have been extremely impressed by the quality of education provided to young children and their families at our school. The interest from families to continue our pre-k program is overwhelming, and families are very grateful for the education provided to their 4- and 5-year olds. I am a parent of two young children and can personally attest to the difficulty of finding high quality preschool that is affordable in our area of Mountain View, Hawaii.

Na Wai Ola PCS provides unique culturally based, high quality education, rich in social emotional, cognitive and physical development support. As a title 1 school, we serve a

community largely of lower socioeconomic status. According to the US Census Bureau's 2012-2016 American Community Survey 5-Year Estimates, over 30% of Mountain View residents live below the federal poverty level. Lower socioeconomic status has great impact on achievement gaps, and without educational support that starts early, in preschool, these achievement gaps will widen. Mountain View is too far from any Head Start preschool program, and without Na Wai Ola's pre-k program, many of our families will be deprived of the freedom to choose a high quality pre-k charter school education that does not financially impact them. Finding child care is costly, and many of our families can't afford to do so. Free, high quality pre-k education has the potential to positively support our community as we try to lift ourselves out of poverty and contribute to society. These families deserve to be able to choose charter school education. Choice is a freedom, and it attracts invested, dedicated parents who care about giving their children the best educational opportunities, and educational success has been linked to having a strong base in early educational experiences.

Please approve HB 996 and allow our Na Wai Ola PCS pre-k program to continue to positively support the educational needs and experiences of our Mountain View community.

Early childhood education funding specifically earmarked for low-income families is critical. Not only does this expose our children to an educational environment and get them ready for the transition that is the kindergarten classroom, it also enables parents to go back to work or school. This is a factor when we look at supporting socio-economic mobility. There is a connection between a lack of early chilhood educational opportunities for low-income families and generational lack of opporunities for upward economic mobility. If any of our legislators are considering a NO vote on this bill, I would strongly encourage you to look at some of the studies done that demonstrate a causal connection between these notions. Hawaii in particular should pay close attention to this because we have one K-12 school district for the entire state and we provide substantial funding to University of Hawaii. More children in school, more young parents could go to college. IF these young parents are not inclined to attend college, then they could join the labor market, which is very tight in Hawaii. We must work to equalize opportunity/access to education and contribution to our communities through work.

This program specifically impacts children in the foster care system. It is shown that the trauma and disruption resulting when children are placed in care, can cause up to two years of developmental delays. Children in foster care automatically qualify for this program and are then able to attend school on the same campus as older siblings. This is important both for addressing any potential developmental delay but also in the sense of belonging and security that comes from keeping children in the foster care system together as much as possible. In homes and on school campuses, keeping children together matters.

I am in full support of HB 996 and I strongly encourage our legislators to continue with their support of education in the State of Hawaii by voting Yes on HB 996.

Thank you for the opportunity to provide comments in Strong Support for **House Bill 996** which appropriates moneys for school year 2019-2020 to the State Public Charter School Commission to continue eighteen federally funded kindergarten classrooms that were created by the federal Preschool Development Grant of 2015.

In 2014, the state public charter school commission (Charter School Commission) was awarded a four-year federal preschool development grant to open prekindergarten classrooms. The Charter School Commission successfully opened eighteen classrooms in eleven charter schools on the islands of Kauai, Molokai, Oahu and Hawaii, many of which are located in remote rural areas. The last year of federal funding for this grant will end at the close of the current 2018-2019 school year. This bill seeks funding to allow the Charter School Commission to continue to serve the children, families and communities in those eighteen classrooms by providing early learning education opportunities.

Early education specialists tell us how important it is to prepare young children for a lifetime of learning. Research also tells us that early childhood education, such as preschool programs, are critical for brain development. What children experience in their early years will set the stage for how well they learn for the rest of their lives and is critical to their well-being in adulthood. Therefore, the Administration respectfully requests the committee's support of this bill to allow the Charter School Commission to continue operating its eighteen prekindergarten classrooms.

EXECUTIVE OFFICE ON EARLY LEARNING'S POSITION: Support

Good afternoon. I am Lauren Moriguchi, Director of the Executive Office on Early Learning (EOEL). EOEL is in strong support of House Bill 996.

We appreciate the Legislature's recognition of the need to increase access to high-quality early learning.

We fully support the Commission's request for funding to sustain its 18 pre-K classrooms across the state. EOEL is statutorily responsible for the development of the State's early childhood system that shall a spectrum of high-quality development and learning opportunities for children throughout the state, from prenatal care until the time they enter kindergarten, with priority given to underserved or at-risk children. The charter pre-K classrooms are included in our proposal to increase access to prekindergarten for our keiki – they provide an important option that addresses family choice and provides opportunities in areas that do not have pre-K programs. If the Commission is not able to sustain their currently-operating classrooms, it will be to the detriment of the community.

In its implementation of the 18 pre-K classrooms, the Commission is working toward achieving the quality standards of the National Institute for Early Education Research, as we are. We believe the Commission is committed to working with EOEL toward ensuring a high-quality pre-K program for our keiki.

We respectfully request that the committee consider moving this bill forward, and defer to the Commission regarding the details of its request.

The Office of Hawaiian Affairs (OHA) Beneficiary Advocacy and Empowerment Committee will recommend that the Board of Trustees <u>SUPPORT</u> HB996, which would provide funding to the State Public Charter School Commission to continue the federally funded prekindergarten program in public charter schools for school year 2019-2020. This measure is necessary to ensure the continuation of a program that benefits young learners, and increases their likelihood of future academic success and positive overall development.

In any given year, there are about 17,000 four-year-old children in Hawai'i, approximately half of whom will enter kindergarten without having attended preschool. Not surprisingly, a significant majority of public school kindergarten teachers report that their new students are not ready for school. Encouraging greater preschool attendance may substantially increase our children's chances of success in kindergarten and beyond: research shows that children are more likely to succeed in kindergarten, reach higher levels of educational attainment, and contribute meaningfully to society, among other positive outcomes, when provided with the opportunity for high-quality early childhood education.

In 2014, OHA wrote a letter to the U.S. Department of Education (USDOE), in support of the State's successful application to the USDOE's Preschool Development Grants Program. The State's application proposed to improve kindergarten readiness with an ambitious yet achievable plan, to expand access to high-quality preschool classrooms in high-need communities through a charter school prekindergarten program. Eleven public charter schools, seven of which are Hawaiian culture-based or Hawaiian language immersion schools, currently support prekindergarten readiness as a result. HB996 will ensure funding for the continuation of the charter school prekindergarten program, and allow preschool-aged children, including Native Hawaiian keiki, in our public charter schools to continue accessing the advantages of early childhood education.

OHA continues to be a strong supporter of Hawai'i's public charter schools, many of which provide a culturally-grounded education for Native Hawaiian and other children.

17 of the 37 public charter schools in Hawai'i are Hawaiian culture-based or Hawaiian language immersion schools, in which OHA has invested over \$18.6 million between FY 2005-2006 and FY 2016-2017. On October 19, 2017, the OHA Board of Trustees approved an additional \$3 million total to these charter schools for FY 2017-2018 and FY 2018-2019. OHA made this investment because research shows that Hawaiian students exposed to culturally-driven educational strategies have a stronger sense of socio-emotional well-being, deeper engagement with their schools, and a stronger commitment to civic activities in their community, factors which are directly tied to greater academic achievement.

Therefore, OHA urges the Committee to **PASS** HB996. Mahalo nui for the opportunity to testify on this measure.

Introducing them to SEL social emotional learning skills benefits them to understand feelings, and motor skills to speak and share their feelings with their peers and others around them. Socializing with peers helps them learn to share, and explain their feelings and etc. It also helps in behavior in setting good

We appreciate the opportunity to submit this testimony in **STRONG SUPPORT of HB 996.**

HB 996 will allow the executive office on early learning to enter into a memorandum of understanding with the Hawaii state public charter school commission to administer the charter school prekindergarten classrooms. This will sustain the 18 high quality prekindergarten programs in charter schools currently funded by the federal Preschool Development Grant beginning school year 2018-2019.

The Laupahoehoe Community Public Charter School (LCPCS) Governing Board sees the importance of Pre-k education for our students and strongly supports HB 996.

Students who attend preschool are better prepared and more successful in Kindergarten and throughout their elementary career. Benefits include increased skill levels in mathematics, reading, and social and emotional intelligence.

On the Hamakua Coast our resources for preschool options are limited. Tutu and Me, a traveling preschool program can be found in either Hilo or Honokaa, 25 miles in either direction. Parents or guardians must accompany their child at least 2 days a week for 2 hours a session to even be considered for enrollment. This makes it difficult for local families where both parents are working, to attend.

Laupahoehoe Community Public Charter School has offered the pre-k program for the last 4 years funded by the Preschool Development Grant (PDG). Our enrollment numbers have increased each year, making it one of the highest enrolled classes in our elementary school.

We currently have 362 students enrolled at LCPCS from Pre-K to grade 12. Sixty students have been identified as IDEA and 217 are of Low Socioeconomic Status, both are found to be characteristics of low performing students. A study at <u>Duke University</u> found that kids who attended a well-funded Pre-K program had higher reading and math abilities throughout their elementary and middle school career and were significantly less likely to have to repeat a grade. They were also, by the 8th grade, 30 percent less likely to need special education programming.

Students that graduated from the first 2015-16 Pre-k class are now in the 2nd grade. Fifty percent of those students are in the High Achievement/High Growth range on their Winter Achievement Status & Growth Summary in the Northwest Evaluation Association (NWEA) assessment program we use here at LCPCS to evaluate our students. One student in the class is identified with Special Education Services under IDEA. Our current 3rd grade class, that did not have the opportunity to attend the Pre-k Program, has only 30% of its students showing High Achievement/High Growth status and has 3 students identified with Special Education Services under IDEA.

We strongly recommend that the current federally funded Prekindergarten classroom program be continued. We believe it will reduce the number of low-performing students and effectively improve our educational system here at Laupahoehoe Community Public Charter School.

The ELB supports the HB 966 appropriation of funds to continue the 18 charter school classrooms developed with funding from the Federal Preschool Development Grant, received by the Charter School Commission in 2015. 2019 marks the completion of the grant and this appropriation would sustain the quality early learning program opportunities for 360 children across our State.

Knowing the impact that quality learning experiences in pre-K have, particularly upon low income and at-risk children and their families, the ELB believes it is incumbent upon our State to continue the excellent work begun with the Federal start-up funds. The Charter School Commission reports gains on many fronts for the pre-K participants: cognitive, social emotional and physical development as well as language, literacy and math. These are the kinds of positive outcomes that pre-K experience offers our keiki and we don't wish to lose them.

Chair Woodson and Members of the Committee:

The Hawaii State Teachers Association <u>strongly supports HB 996</u>, appropriates moneys for school year 2019-2020 to the State Public Charter School Commission to maintain and continue the current federally funded eighteen existing charter school prekindergarten classrooms that were provided for by the federal Preschool Development Grant of 2015.

As noted by an MIT working group on the topic, investments in early childhood education pay dividends for the formal preparation of children as learners and future citizens, while also benefiting taxpayers and boosting economic vitality. Research on the benefits of quality pre-kindergarten programs indicates that for every dollar invested in such opportunities, society saves four to eight dollars on remedial classes, special education, welfare programs, and criminal justice costs. Roughly 85 percent of a child's brain develops from birth to age five, according to modern neuroscience, emphasizing the importance of providing a quality learning environment during these formative years. Preschool brings an approximately \$4.20 return on investment for every dollar spent on quality early childhood services, especially in terms of long-term life skills. At the national level, every dollar spent on early childhood education saves taxpayers up to \$13.00 in future costs, including lowered healthcare costs, reduced rates of educational remediation and prison incarceration, and higher productivity. Access to quality pre-kindergarten programs not only helps working parents fulfill their responsibilities, but is essential for building a 21st century labor force. Early childhood education is especially

important for at-risk students. According to the High Scopes/Perry Preschool longitudinal study, at-risk children with access to quality early learning programs were 20 percent more likely to graduate from high school, 14 percent more likely to be employed, and 24 percent less likely to have been incarcerated by age 40 than peers without such access. As the Department of education continues to streamline educational accountability, particularly through the possible institution of merit pay and high-stakes evaluations for teachers and educational officers, it is imperative that we do all we can to ensure our children are "classroom ready," meaning that they are prepared to receive basic instruction and effectively socialize with peers upon entering elementary school, placing both our keiki and their teachers on the path to success.

Utilizing public school resources for the provision of early learning will place our children's futures in the hands of the state's most qualified education professionals, namely our certificated and licensed public-school teachers with additional certifications in early childhood education. Additionally, public early learning programs will not set a precedent for the future adoption of school voucher programs at the elementary and secondary school level. Finally, this proposal does not violate the U.S. Constitution's and Hawaii State Constitution's Establishment Clauses, which bar preferential governmental treatment for religious institutions, ensuring that the state will not become ensnared in costly litigation because of a misappropriation of funds to programs that promote theological viewpoints. Public early learning will, instead, include research-based, developmentally appropriate, secular practices that are associated with better educational outcomes for children. Public early learning programs currently exist in nineteen public schools, with only five programs on O'ahu and only one on Maui and Lana'i each. Since charter schools are public schools, funding public prekindergarten programming in the eighteen preschool classes currently offered in charter schools will expand access to children who may not be served by DOE preschool programs existing outside of their families' geographic locations.

Because early childhood education is beneficial to lifetime learning, the Hawaii State Teachers Association asks your committee to **support** HB 996.

On behalf of Hawaii Children's Action Network (HCAN), I am writing in SUPPORT of H.B. 996, which would appropriate moneys for school year 2019-2020 to the State Public Charter School Commission to maintain and continue the current federally funded eighteen existing charter school prekindergarten classrooms that were provided for by the federal Preschool Development Grant of 2015.
